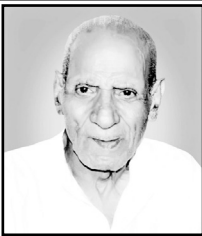

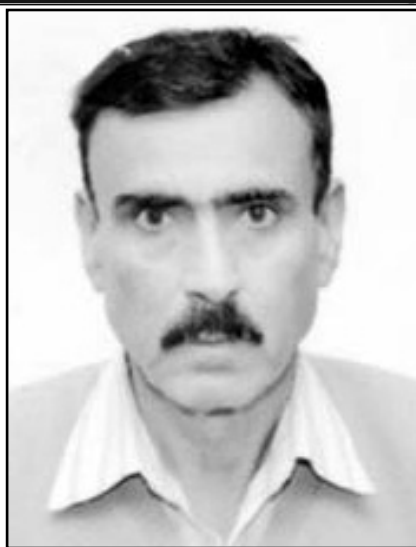


SH. RTD CAPTAIN RATTAN SINGH BANDRAL 1930 to 2021

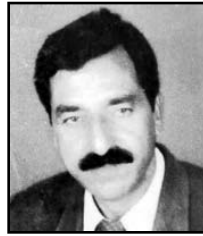
