

CS calls for making urban areas litter-free by March 2022

JAMMU: The Chief Secretary, Dr. Arun Kumar Mehta on Friday reviewed the functioning of the Housing & Urban Development Department and took stock of the progress under developmental programmes and schemes.

Principal Secretary, Housing & Urban Development, Commissioner Secretary, Jal Shakti, Commissioner, Jammu Municipal Corporation, Commissioner, Srinagar Municipal Corporation, Directors Urban Local Bodies Jammu and Kashmir along with concerned officers participated in the meeting.

It was informed that the Department observed the first-ever 'My Town My Pride' programme in October 2020 with a 3 fold objective of enhancing public outreach across the urban areas and towns of J&K; providing door-step service delivery; and strengthening the grass-root democracy in Jammu and Kashmir. During the 2-day programme, 553 developmental works were identified, of which 345 have been completed so far and the remaining will be completed by March 2022.

Regarding, the Mass Rapid

Transit System-Metrolite (MRTS), it was informed that the two projects coming up in the twin capital cities, on completion, will provide a safe, reliable, convenient, cost-effective, and sustainable mode of urban transportation.

The Metrolite corridors will run from Bantala to Bari Brahmana (23 km) in Jammu, Indra Nagar to HMT Junction (12.50 km), and Hazuri Bagh to Osmanabad (12.50 km) in Srinagar. Once functional, MRTS will promote public transportation with a corresponding reduction in traffic congestion by reducing per capita vehicle ownership and also the per capita traffic accidents.

Under the Atal Mission for Rejuvenation and Urban

Transformation (AMRUT), 64 projects have been completed and the remaining 19 will be completed by March 2022 at an estimated cost of Rs. 513.13 crore. The Mission sponsors developmental works in various sectors including urban transport, drainage, green spaces, water supply, and sewerage management. Jammu and Kashmir has received 13.13 crore as reforms incentive for registering good performance on various parameters.

To further boost development in the urban areas, AMRUT 2.0 is being launched for 5 years with a target of providing water tap connections to all statutory towns; sewerage connections in 3 AMRUT mission cities; and rejuvenation of water bodies, green spaces, and

parks.

Under the Swachh Bharat Mission (URBAN) 2.0, the Department will be working towards achieving a 'garbage-free' status for all cities and towns by focusing on segregation of solid waste and door-to-door collection in all urban local bodies. The Chief Secretary directed the Department to ensure 'litter-free' urban areas by 2022 and implementation of scientific waste management techniques including safe disposal in landfills. The Department was advised to convert all legacy dumpsites into green zones through appropriate interventions. Dr. Mehta reiterated the dedicated and persistent de-weeding drives in Dal and Nigeen lakes throughout the year for holistic

cleanliness and upkeep of the areas, besides implementing the sewerage treatment protocols in a time-bound manner.

The Housing and Urban Development Department was asked to promote rainwater harvesting techniques in urban areas to optimally utilize rainwater and augment the receding water supplies.

Further, the Chief Secretary emphasized the financial and environmental sustainability of developmental works/models being executed through various local governance bodies and directed formulation of guiding principles and framework. The Department was asked to lay special focus on capacity building and training of both the elected members and employees of all urban local bodies.

The Department was also advised to evolve performance-linked incentives to reward the municipalities registering good performance in reform implementation.

Moreover, the Department was directed to promote IT-enabled citizen services by strengthening the IT infrastructure and back-end service support to extend the ease of access to remaining government services.

PHDCCI suggests NITI Lecture Series for J&K

JAMMU: Chairman, PHD Chamber Of Commerce & Industry Jammu (PHDCCI), Rahul Sahai led a delegation to meet and submit memorandum to Dr. Vijay Kumar Saraswat, Member, NITI Aayog, and Chancellor, Jawaharlal Nehru University at Guest House Canal Road Jammu. He submitted a memorandum of suggestions on measures for revival of J&K economy. Sahai apprized Dr. Saraswat about higher education institutions of Jammu and requested him to visit these institutions and deliver lecture for youth of J&K. Saraswat assured that will definitely do in

coming months. Rahul Sahai also suggested NITI Lecture Series for J&K said Niti Aayog in association with PHDCCI should start a series of lectures for J&K to invite globally and nationally reputed policy makers, experts, administrators to share their knowledge, expertise, experience in policy making and good governance.

Sahai also suggested to include one or two districts from Jammu in the list of Aspirational Districts, formulate an Innovation task-force comprising leaders from academic institutions and industry (Govt. and non-Govt.) to create an innovation-enabling roadmap for J&K, setup

Digital Skilling Centers to equip youth to upgrade their skills, provide world-bank Technical Education Quality Improvement Program funding to private institutions in the higher education, undertake rapid digitization program for the education sector in J&K, provide high-speed internet access to all remote areas in J&K to boost connectivity and learning. Sahay talked about the implementation of all central schemes in Jammu and

Kashmir; some relaxation in the RBI rules for the MSME sector hit by COVID-19, change in land use rules to allow businesses on agriculture land, resolving issue of Gair Mumkin Khad besides many other issues including liquor vendors, nine percent road tax on purchase of new vehicles and promotion of tourism areas.

Dr. Vijay Kumar Saraswat Member, NITI Aayog, and

Chancellor, Jawaharlal Nehru University was accompanied by Ranjan Prakash Thakur IRTS Principal Secretary Industries and Commerce department of J&K. Dr Saraswat hailed PHDCCI delegation for suggesting positive measures for overall development of UT and assured to incorporate and resolve the eligible issues at the earliest and said interactions will be continued with the stake holders .

Distt Admn directs launching special drive against traffic violations, roadside parking in Valley

SRINAGAR: Traffic jams during peak hours are becoming a headache for commuters across Srinagar district. Roadside parking and encroachment on footpaths and lack of permanent bus-stops are some of the main causes of traffic mess. Though the Traffic Control Unit and Road Transport Office (RTO) Kashmir are working with full capacity, yet both of them are completely unable to either regulate traffic system or to motivate the general public to abide by basic traffic rules and regulations.

Though traffic signals have been installed at all main crossings in Srinagar city now, and all of them are in working condition but it is quite unfortunate that they are not being followed except two one at TRC Chowk and other at Sangar Mall complex on Maulana Azad road, Srinagar. Taking cognizance of the complaints received from general public with regard to nuisance of wrong parking, roadside encroachments on roads, the Deputy Commissioner Srinagar, Mohammad Aijaz Assad undertook a surprise inspection of various roads to assess the traffic scenario. During the visit, the DC directed the authorities to take strict action against traffic violators particularly against wrong parking and road-side encroachments. He also directed for taking immediate measures to overcome traffic jams for ensuring better regulation of traffic movement within Srinagar Municipal limits, especially on congested routes. District administration directed Traffic Police, RTO Kashmir, Police, Revenue and SMC authorities to work in close coordination and act tough against traffic rules violators, who cause a lot of inconvenience to common people. He directed the officers to devise an effective mechanism for better traffic regulation, particularly hassle-free movement of ambulances and other vehicles required to reach destination in a time bound manner.

He also directed the authorities to conduct a massive and intensified enforcement drive on daily-basis against traffic violations, wrong parking and encroachments in Srinagar City for a visible improvement in traffic system. He also directed to provide a provision for adequate parking spaces in crowded places and relocation of roadside vendors to facilitate hassle-free movement of pedestrians. The DC also stressed that civic sense and driving sense is imperative in better traffic management and appealed to all stakeholders to put in collective efforts to overcome traffic jams and decongest Srinagar City for smooth traffic regulation.

Meanwhile, SMC Commissioner also visited Lal chowk and other adjacent areas and asked roadside street vendors to restrict their business to only designated spaces and not indulge in any violation/encroachment which can cause inconvenience to general public or disrupt movement of traffic.
