Whereas, these posts were notified vide Advertisement Notification No. 02 of 2019 dated 01.02.2019 with cut-off date as 14.03.2019; and

Whereas, as per the indent received from the concerned Indenting Departmenet, the qualification prescribed for the post is as follows:

"10+2 with Science or above qualification with Diploma in Anesthesia Assistant Course from any recognized institute/SMF"; and

Whereas, the written examination for the said post was held on 11th of May 2019 and provisional selection list was issued by the Board vide Notification No. SSB/Secy/Sel/2019/5160-66 dated 05.10.2019 and 33 candidates were called for document verification/counselling on 2nd and 4th of November, 2019; and

Whereas, the selection process to the post of Technical Assistant/Technician (Anesthesia) has been subject matter of SWP No. 605/2019 titled Tajamul Ahmad Dar V/s State of J&K and other in the Hon'ble High Court of J&K at Srinagar; and

Whereas, the case was transferred to Hon'ble Central Administrative Tribunal (CAT) in the month of September, 2020 in TA No. 062/1476/2020 alongwith MA 62/1413/2020; and

Whereas, the Hon'ble CAT vide its order dated 08.10.2020 passed the order, the operative part of which is reproduced as below:

"...Accordingly, the MA is dismissed as withdrawn and TA is also dismissed. No costs"; and

Whereas, the key issue whether the candidates who possess higher qualification than the prescribed in the rules are eligible for the post of Technical Assistant/Technician (Anesthesia), Radiographic Technician, Clinical Staff for Casualty Bed and Theatre Assistant was also under adjudication separately in the TA No. 62/7196/2020 titled Ajaz Ahmad Ahaner V/s UT of J&K and others; and

Whereas, the Central Administrative Tribunal vide its order dated 25.10.2021 also dismissed the TA 62/7196/2020 and passed the following order:

"...We do not find any merit in the TA, which is accordingly dismissed. There shall be no order as to costs"; and

Whereas, The above said judgment of the Hon'ble Central Administrative Tribunal was challenged in the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar in WP (C) No. 2251/2021 titled Ajaz Ahmad Ahaner and other V/s UT of J&K and others. In the above said writ petition the Hon'ble High Court vide dated 16.11.2021 passed the following order:

"...For the foregoing reasons, we do not find any error or illegality in the impugned judgment passed by the Tribunal. The impugned judgment of the Tribunal is well reasoned and lucid. The same does not call for any interference. The writ petition lacks merit and the same is, accordingly, dismissed".

Whereas, considering all the facts and circumstances of the case together with the aforesaid orders of the Hon'ble Courts, the selection list alongwith waiting list for the post of Technical Assistant/Technician (Anesthesia) was prepared and placed before the Board in its 192nd Board meeting held on 21.11.2021; and

Whereas, the Board after taking into consideration all the facts before it, decided to approve the selection list prepared by the concerned officers of the Board.

Now, therefore in view of the above:

(i) the selection list for the post of Technical Assistant/Technician (Anesthesia) as approved by the Board mentioned above is hereby notified as Annexure "A" to this notification.

(ii) The selection list approved is subject to the outcome of any writ petition (s) pending in any court of law of the competent jurisdiction.
