Cancellation / De-registration of Societies registered under erstwhile J&K Societies Registration Act 1998 (Samvat)-1941 AD and who have not applied for Re-registration under Societies Registration Act 1860 with Registrar of Societies, Jammu.

Whereas, the J&K Societies Registration Act 1998 (Samvat)-1941 AD stands repealed and the corresponding Central Societies Registration Act 1860 was made applicable, as per the Jammu & Kashmir Re-organization Act- 2019 (Notification no. 34 of 2019 Dated 9th August, 2019- issued by Ministry of Law and Justice, Government of India).

Whereas, in reference to the Administrative Department's No. IND/DIC-169/2007 dated 19.04.2021, all the societies registered before 31.10.2019 under erstwhile J&K Societies Registration Act 1998 (Samvat)-1941 AD were required to get their societies re-registered under the Societies Registration Act 1860 applicable as per Jammu & Kashmir Re-organization Act 2019. Accordingly, public notices were published from time to time in the leading Daily newspapers w.e.f. 20th April, 2021 to 07.12.2021 for submission of the requisite documents for Re-registration till the last date i.e. 18th December, 2021.

Now, it is notified that such Societies registered under J&K Societies Registration Act 1998 (Samvat)-1941 AD which have not applied for Re-registration under the Societies Registration Act 1860 are deemed to have been cancelled / de-registered with immediate effect after public issue of this notice.
