

NDS Releases Dr Chanchal's Children Book on Dogri Mannta Divas

Rana exhorts intelligentsia to redouble efforts in promoting, preserving Dogri

JAMMU: BJP leader and former legislator Devender Singh Rana today made a passionate appeal to writers, poets, academicians, intellectuals and intelligentsia to play their crucial role in promoting and preserving Dogri, the language emanating from the land of warriors and spoken from Ravi to Chenab and places like Kangra and other areas of Himachal Pradesh.

"Mithi ar Dogre Di Boli, 'Tb Khand Mithe Log Dogre", Devender Rana said while releasing 'Moti Mahal' a children book in Dogri, penned by Dr Chanchal Sharma at a function organised by Nami Dogri Sanstha (NDS), adding that if the present generation fails in its duty, the posterity will never forgive, as death of a language is death of soul.

Rana strongly advocated for use of mother tongue in day to day interaction, saying catching them young will make children proud inheritors of the language. In this backdrop, the release of the children's Dogri book "Moti Mahal" can be described as a befitting tribute to Dogra Mannta Divas, the day when Dogri was incorporated in the 8th Schedule of the Constitution of India.

He lauded the literary contribution of Dogri writers and poets for their relentless campaign to restore the pristine glory of this rich language. More than sermons, the work done at grass roots levels by scholars, writers and artists matters the most. He exuded confidence

PAGD has lost public support due to its misrule' over years: Raina

JAMMU: Taking a strong exception to objections by opposition parties over the recommendations of the delimitation commission, Jammu and Kashmir BJP president Ravinder Raina on Tuesday said the People's Alliance of Gupkar Declaration (PAGD) has lost public support due to their misrule over the years.

He also said the BJP is connecting and not dividing the people, while opposition PAGD leaders are poisoning their minds for petty political gains.

The Delimitation Commission on Jammu and Kashmir has proposed six additional assembly seats for Jammu region and one for Kashmir; while reserving 16 constituencies for Scheduled Castes and Scheduled Tribes, triggering strong protests from parties such as the National Conference which made it clear that it would not sign the report in its present form.

Countering the objections raised by PAGD leaders over the recommendations, the BJP leader said whether it is delimitation commission or election commission, these are autonomous and independent institutions which have their own powers.

The delimitation commission came out with its recommendations after working for over two years, during which they met leaders of all political parties, social workers, district development and block development council members, heads of organisations of panchs and sarpanchs, and collected data from government machinery, including deputy commissioners, and worked on set parameters, he said.

Raina further said if an independent institution is saying something and that too headed by a

retired Supreme Court judge whose credibility and transparency is well known, there is no place for objection.

He said the National Conference (NC), Peoples Democratic Party (PDP) and Congress have ruled Jammu and Kashmir over the last seven decades, but failed to give equal rights to different communities.

I do not see anything wrong in increasing six seats to Jammu region and one in Kupwara district of north Kashmir. They should talk of the whole Jammu and Kashmir as a unit rather than restricting their politics to mohalla' (locality) level, the BJP leader said, adding that they are free to raise their concerns with the commission rather than making it an issue.

The BJP leader said the party is happy over the recommendation for reservation of nine seats to Scheduled Tribes and seven seats to Scheduled Caste communities.

The Scheduled Tribes were oppressed by NC, PDP and Congress over the years for their vested interests, while the BJP under the leadership of Prime Minister Narendra Modi provided them justice and equal rights, he said.

Raina said the opposition parties are smelling their defeat before the elections as they have lost the faith and support of the public.

We are linking people and they are poisoning their minds by provocative statements, he alleged and asked the PAGD leadership to stop provoking the public and instead work for the welfare of the people.

He added that the BJP has set a target of 50 plus seats in the next assembly elections which would be held after the completion of the delimitation exercise.

JAMMU: Taking swift action to avoid the further multiplication of Omicron in Jammu, Divisional Commissioner Jammu, Dr Raghav Langer visited the micro containment zone declared by civil administration after two positive cases of Omicron detected in Talab

Tillo area and passed strict instructions to adhere the norms.

In a first since its detection, three cases of Omicron - new variant of Covid - have been confirmed from Sarasvati Vihar locality in Talab Tillo area of Jammu City by National Centre for Disease

Control (NCDC).

As the three Omicron cases confirmed by NCDC, Delhi in Jammu, the district administration has declared the Sarasvati Vihar as micro containment zone. Immediately after the declaration Dr Langer visited the spot and have a physical check of the micro containment area. "Please observe Covid Appropriate Behaviour and follow the guidelines, Div Comm appealed to the local people and also passed on the spot instructions to the police and civil administration.

Growth index of minorities in UTs was much better than states in India: Dr Darakhshan

JAMMU: Chairperson of Waqf Development Committee of Ministry of Minority Affairs Dr Darakhshan Andrabi along with the team of Central Waqf Council reached Silvasa on Tuesday.

She is on a two day tour of the Union Territory of Dadra, Nagar Haveli and Daman & Diu to assess the implementation of the schemes and programmes of the Ministry of Minority Affairs in the UT and also to inspect the Waqf Management there.

People of areas outside Kashmir Valley may not be again denied due status in Legislature & Administration

➡ Earlier people of areas outside Kashmir Valley have been denied their due status atleast nine times

The administrative order of the erst-while princely state of J&K as regards the two regions of Jammu and Kashmir was something like (i) Jammu Region-36315 sqkm : 5 Districts (Mirpur, Jammu, Kathua, Udhampur; Reasi) comprising of 18 Tehsils plus 2 Jagirs (Poonch and Chenani) (ii Kashmir region- 22133 sq km : 3 Districts (Muzaffrabad, Baramulla, Anantnag) comprising of only 10 Tehsils.In 1947 after Pakistani illegal occupation of some areas including Mirpur district and Muzaffrabad district the un occupied areas (Jammu, Kathua,Udhampur; Reasi, Poonch Jagir; Chenani Jagir) in Jammu Region (26293 sq km) were reorganised as 6 District of Poonch, Rajouri, Jammu, Kathua, Udhampur and Doda and the areas 2 districts (Anantnag and Baramulla Districts) in Kashmir Region (15948 sq km) were reorganised as 3 Districts of Anantnag, Srinagar and Baramulla.

First it was in 1951: While drawing out the Constituent Assembly for drafting the J&K Constitution when adhoc delimitation was done @40000 population per/seat @1941* Census (total *40,21,616 including Ladakh Region)) allocating 43 seats over Kashmir Region and just 30 seats over Jammu Region so wrongly assuming the reference population for Jammu region as just 12,00,000 out of * 20,01,557 and populations as large as 17,20,000 for Kashmir Region out of

*17,28,686.

Second it was after 1957: When elections were repeated for Legislative Assembly by retaining the distribution of seats same as it was done for Constituent Assembly on adhoc (wrong) basis i.e 43 MLAs for Kashmir Region and 30 for Jammu Region totally ignoring that by that time J&K Representation of People Act1957 had been enacted laying down very very clear parameters (Section-4, Sub Section -2, Clause (a)-ipopulation,ii geographical compactness i.e area iii: Nature of terrain iv Facilities of Communication v. and the like considerations) for the distribution of single member segments in the Legislative Assembly (b) Section -50 of J&K Constitution had constitutionally allocated only 12 elected members in the Legislative Council for areas in Kashmir Region and 14 (2 more than Kashmir Region) elected members in Legislative Council for Jammu Region. Third it was in again in 1966: In 1966 on adhoc basis only one seat was reduced from areas falling in Kashmir Region and seats over Jammu region increased from 30 to 31 only where as needed was atleast 38.

Fourth it was in 1975 : In 1975 by 12th Constitutional Amendment Act of 1975 of 19-08-1975 when Clause - a of Section 48 of J&K Constitution was amended to increase the seats open for elections from 75 to 76 out of 100 but again on adhoc basis seats were delimited as 32 for

Jammu region as against min 38 to 39 and 42 as against fair number of max 35-36 for Kashmir region since in terms of J&K RPA

of 1957 where atleast 4 out of 5 deciding parameters were physically in favour of Jammu Region that also had more elected MLCs in Legislative Council (14 as against 12 for Kashmir Region).

Fifth time it was in 1979. Before June 1979 Jammu Region spread over 26293sq km area had 6 District where as Kashmir Region spread over just 15948 sq km had only 3 Districts but through SRO 306 of 6/6/1979 Government arbitrarily increased the districts to 6 in Kashmir region too i.eBaramulla, Kupwara, Anantnag, Pulwama, Srinagar; Badgam.

Sixth time it was in 1984: in view of objections from Jammu Region for the injustice being meted like not increasing districts in Jammu Region in 1979 Government appointedin 1981 Wazir Commission and Wazir Commission in 1984 recommended increase of districts in Jammu region from 6 to 9 and from 6 to 7 in Kashmir region but the J&K Governments did not implement even the Wazir Commission recommendations.

Seventh time it was in 1995 : An exercise, rather the only exercise, for regular delimitation of Assembly Segments had been started in 1981(first vide SRO No; 537 of 02-12-1981 Delimitation

Commission headed by Justice J. N. Wazir, Retd CJ of J&K HC) &was still continuing in 1990s. The Delimitation commission

by its order of 27 April 1995 distributed 46 MLAs over Kashmir Region and only 37 MLAs over Jammu Region totally defying the guiding parameters laid down in the J&K RPA of 1957 {Jammu region is much less compact than Kashmir region: The terrain of areas in Doda, Kishtwar; Udhampur; Reasi, Kishtwar; Ramban, Kathua, Rajouri and even some parts of Samba District is bad and difficult as compared to most of the areas in Kashmir region. The surface transport infrastructure in Jammu region was at much lower level as compared to Kashmir region making it more difficult for a MLA visit his people or for people to visit him}. Writer too had submitted his draft notes on the exercise done by him to the Chairman Delimitation Commission in 1994 to enable the DC to have a birds eye view (The material prepared by the writer had also been published in the leading Daily News Paper of J&K (14-06-1992, 14-07-1992,26-02-1993, 4-101993,25-03-1995, and like). Eighth time it was in 2002. It was in 2002 that the then National Conference lead J&K Government sensing growing awareness amongst people and fearing a fair delimitation next time got the J&K Constitution amended through 29th Amendment Act of

2002 providing in Section 47(3) in a way that next Delimitation for Legislative Assembly could be held only after 1931.

Ninth time it was in 2006-07: In 2006 the PDP-Congress Government headed by Ghulam Nabi Azad was in place and without doing any rational exercise as well as ignoring the 1984 Wazir Commission recommendations for making 9 districts in Jammu Region and only 7 districts in Kashmir Region instead vide SRO 185 of 22 May 2007 increased the Districts in Kashmir Region from 6 to 10 and in Jammu region also to10 in a way giving 300 % more than what was recommended by Wazir Commission (in 1984) to Kashmir region & only 33% more to Jammu region.

Tenth time it could be now in 2021 looking at what the present Delimitation Commission for UT of J&K has been reported to have shared with its Associate members on drafts being prepared where in it has been reported that 6 more seats out of the 7 new seats will be distributed over Jammu Region along with the existing 37 seats i.e making total 43 and 1 seat over Kashmir Valley in addition to existing 46 thereby making 47 in Kashmir valley. People 'have' set very high hopes in the 2020 Delimitation Commission hoping that even out of earlier 83 seats 43 to 44 seats may fall in the basket of Jammu region leaving only 40 to 39 seats for Kashmir region ; and after taking into account new 7 seats the commission may

distribute 47 to 48 seats of over Jammu region and about 43 to 42 seats over Kashmir Region. But the draft proposals that have come in reports too are defying the parameters laid down for proving a representative of nearness to people in the Legislative Assembly as well as the constitutional facts like Section-50 of J&K Constitution where under Jammu Region had more elected MLCs (14) as compared to Kashmir region that had lesser (12 only). No doubt the task that the present DC has is unique since there is no exercise done earlier of the type that critically making use of the 5 parameters for delimitation of a Legislative assembly since it had been only J&K where in the past serious wrongs had been done. Delimitation Commission has to design its own model and for that it required collection of extensive ground information, analysing the information and fitting that into the working model specifically designed. It appears DC could not collect and has not been provided enough of working tools/ assistance by even the" Associate Members". Hope the Delimitation Commission does not shake the faith of the people outside Kashmir Valley and final orders carry a rational message much different than what has been reported. Ofcourse responsibility more lies on the Associate members too.
