Sikhs in J&K disenchanted as Delimitation Commission overlooks community: Bunty

Seeks 2 seats reservation for Sikhs in J&K Assembly

JAMMU: Chairman, Sikhs for Humanity Foundation (SFH), Surinder Singh Bunty on Tuesday questioned the criteria adopted by the Delimitation Commission in draft proposal to give 9 and 7 seats to ST and SC communities respectively and completely ignoring the Sikh community which has considerable population in both the provinces of the UT viz Kashmir and Jammu.

Addressing a press conference here, the Chairman SFH said that going by the tall claims of the government with regard to giving fair deal to each and every segment of the society in the delimitation process, the Sikhs in the UT of J&K had pinned hopes this time to get justice but what has

come to fore till date is quite dissatisfying as Sikhs have been marginalized again with aforesaid panel completely ignoring the community which has a track record defending borders by proving their mettle in the army and even by staying in the valley despite adverse situation due to turmoil and personal attacks on the community. He said that

looking into the contribution and role of Sikhs in strengthening the borders and remaining at forefront as nationalist population at least the community should have been given 2 seats as political reservation in J&K legislature. He, however, expressed concern over sheer neglect of the Sikh Community in the process of delimitation.

He reiterated that the Sikh Community of J&K has a formidable contribution in the progress and development of erstwhile State of J&K and has history of major sacrifices in the safety and protection of the region from foreign invasions. He said that it is agonizing that the community is being continuously marginalized politically as no one gave the due which the Sikhs deserve on merit.

He urged that still there is time to consider the just and genuine demand of Sikhs by way of giving them what they deserve on merits as otherwise the community will feel dejected and deprived, which should not be the case especially under the panel which is known for its fairness and integrity.

Anil Dhar demands constitution of Truth & Reconciliation Commission to unveil horrendous migration of KPs from Valley

JAMMU: Seeking constitution of Truth and Reconciliation Commission to unveil the circumstances leading to massacre, plunder and subsequent displacement of Kashmiri Pandits from their homes and hearths in the Valley early 1990, former National Conference Provincial President Anil Dhar on Tuesday said this will let the nation and the world know atrocities committed on the peaceful, educated and civilised minority community at the onset of terrorism in Kashmir.

Talking to media persons during his interactions all day and in a press conference here this afternoon, Anil Dhar said this will also end the hurtful, malicious and motivated propaganda and the blatant lie about former Governor Jagmohan having engineered or facilitated the migration. Such venomous propaganda has now crossed the limits with responsible people like those having occupied the constitutional positions getting swayed and making painful observations on

Kashmir history's most horrendous chapter, he said.

Dhar expressed anguish and deep hurt over the observations of National Conference President Dr Farooq Abdullah, blaming Jagmohan for Kashmiri Hindus migration, saying this was contrary to the fact that it was Pakistan and its proxies which still continue to be responsible for the migration and exodus of Kashmiri Hindus from the Valley.

He wondered why Dr Farooq Abdullah is trying to provide shield to Pakistan and the terrorists, knowing well their machinations about ethnic cleansing. He reiterated that the National Conference has lost interest in the cause of

Kashmiri Pandits.

He also reiterated the reasons given in his letter to Dr Farooq Abdullah while parting ways with the party, saying the utterances from the NC leadership did not instill any sense of confidence in the Kashmiri Hindu community, who have faced the worst kind of persecution, genocide and mayhem from the past more than thirty years and have lost their homes and hearths. He also reiterated that the latest statements of Vice President Omar Abdullah reflect communal overtones and at times give a feeling of his bias against the Hindus.

Anil Dhar asked the NC leadership that if their claims and blame on the former Governor

Jagmohan was true, who had conspired to shunt out thousands of Muslim and Sikh families from the Valley in 1990, who are registered as migrants with Relief Commissioner in Jammu. Anil Dhar referred to the reply given by the government to a question of Rafi Ahmed Mir in the Jammu and Kashmir Legislative Assembly during budget session 2010-11, putting the total number of Kashmiri migrant families registered with the Relief Organisation as 38,119 which included 34,202 Kashmiri Pandits, 2168 Muslims and 1749 Sikhs.

The reply had further stated that of the registered families 13,702 Hindu families were entitled to draw the relief against 2025 Muslim and 143 Sikh families. "Did Jagmohan conspired in the migration of the Muslim migrants also?", he asked. Anil Dhar sought a white paper to clear the mist about actual migration, community wise, so that the truth about claims of Jagmohan having engineered the migration comes to fore.

HC upholds dowry death charges against husband & ors

JAMMU: Justice Vinod Chatterji Koul while upholding the charges framed against husband and ors in dowry death case, observed that suicide is one of the modes of death falling within the ambit of Section 304-B IPC. The expression "otherwise than under normal circumstances" would comprehend within its sweep, the death caused by burns or bodily injury or even the suicidal death.

The criminal revision petition filed by the accused in a criminal trial of FIR No.178/2014 for offences under Section 306, 304-B, 109 and 498-A RPC pending before the Court of 1st Additional Sessions Judge, Jammu ["the trial court"], is, directed against the order of the trial court dated 25.02.2015, whereby the trial court has framed charges against all the accused for commission of offences under Section 306, 304-B and the case of the prosecution pending before the trial court is that on 13th October, 2014, a telephonic information was received at Police Post, Gajansoo from Police Control Room, Jammu, that a lady, namely, Pooja Sharma W/o Santosh Kumar Sharma R/o Galbaday Chak, Tehsil and District Jammu, had been brought to Government Medical College, Jammu, as a poison case for medical treatment.

The Police was informed that the lady Pooja Sharma was brought dead in the Government Medical College, Jammu and her body had been kept in the Mortuary Room of the hospital. On receipt of said information, the Police initiated proceedings under Section 174 of Cr. P. C. The Officer Incharge of Police Post, Gajansoo, along with other police officials rushed to Government Medical College, Jammu, and took possession of the dead body of the deceased in presence of her legal heirs and prepared farad maqboozgi naash on spot. After post-mortem, the dead body of the deceased was handed over to her legal heirs for last rites. Statements of witnesses under Section 175 of the Code of Criminal Procedure were recorded and on the basis of statements of witnesses so recorded, commission of cognizable offences was made out. Accordingly, FIR No.178/2014 was registered and the investigation was entrusted to Incharge Police Post, Gajansoo.

Justice Vinod Chatterji Koul after hearing Sr. Adv Sunil Sethi with Adv Sumit Nayyar for the applicants whereas AAG Assem Sawhney appearing for the UT, while dismissing the petition observed that Courts should use their discretion to determine if the period between the cruelty or harassment and the death of the victim would come within the term "soon before".

What is pivotal to the above determination, is the establishment of a "proximate and live link" between the cruelty and the consequential death of the victim." In view of clear dictum laid down by the Supreme Court, when the evidence on record is analyzed in the context of legal position discussed above, it is abundantly clear that there is sufficient evidence on record to, prima facie, hold that soon before death, the deceased was subjected to harassment on account of dowry demand by the accused.

The other argument raised by Sethi, senior counsel that suicidal death does not fall within the ambit of Section 304-B RPC as the same is separately dealt with in Section 306 RPC, is also without any substance and is no longer res integra.

In the case of Satbir Singh (supra) followed by the judgment of the Supreme Court in the case of Bhupendra, it is now beyond any pale of discussion that suicide is one of the modes of death falling within the ambit of Section 304-B IPC.

Court acquits then Director ULB & ors in illegal appointment case

JAMMU: Additional Sessions Judge Anticorruption Jammu Ritesh Dubey acquitted Mohinder Singh, then Director Local bodies Jammu, Sat Pal Saini then Administrator NAC Lakhampur and Ravi Kumar then I/C Executive Officer NAC Katra in illegal appointment case after facing trial for 16 years.

According to the VOJ (now ACB) case that a PE was conducted on the complaint lodged by Dr. Romesh Chander Sharma MLA Nowshera followed by letter No. 312 dated 24-04-2003 from private Secretary to MOS Housing and Urban Development that despite a ban on recruitment, the then Director Local bodies Mohinder Singh illegally appointed Devinder Singh s/o. Mukhtyar Singh who was later transferred along with post to Municipality Poonch. The enquiry revealed that Mohinder Singh had issued appointment/regularization orders in respect of 10 individuals named in the charge sheet, by abusing his official position, and in furtherance of a criminal conspiracy hatched with Sat Pal Saini the then Administrator NAC Lakhampur and the beneficiaries accused. Enquiry revealed that 7 out of the 10 illegal appointees were close relatives of Sat Pal Saini. These appointment orders were issued without advertising the posts, inviting the applications and conducting interviews, obviously for extraneous considerations. Also the appointments were made by the accused against non-available posts, with ulterior motive of conferring undue pecuniary benefits upon the beneficiaries and putting state exchequer to loss and the instant case was registered, and investigation was done. The beneficiaries were found engaged, or/and regularized first, then posted to some other district, and then brought back within a small period of 3/4 months respectively. For some of the beneficiaries, recommendations were found marked to the Director by the Special Assistant/PA to MOS H&UDD. All the 10 illegal beneficiaries did not face any interview. Some had not even applied. This clearly indicated that all these appointments were made on pick and choose basis. Investigation revealed that Mohinder Singh the then DLBJ in connivance with Sat Pal Saini the then Administrator NAC Lakhampur; Ravi Kumar the then Executive officer NAC Katra/Batote, Nanak Singh the then Executive Officer NAC R.S Pura and Irshad Hussain, the then Executive office NAC Nowshera, issued the engagement/ appointment orders in March, July, October and December 2002, in respect of illegal beneficiaries, in different local bodies of Jammu province without any available vacancy, in view of extraneous considerations willfully, and in violation of various Government orders/notifications/ SROs mentioned in the charge sheet.

Additional Sessions Judge Anticorruption Jammu Ritesh Kumar Dubey after hearing Sr. Adv Abhinav Sharma, Advocates SC Bali, AP Singh and Ajay Bakshi for the alleged accused persons observed that the fact that beneficiaries were regularized in short span of time after their initial appointments. Though the same may appear to be little unusual yet the same again cannot be said to be by way of criminal misuse of authority in view of the established facts and circumstances such as no illegality was found in initial appointments, no rules or practices governing such cases have been established by the prosecution, and Government Orders including SRO 64 have been observed herein before as not applicable to present appointments. If the prosecution basis its claim on the wrongfulness of regularizations, it ought to have established the reasons for the same. But except for a submission as to application of SRO 64, the prosecution has not been able to prove why the aforesaid regularizations were not valid. It is noted again that the non-removal of appointees/regularized officials from said service, itself supports the defence submission that there was nothing wrong in the same.

Court further observed that there is no doubt that the appointments, on their face, may not appear to be done in a very healthy manner. But the trials and the judgments are not to be based on suppositions and assumptions, and prosecution case does not get proved on the face of its accusations. And the prosecution has to establish and prove its case by leading cogent evidence. The evidence as could be tendered in this regard was to present exact rules, procedures, regulating appointments in the local body institutions. But that has not been done by the investigating and prosecution agencies. Further, the conduct of the accused herein could have been criminal if the same was a deviation from the practices followed in the appointments in Local Body Institution. It is noted again that no such deviation is established in the present case in view of the lack of evidence to establish such practice. Without proving the practice, obviously the deviation could not be established, Court said. It is further noted again that no breach of the relevant Government Orders/SROs regarding regularization, ban etc, is found committed by the accused.

With these observations, Court is not convinced that the prosecution has been able to remove the element of doubt from its accusations against the accused as well as the charge framed by this court, by such strong evidence as could lead to one and only one hypothesis pointing to the guilt of the accused and ordered that the accused are acquitted of the charge for the offences under sections 5(1)(d) r/w 5(2) PC Act Svt. and 120-B RPC, framed by this court. The Challan is dismissed.
