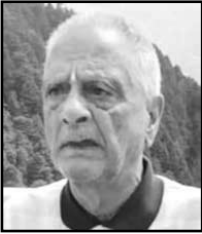

Drug peddler arrested with poppy straw

GANDERBAL: Continuing its efforts to eradicate menace of drugs from the society, Police on Sunday arrested a drug peddler in Ganderbal and recovered contraband substances from his possession.

As per details, a party of Police Post Nagbal at a checkpoint established at Grthal Nagbal intercepted a suspicious person who tried to escape from the spot however, the alert police tactfully apprehended him. He was identified as Abdul Ahad Mir, son of Ali Mohd Mir, resident of Wayil, Ganderbal. During checking, 2 Kg Poppy Straw was recovered from his possession. He has been arrested and shifted to Police Station where he remained in custody. Accordingly, FIR No. 229/2021 under relevant sections of law was registered at Police Station and further investigation
