# AIBCU demands 27 per cent reservations for OBC communities

# KPC hails Home Minister, LG for rejecting demand of statehood before elections

JAMMU: Kashmiri Pandit Conference (KPC) has hailed the statements of Union Home Minister Amit Shah and LG Manoj Sinha, wherein they rejected demand for grant of Statehood before elections in J&K and said that rehabilitation plan for KPs will be declared within three months, which will not be a part of 6,000 jobs and equal number of residential quarters in Valley.

Speaking during a meeting held on Sunday, Kundan Kashmiri, President KPC has said that grant of statehood to J&K will be disastrous at this time as it would vanish entire plan to restore peace and ensure development in J&K besides ensuring rehabilitation of displaced Kashmiri Pandits. He further said that LG's administration is doing a tremendous job and needs more time to eradicate corruption, separatism besides curbing terrorist activities.

"Mind-set of Kashmir-cen-

tric leadership has not changed is still against the nation. Further; time is not congenial as yet for any political change which includes change of UT status to statehood or restoration of other concessions, as it will affect law & order in erstwhile state of J&K," said Kundan, adding that as J&K is the most sensitive part of Indian nation having its borders with rogue neighbouring countries viz Pakistan and China, as such decisions taken in hurry or under pressure is neither advisable nor in interest of Nation. He further welcomed L.G's statement regarding rehabilitation of KP community and urged Home Minister and LG J&K to initiate a dialogue process with KP community leadership for discussing and finalising the rehabilitation plan.
