



In case any candidate fails to join within the stipulated period the engagement order shall be cancelled.

The engagement shall be subject to the following conditions:

- The appointment shall be purely on contractual basis with a monthly consolidated remuneration as mentioned in Advertisement Notice/ as per guidelines.
