LG directs safety...

safety, he added. Divisional Commissioners were directed to take strict measures for removal of all encroachment from Roads including hoarding that creates barrier for safe driving.

The Lt Governor asked the Traffic Police to put a crackdown on over-speeding and ensure regular highway patrolling. Installation of road signage's and speed limit boards should be given special focus, he added.

Health department was instructed to explore the possibility of developing trauma centres facilities, if required anywhere.

Directions were also passed on adopting digital and automated systems and ensuring optimal utilisation of the existing equipment and digital technology installed on Highways and roads.

The Lt Governor further called for replicating the best models in the country for developing a robust system of Audit of accidents.

Highlighting the large number of visitors who would be coming to India during its G-20 presidency and the international media focus on various events, Prime Minister Modi underlined the importance of states and UTs utilising this opportunity to re-brand themselves as attractive business, investment and tourism destinations, according to the statement.

He also reiterated the need to ensure people's participation in the G-20 events by a "whole-of-government and a whole-of-society approach".

A number of governors, chief ministers and lieutenant governors shared their thoughts during the meeting, emphasising the preparations being done by the states and UTs to suitably host G-20 meetings, the statement said.

The meeting was also addressed by External Affairs Minister S Jaishankar and a presentation was made by India's G-20 Sherpa Amitabh Kant.

Earlier this week, Prime Minister Modi had told an all-party meeting that India's G-20 presidency is a unique opportunity to showcase the country's strengths to the entire world.

India officially assumed the G-20 presidency on December 1.

The country is expected to host over 200 preparatory meetings across the country beginning this month. The next G-20 Leaders' Summit at the level of heads of states or governments is scheduled to be held on September 9 and 10 next year in New Delhi. G-20 or Group of 20 is an intergovernmental forum of the world's major developed and developing economies. It comprises Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the UK, the US and the European Union.

and free and fair polls. The electoral exercise in Jammu and Kashmir is usually spread over a month. The revision of the electoral rolls was done after a gap of nearly three years. It was last carried out with reference to January 1, 2019 as the qualifying date.

The electoral rolls could not be updated after the abrogation of provisions of Article 370. Later, the constituencies were redrawn following a delimitation exercise.

Following the delimitation, the number of assembly seats have gone up from 83 to 90, excluding the seats allocated to Pakistan Occupied Kashmir.

The final electoral rolls of Jammu and Kashmir were published on November 25 with the highest-ever addition of more than 11 lakh voters, officials had said.

Taking into account the deletion of names from the electoral rolls, the net increase stood at 7,72,872 electors, they said.

The final electoral rolls have a total of 83,59,771 electors -- 42,91,687 males, 40,67,900 females and 184 third gender.

During this special summary revision period, a record 11,40,768 claims were received for inclusion of names in the electoral rolls across the Union territory.

Out of these, 11,28,672 claims were accepted and only 12,096 claims were rejected. These included 3,01,961 claims of inclusion in the age group of 18-19.

A total of 4,12,157 requests for deletion were received, out of which 3,58,222 were

accepted and 53,935 were rejected.

There has been an addition of 613 new polling stations in the Union territory.

The gender ratio of the final electoral Roll has increased from 921 to 948.

to the confirmed passengers about cancellation of sorties due to bad weather conditions. The Div Com instructed the DCs to give vide publicity and notify the fares and timings at Hospitals, Bus Stand and other prominent places for information of the general public.

While giving details of routes and fare the representatives of Civil Aviation informed that the fare from Jammu to Rajouri will be 2000, Jammu to Poonch 4000, Jammu to Doda 2500, Jammu to Kishtwar 4000, Kishtwar to Nawapach 1500, Kishtwar to Sounder 1000, Kishtwar to Inshan 2000.

The Div Com said that the operation of a regular helicopter service would not only provide immediate relief to the locals but will also help during medical emergencies. The meeting was informed that the procedure for medical emergencies will also be finalized.

It is also alleged that the present accused is habitual offender as he was also involved in criminal conspiracy to leak question papers of FFA, JE (Mains) exams as well and has collected huge proceeds of crime. In such circumstances, the accused who is involved in such serious and economic offences cannot claim bail on medical grounds," the Court observed.

While rejecting bail application, CJM Jammu Anjum Ara observed that the Court is of conscious of the fact that liberty of a person is precious and is to be protected by courts however liberty of a person who is accused of an offence is to be considered on the facts and circumstances of the case. "Offences involved in present case impact whole society especially meritorious students whose future is ruined by such unfair methods. Such socio-economic offences need to be dealt with a different approach. Thus, accused is not found entitled for any leniency of bail at this stage for the reasons viz; he has played a key role in criminal conspiracy with other accused persons; he is involved in serious economic offence; he is habitual offender involved in other similar cases; further investigation of the case is still going on; the accused being highly influential can temper with evidence and hamper/frustrate further investigation and the involvement of many more accused is yet to be ascertained by the investigating agency as such the release of accused at this stage will hamper the investigation," the Court observed.

field that technical bids pursuant to the notice inviting tenders are scrutinised by the technical experts and sometimes third-party assistance from those unconnected with the owner's organisation is taken. SDGs to be...

J&K is the front runner in implementing several schemes and programmes and is also closing to saturating several other schemes.

"Apart from this, J&K is first among many states and UTs in achieving aspirational districts, aspirational towns, aspirational blocks and aspirational Panchayats. J&K is the only one in the entire country to tread this developmental path. There is another set of measures which include Panchayat Development Index, Block Development Index and City Development Index parallel to these. We also have a third element in the shape of 1250 Deliverables through which we are rating and fast tracking achievement of different government schemes and welfare measures," he added. The Planning Development & Monitoring Department, Government of Jammu and Kashmir organized a UT-wide workshop on Sustainable Development Goals for Jammu Kashmir here. The consultation was organized in collaboration with NITI Aayog, Ministry of Statistics and Programme Implementation (MoSPI) and United Nations Development Programme (UNDP).

The UT-wide consultation saw participation from senior officials of all departments of Jammu and Kashmir and included speakers and experts from Union Ministries, State Governments and UNDP. The Sustainable Development Goals or the 2030 Agenda on Sustainable Development is a global consensus signed by India and 190 plus countries of the world in 2015.

It includes 17 Goals and 169 global targets, which cut across social, economic and environmental dimensions. In India, NITI Aayog, in close coordination with MoSPI, monitors the progress on the global goals at the national as well as at the level of States and Union Territories. The SDGs have brought the focus on development-related out-

comes and not just financial expenditure and physical progress.

This workshop was held at the heels of a new partnership between the UT and NITI Aayog. The UT of Jammu and Kashmir and NITI Aayog, in technical partnership with UNDP, have entered into an agreement to establish a Sustainable Development Goals Coordination Centre (SDGCC) at the Planning, Development & Monitoring Department. This partnership will seek to strengthen the monitoring system of the state, derive actionable insights from data analytics, promote gap-based targeting and build capacities.

The consultation in Jammu included sessions by NITI Aayog on the Indian model of SDG localisation, national and UT indicator framework by MoSPI, sharing of best practices on the adoption of the SDG framework by Gujarat, Uttarakhand, Haryana and Punjab, and on aligning budgets to SDGs.

Detailed discussions and deliberations on the UT's progress in adopting the SDGs, the progress and achievement pertaining to the goals and charting the way forward were the central themes across all sessions. Every session was followed by a question and answer session where participants gave their suggestions and feedback to the speakers. Secretary, PD&MD briefed the gathering that J&K has been a frontrunner UT scoring better than many States/UT's in majority of sectors like health, agriculture production, education, renewable energy, providing civic amenities, enhancing forest cover, and ensuring gender equality esp during the last two years.

Dr Raghav Langer, Administrative Secretary thanked the Chief Secretary for his valuable insights and guiding the UT on the journey towards fulfilment of SDG's. He also thanked senior Administrative Secretaries, DG Planning PMCE/PFD, ED E&S, DG Budget and other senior officers of Planning Department for their interactive participation in the workshop.

While some state governments and high courts favoured the proposal, some were not in favour of creation of ALJs. Some others wanted changes in the proposal formulated by the central government, he pointed out. The matter regarding creation of a Judicial Service Commission to help the recruitment to the post of district judges and review of selection process of judges or judicial officers at all level was also included in the agenda for the Chief Justices Conference held in April, 2015, where it was resolved to leave it open to respective high courts to evolve appropriate methods within the existing system to fill up vacancies for appointment of district judges expeditiously.

The Expert members includes Dr. A.B. Akolkar, Former Member Secretary, Central Pollution Control Board, Ministry of Environment & Forest, Government of India; Prof. A. A Qazmi, IIT Roorkee; Prof. Meenakshi Dhote, Environment Planning Department, SPA, New Delhi; Prof. Aarti Grover, Landscape Architecture Department, SPA, New Delhi; Prof. K. K. Pandey, Prof. of Urban Management, Indian Institute of Public Administration, New Delhi; Prof. Zahoor Ahmad Rather, SKUAST, Kashmir (Floriculture & Landscape Department); Dr. Pratibha Singh, Expert in Hydrology, RMSI; and Dr. Himayun Rahid, Scientist, Department of Environment and Remote Sensing, J&K. The committee has been tasked to comprehensively examine, after due consultations with the stakeholders, the question of buffers of the Dal and allied water bodies covered by the Srinagar Master Plan 2035, from an environmental/lake ecosystem and urban planning/design point of view for the sustainability and conservation of these water bodies also ensuring that the gains from the efforts over the last two decades are taken to their logical conclusion.

The committee has been asked to submit a comprehensive report with clear and unambiguous recommendations on the extent of the buffers around these water bodies and the permissible activities that could be allowed in the buffer zones or in such areas beyond the buffers as would be necessary in the interest of the conservation of these water bodies. "The committee shall be serviced by the J&K Lake Conservation and Management Authority and shall complete its task within two months from the date of issuance of this order," the order reads.

Three arrested with Charas

Charas like substance from their possession. A peddler was arrested by a police team of Police Station Atholi led by SHO Insp Vikram Parihar while on routine patrolling.
