JAMMU: Jammu and Kashmir Bharatiya Janata Party (BJP) senior leader and Spokesman Thakur Abhijeet Jasrotia has criticized Mohammed Younsif Tarigami, CPI (M) leader for his statement that BJP is hesitating and running away from holding elections in Jammu & Kashmir. In a press statement issued

here, Jasrotia affirmed that likes of Farooq Abdullah and Tarigami are products of those days when rigging in elections was norm and Delhi-led Congress and Third-front Governments used to install puppets. Describing Tarigami's statement as akin to bad workman quarrelling with his tools, Jasrotia observed that Election Commission
