Several MCs of Jammu Div self-declare ODF +status

JAMMU: Several Municipal bodies, including Municipal Councils and Municipal Committees of Jammu Division have self-declared as Open Defecation Free plus status after complying with all bye-laws and development done in Municipal limits as per the Swachh Bharat Mission norms.

The Municipal Council Ramban and Municipal Committee Billawar, Ramnagar and Katra after proclaiming ODF Plus status have sought Feedback/suggestions/objections within 15 days to perform all necessary action on the comments/ suggestions/ objections received.

The Municipal Bodies have also declared Open Defecation, open urination, and unauthorized dumping of sewage in open areas, drains and water bodies as punishable offences. The Civic authorities of these Municipal areas have informed the public that a penalty of INR 200 would be imposed for open defecation, INR 100 for open urination and INR 500 for unauthorized dumping of sewage in

open areas, drains and water bodies.

Meanwhile, Ramban MC has enjoined upon all concerned that a penalty will be imposed for violation of National Sanitation bye laws related to open dumping/desludging of Faecal Sludge in Street/Nallas/Open Drain/Water bodies/open spaces within Municipal Jurisdiction. The violation of National Sanitation bye laws by the Households would attract a fine of Rs. 2000 for 1st offence and Rs 3000 for 2nd offence.

Similarly, Commercial establishments, Offices, Hotels and Private Desludging Operator would be charged Rs. 3000 fine for 1st offence and Rs 5000 for 2nd offence.

Therefore, all individual households/commercial establishments, offices and hotels etc. are accordingly informed to approach Municipal Council Ramban for availing the services for desludging/ clearing of Faecal Sludge from their premises by paying the nominal charges fixed by the Municipality.

CD Hospital performs rare surgery of implanting SEMS

SRINAGAR: The Chest Disease Hospital, Srinagar, on Monday conducted a rare and complicated surgery implanting a Self-expanding Tracheobronchial Y-shaped metallic stent (SEMS) in a patient diagnosed with cancerous growth of windpipe (trachea) hence compromising the airway/oxygenation.

The procedure was jointly performed by the department of pulmonary medicine and department of Anaesthesia GMC Srinagar on a 52 years male, suffering from an increasing shortness of breath and stridor, who upon Bronchoscopy revealed cancerous growth of trachea and Biopsy was later diagnosed with squamous cell carcinoma.

The surgery was performed by a team of interventional pulmonologist led by HOD Pulmonary Medicine Professor Naveed Nazir Shah, Professor Khurshid Ahmad Dar, Associate

Professor Syed Suraiya, Dr. Mohammad Yousuf Dar, Dr. Naem Firdous, Dr. Aaliya Mohi ud Din, Dr. Hena Mustafa, Dr. Shahid Majid and Dr. Aasir Hussain, The anaesthesia team was comprised of Dr. Israr ul Haq, Dr. Rameez Raja, Dr. Mir Faisal who under the guidance of HOD Anaesthesiology, Dr. Rukhsana Najeeb along with allied OT staff including Hilal (I/C), Gulzar, Mohammad Younis, Mohammad Hafeez. Y Shaped metallic stent was placed in position under direct vision via bronchoscope.

By performing this procedure, the CD Hospital has made its mark in the field of international Pulmonology thus registering a great achievement in the history of Chest Medicine.

Secretary, Health and Medical Education Department, Bhupinder Kumar, has complimented the entire team of CD hospital for their contribution in the medical field.
