AKHNOOR: A nine years old child was crushed to death by a school van on Tuesday.

As per report, nine years old Krish Sharma, son of Raj Kumar, resident of village Agore Garhi, tehsil Bhalwal got hit by a school van (JK02CX 4514), when he was riding a bicycle with his elder brother. Locals immediately shifted him to Sub District Hospital SDH Akhnoor where doctors declared him as brought dead.

On information, SHO Joginder Chib along with team rushed to spot and arrested school van driver besides seizing school van. Body of Krish Sharma was handed over to family for last rites.



recovered approximately 5.75 gm Heroin (Chitta) from his possession. During patrolling, a Naka was established by Addl SP Samba, Surinder Choudhary assisted by SDPO Vijaypur Priyanka Kumari and SHO Vijaypur Insp. Tribhuvan Khajuria near Ishant Hotel, Gurha, Morh Vijaypur. A person was found moving under suspicious circumstances. During frisking of suspect, 5.75 gm Heroin (Chitta) like substance was recovered from his possession, who was identified as Rinku Kumar, son of Dewan Chand, resident of Nagrota, Uttarbhani. He was arrested on the spot and contraband item was also seized. FIR 192/2022 under sections 8/21/22 of NDPS Act was registered at Police Station Vijaypur.
