3. The pre bid meeting if desired by the participating firms shall be held in the office of the Executive Engineer Jal Shakti (M) GWD Division Jammu on 22.12.2022 (1300 hrs).

4. The bids shall be submitted/uploaded from the website <http://jktenders.gov.in> from 23.12.2022 (1400 hrs) to 28.12.2022 (1800 hrs).

5. The complete bidding process shall be online and scanned copies of the following documents will have to be uploaded before due date:-

(i) Copy of treasury e-Challan/receipt for Rs. 500.00 against the cost of tender document under the receipt Head 0215 in favour of Executive Engineer, Jal Shakti (M) Ground Water Drilling Division Jammu indicating name of work to be executed. It may be noted that the receipt of the e-challan should be of the date after the issuance of publication of the e-tender.

(ii) The tenders shall be accompanied with an earnest money of 2 % of quoted rates in the shape of CDR/FDR, from a scheduled Bank payable in JAMMU. The CDR/FDR shall be pledged to Executive Engineer Jal Shakti (M) GWD Division Jammu, valid for a period of 12 months from the last date of submission of bids. The earnest money deposit shall be refunded in favour of unsuccessful tenderer immediately after finalization of the tender, whereas it shall be retained in case of successful tenderer till signing of agreement and furnishing of performance security

(iii) Copies of tender documents, terms and conditions duly signed and stamped (each page) by bidder.

(iv) Scanned copy of Experience certificate of having completed one similar work during last five financial years. The experience certificate shall have been issued by an officer of the rank not below an Executive Engineer of any Government Department/Semi Government/PSUs.

(v) Scanned copy of Registration of Water Well Drillers issued by Chief Engineer Jal Shakti (PHE) Department Jammu. In case the bidder is not able to furnish the Registration with the cover 1st of this bid document, he can produce the same before the opening of cover 2nd of this bid document.

(vi) Scanned copy of the latest Income tax return certificate.

(vii) Scanned copy GST return in FORMGST-3B of the latest quarter.

(viii) Scanned copy of documentary proof of ownership or on hire basis of requisite machinery like Air Rotary (ODEX) Drilling Rig. In case of a firm having these machine/s arranged on hire basis the firm shall produce a copy of an agreement with the actual owner (Registered Drilling Firm) of the machine for lease of the machinery and expertise, duly attested by a Magistrate First class valid for a time period of not less than 06 months from the last date of submission of bids.

(ix) Average Annual financial turnover during any three financial years out of the last 05 years, ending 31st March of previous financial year, issued by a registered Chartered Accountant under his seal and signature shall be Rs 25.0 lacs.

6. The Technical Bids of the tender document received shall be opened online in the office of Executive Engineer Jal Shakti (M) GWD Division Jammu on 30.12.2022 (1400 hrs). If the office happens to be closed on the date of opening of the bids as specified, the bids shall be opened on the next working day during the office hours.

7. The Financial Bids of the tender document of the qualified bidders shall be opened online in the office of the Executive Engineer Jal Shakti (M) GWD Division Jammu. If the office happens to be closed on the date of opening of the bids as specified, the bids shall be opened on the next working or as to be decided by tender opening committee.

1 Bids must be accompanied with cost of Tender document in shape of e-challan through Treasury indicating Treasury Voucher No. & date, e-NIT No. and name of work duly crediting to 0059 (Revenue) should be between the date of start of bid favoring Executive Engineer PWD (R&B) Division Rajouri uploading a copy of treasury challan/receipt, Scanned copy of the earnest money/bid security in the shape of CDR/FDR/BG pledged to Executive Engineer PWD (R&B) Division Rajouri will also be required to be uploaded along with and relevant Mandatory documents as per check list mention in the SBD. The lowest found bidder (L1) should have to submit the hard copy of tender fee and earnest money in the Office of the Executive Engineer PWD (R&B) Division Rajouri at the time of award of contract.

2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.
