In Compliance to Hon'ble National Greent Tribunal Order Dated:- 10-12-2021 in O.A.No. 320/2021 and IN pursuant to the Environmental Guidelines for poultry Farms, January 2022 issued by Central Pollution Control Borad (Ministry of Environment, Forest and Climate Change, Govt. of India) , Kind attention of all Poultry Farm Owners is invited to the following:

1. Poultry Farms handling above 5000 birds will be covered under under the envrionmental Guidelines for poultry Farms, January 2022 issued by central Pollution Control Board (Ministry of Environment, Forest and Climate Change, Govt. of India).
2. Siting Criteria Accordingly shall apply to all consent to Establish (Fresh/ Renewal/ Consent to Operate (Fresh/ Renewal) cases of Pouty Farms handling above 5000 birds w.e.f 01-01-2023.
3. The Consent Fee Prescribed vide Order No. 59 SPCB of 2016 Dated:- 29-03-2016 based on the Capital Investment of the Units shall be applicable for the Calculation of Consent Fee for consent of Establish (Fresh/ Renewal/ Consent to Operate (Fresg/ Renewal) cases of Pouty Farms handling above 500 birds under Grenn Category.
4. All Poultry Farms shall follow the norms laid under the Environmental Guideline for Pouty Farms January, 2022 viz. Scientific disposal of dead birds and poulry lit-ter irrespective of the Number of Birds.
