

Get ISO certification for your processes: CS to JKMSCL

JAMMU: Chief Secretary, Dr Arun Kumar Mehta on Friday impressed upon the office bearers of the Jammu & Kashmir Medical Supplies Corporation Limited (JKMSCL) to get their all the processes adopted for procuring medicines, equipment and other supplies certified from International Organization for Standardization (ISO).

He made these remarks while chairing the 9th Finance Committee Meeting of the Corporation. The meeting was attended by Secretary, Planning; Secretary, Health; MD, JKMSCL and other concerned officers.

Dr Mehta urged the officers that for ensuring the superiority of all their methods of procuring the vital drugs and medical equipment it is necessary that the Corporation acquires the ISO certification. He told them to ensure that all the supplies provided to the hospitals are best in its quality and class.

The Chief Secretary further enjoined upon them to compare their rates of procurement with other States/UTs for having a fair idea about the same. He also advised them to have their comparison with the rates prevailing in Janashadi stores for the purpose of promoting efficiency in the Corporation.

Dr Mehta directed the Corporation to have the medical requisitions evaluated by a team of experts so that the quality medicines required by the hospitals are procured. He told them to see that all the major requirements of hospital

tals are met with the supplies provided to them.

He also told them to follow the GFR and other guidelines for hiring of contractual staff, administrative charges or writing off expired drugs. He asked

them to complete all the accounts till the current fiscal forthwith. He also called for auditing of all the accounts and utilization of their balances to bring value to government.

It was given out that the

machinery & equipment worth Rs290 crores have been procured by the Corporation in a World Bank funded project. Moreover purchase order to the tune of Rs 239.55 crores has been made for procuring equipment out of the funds provided by J&K Infrastructure Development Finance Corporation. This includes purchase orders for imported items amounting to Rs. 130.00 crores (viz 05 Tesla MRI Machines, 03 High End Color Dopplers & 05 CT Scan Machines) in which JKMSCL is mandatorily required to open Letter of Credit also for smooth reception of these equipment.

5. The Financial bid of the bidders shall be opened online after scrutinizing the technical bid in the office of the Executive Engineer Jal Shakti Mech. Division North Jammu in presence of the bidders who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

In case the original documents are not submitted by the L1 bidder after opening of financial bid, the tender will be cancelled and the bidder will not be allowed to participate in any further / future tendering process in the division for a period of one year.
8. The date and time of opening of financial bids will be notified on website <http://jktenders.gov.in> and conveyed to the bidders automatically through an e-mail message on their e-mail address.
9. The original documents when submitted by L1 bidder for the cost of tender documents, specified in the tender document should be same as uploaded on line (Scanned copies) otherwise allotment will not be issued, the tenders will be cancelled and the bidder will not be allowed to participate in any further / future tendering process in the division for a period of one year.
10. Bid security of successful tenderer will have to be in form of CDR/FDR of any scheduled bank and shall have to be valid for 180 days after last date of receipt of Bid.
11. Only such firms should submit tender, who have requisite infrastructure and workshop facility for carrying out similar type of job which may be inspected by the competent authority before awarding the job contract so as to access the working capacity of the tenderer. The workmanship and material used should be of high quality and as per the specifications of the job order / tender.
12. The bid for the execution of work shall remain open for acceptance for a period of 180 days from the date of opening of bids. If any bidder/ tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the earnest money of the firm shall stand forfeited.
13. The tenderers are advised to visit the site of work / inspect the parts to be fabricated before uploading their tenders so as to acquaint themselves with exact measurement and site conditions.
