Pursuant to Notification No. 094-BOPEE of 2022 dated 28-11-2022, the physical round of counseling of eligible candidates for admission to B Pharma Course-2022 at various Government/Private colleges/Institutions was held on 01-12-2022 simultaneously at BOPEE office Srinagar/Jammu. The list of candidates who participated in the said counseling and have been provisionally selected / allotted seat(s) as per their merit-cum-preferences for the said course is hereby notified as per the Annexure "A" to this Notification which shall remain available on website of the Board (www.jkbopee.gov.in) only. The candidates are advised to report in their respective allotted Colleges/Institutions w.e.f. 03-12-2022 to 10-12-2022 (till 03:00 P.M.) along with following documents:-

1. Marks card of qualifying examinations.
2. Date of birth (10th class marks card/Diploma issued by the Board).
3. Domicile certificate of UT of J&K and for candidates of UT of Ladakh, ST certificate issued by the Competent Authority of Ladakh shall be treated as Domicile Certificate.
4. Valid Reserved Category Certificate, if any, and
5. Any other certificate/document required by the authorities of the institution concerned.

It shall be the sole responsibility of the institution concerned to ensure proper check and verification of documents / eligibility strictly as per Pharmacy Council of India guidelines before any candidate is allowed for admission.

In order to complete admission process within the specified date, the Institutions shall keep their admission counters open even on holidays/off days and designate Nodal Officers to facilitate the candidates to complete their admission process well in time. However, the candidates in their own interest shall avoid waiting for the last day to complete admission formalities since delay has the potential of causing hardships to the candidates only.

It is hereby implored upon the management of all colleges/institutions to ensure the veracity of documents, particularly the category certificates wherever, the admission is to be granted in lieu of a particular reserved category. The Colleges / Institutions concerned shall ensure that, any candidate(s) with disability, if selected in open merit or some reserved category, it shall be ensured that his/her PwD Certificate/Eligibility is in conformity with Pharmacy Council of India guidelines, regulations framed by the regulatory authority and wherever required shall refer the matter to Medical Board to assess such candidates and make recommendations based on which concerned college shall take further necessary action. In case any such candidate does not fulfill the bench mark of eligibility, he/she shall not be admitted to the course/college.

The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false / fabricated, and action as warranted under law shall be initiated against such candidates.

1. The candidates who have been allotted seats during the first round of counseling in accordance with their merit / preferences shall have to join the allotted Colleges / Institutions upto 10-12-2022 and in case any candidate fails to join against his / her allotted seat(s) in respective College(s) he / she shall not be eligible to participate in second round of up-gradation/allotment counselling under any circumstances.
2. The seats under TFW Category shall be filled during second round of counselling, as & when held by the Board subject to the condition that 30% of candidates shall be admitted in respective College / Institution as per PCI guidelines.
3. The Colleges/ Institutions shall submit the shortfall, if any, to BOPEE Office, Jammu/Srinagar upto 03:00 P.M. on 10-12-2022 through e-mail jkbopee@gmail.com / coejakbopee@gmail.com.

The Annexure-A to this notification shall remain available on the website of the Board www.jkbopee.gov.in only.

The other terms and conditions shall remain the same as notified in e-Information Brochure / notifications / notices issued by the Board from time to time in this regard.
