The Black Annealed Barbed wire with standard specification conforming to product code BA-BW, allied materials like "U" nails etc. and its mechanical carriage including loading, unloading and stacking charges will be managed/procured himself by the contractor. A proper testing certificate with regard to the material i.e Barbed Wire etc. has to be produced by the contractor before the execution of work. The extraction and carriage charges of Wooden Fence Posts shall be deducted by the department from the bill of the contractor at the time of payment after satisfactory execution of work. A proper Measurement Book of the work has to be prepared against which work done payment is to be made to the contractor. In respect of DRSM work, the contractor has to extract/collect the stone, preferably Nallah Stone from the area to be identified by the Forest staff with fashioning of stones to be used along the exposed faces and carry upto the site of construction at required places especially in Soil eroded forest area.
