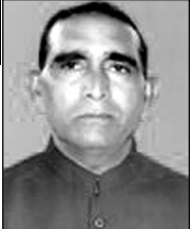

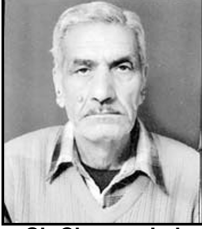

3 drug peddlers arrested with 15 gm heroin

UDHAMPUR: Continuing its endeavour to eradicate menace of drugs from the society, Udhampur Police arrested three drug peddlers in 2 different cases and recovered 15 gm Heroin like substance from their possession.

As per details, a party of Police Station Udhampur headed by PSI Kulbhushan Singh and assisted by SHO Udhampur Insp. Raghubir Singh under the supervision of Adtl SP Udhampur Sh. Anwaar UI Haq and Sahil Mahajan DySP Hqrs Udhampur, was deputed at Naka Point Jakheni when a Motoreycle (JK02CU 9308) was signaled to stop. The rider disclosed his name as Aditya Kumar, son of Sham Lal, resident of Village Dewla Chammb Tehsil Sadar District Bilaspur while pillion-rider was identified as Abinash Sharma, son of Shambu Dutt Sharma, resident of Prey Tehsil Ramnagar District Udhampur. During search, 6.5 gm heroin like substance was recovered from Aditya and 1.5 gm Heroin was recovered from Abinash, and both were arrested on spot. Case under relevant sections of law was registered at Police Station Udhampur.

In another case, a party of Police Post Round Domail led by PSI Akhilesh Khajuria Incharge Police Post Round Domail, apprehended one Sushil Sharma, son of Paras Ram, resident of village Kagote, Ramnagar, Udhampur from Ritti and recovered 7 gm heroin from his possession. The accused was arrested and sase under relevant sections of law was registered at Police Station Udhampur.

Father-son nabbed with illicit liquor

MIRAN SAHIB: Police on Wednesday arrested a father-son duo and recovered 35 lt Desi illicit liquor and approximately 500 lt to 600 lt Lahan from their possession. As per details, Police Station Miran Sahib received information through reliable sources that one Bodh Raj, son of Mumshi Ram, along with his son Arjun Kumar, resident of Phinder, Miran Sahib are indulged in preparing / selling illicit liquor without any legal permission.

Accordingly, a party of Police Station Miran Sahib led by SHO Insp Zaheer Mushtaq assisted by Incharge Border Police Post Kullian ASI Ranjeet Singh under the supervision of SDPO R S Pura Surinder Singh and overall supervision of SP Ramnish Gupta raided the spot and recovered an underground tank where illicit liquor was prepared. The team seized 35 lt Desi illicit liquor and approximately 500 lt to 600 lt Lahan, which was destroyed on the spot. During checking, a Toka was also recovered from the possession of accused persons. FIR 163/2022 under sections 48 (E), 48 (F) of Excise Act, 4/25 of Arms Act was registered against them.



2 narcotic-peddlers booked under PITNDPS - PSA

KATHUA: District Police Kathua under overall supervision of SSP R C Kotwal booked two drug-peddlers. As per details, a police team led by Insp O P Chib SHO Police Station Kathua under supervision of DySP Headquarter Kathua Shammi

Kumar, nabbed a notorious narcotics smuggler Kuldeep Kumar, son of Late Rasal Chand, resident of Chack Drab Khan Tehsil & District Kathua, who was habitual drug peddler and involved in possession and transportation of Narcotic Drugs and psychotropic substances in different NDPS cases and against whom a detention warrant under Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances PITNDPS Act- 1988 was issued by Divisional Commissioner, Jammu. While another team led by Insp Jatinder Singh Incharge SHO Police Station Lakhampur under supervision of DySP DAR Sukhdev Singh, nabbed one Shiv Kumar Anand, son of Ashwani Kumar, resident of Ward- 7 Lakhampur Tehsil & District Kathua, who is also a habitual drug-peddler involved in possession and transportation of Narcotic Drugs and psychotropic substances, against whom a detention warrant under Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances PITNDPS Act- 1988 was issued by Divisional Commissioner, Jammu. In order to prevent illegal activities in drug trafficking in the district, dossiers were prepared against both accused and sent to Divisional Commissioner Jammu for their detention under PITNDPS Act-1988 (PSA). Accordingly Divisional Commissioner, Jammu issued detention warrant against both accused under PITNDPS Act, warrants were executed and lodged in District Jail Kathua to curtail their activities.

Grenade attack outside Sidhra Police Post

JAMMU: High alert was sounded across Jammu & Kashmir after a grenade attack. The attack took place on late Tuesday evening near police post in Sidhra area of Jammu district. Police sources said that explosion took place outside the building. "A lever of the grenade was also recovered from blast site. No casualty occurred because of explosion," sources said. A high alert was sounded across the union territory because a similar grenade was used by terrorists in 2018 in Budgam, sources added.
