of the smart parking initiative using modern solutions to considerably reduce parking on roads and generate revenue for the city.

Terming Community involvement key to revitalize and rejuvenate the cities, the Lt Governor said, with the help of people we can create healthy cities, create incentives for Swachh Abhiyan, protect natural assets and strengthen transportation, water and utility infrastructure.

He said that it is high time for Urban Local Bodies (ULBs) to reinvent their economic base and fully utilize the assets to generate revenues and spur the local economy. Many under-utilised assets can generate employment, business opportunities with engagement of local community, Sinha added.

Sinha further observed that there is a need to focus on the concept of augmented city for the development of urban areas.

We have to add value to the potential of Jammu city, its tradition, heritage, culture, uniqueness and how it can grow economically, he added.

Last year, a record 3506 projects were completed in district capex only in Jammu. This financial year's budget of Jammu district capex has been increased to Rs 1442 crore as compared to Rs 700 crore in the last financial year, it was informed.

The elevation of the main building has been kept depicting "Dogra Heritage and Culture" in blend with the architecture of the surrounding Heritage buildings. 'The facility will provide parking space for nearly 400 vehicles, significantly decongesting traffic in the adjoining area of Jammu city by reducing street parking.

Rajinder Sharma, Mayor, Jammu Municipal Corporation, on the occasion appreciated the completion of Multi Level Parking and observed that the facility shall ease the traffic situation in the area. He further said that JMC is now focussing on solid waste management in addition to sanitation and enforcement activities.

The BJP, which won 99 seats in the 2017 polls, is projected to win in the range of 117-151 seats in a House of 182 and the Congress between 16 and 51 seats. It is also upbeat about the possibility of the AAP eating into Congress votes, which could be additionally beneficial for the saffron party.

The best showing for the BJP in Gujarat came in 2002 when the party had won 127 seats in the 182-member state assembly.

The poll outcome will determine if the Aam Aadmi Party(AAP) gets a chance to establish itself as a pan-national party and a challenger to the BJP at the national level also.

The AAP, which is in power in Delhi and Punjab and had launched an aggressive campaign to make it a three-cornered contest for the first time in Gujarat, was projected to bag anything between 2 and 13 seats. The majority mark is 92.

For the Congress, its role as the main challenger to the BJP is at stake and Thursday's results will show if the party's silent campaign' has cut ice with people. 'Top leaders of the party, which was projected to bag between 16 and 51 seats, were busy with Rahul Gandhi's Bharat Jodo Yatra. The Congress bagged 77 seats in 2017.

Congress holds power only in Rajasthan and Chhattisgarh, both of which will go to polls in 2023, and party insiders say that any hopes for the party's revival has to start from Himachal Pradesh. It is expecting the electorate to go by the nearly four-decade old tradition of voting out the incumbent government in the hill state.

As the BJP battled anti-incumbency sentiments after 27 years of rule in Gujarat, Prime Minister Modi was the party's trump card and the ruling party banked on 'Brand Modi' in a bid to contain the anti-incumbency factor.

Among the key issues in Gujarat campaign were unemployment, price rise, water not reaching certain pockets of the state, land acquisition for big projects and farmers not getting proper compensation for crop damage due to excess rains.

While Modi led the BJP poll campaign holding several rallies and mega road shows in Gujarat, Home Minister Shah was in the state for almost two months, micromanaging the campaign and the election strategy.

Party president J P Nadda, chief ministers of BJP-ruled states including Yogi Adityanath, Shivraj Singh Chouhan, Himanta Biswa Sarma and Pramod Sawant also addressed election rallies in the state. Almost all the Union ministers of the BJP took part in the campaign.

Congress leader Rahul Gandhi took time off his Bharat Jodo Yatra to address two rallies in Gujarat where Rajasthan Chief Minister Ashok Gehlot led the party's campaign. The new party chief Mallikarjun Kharge also addressed poll rallies.

Delhi Chief Minister Arvind Kejriwal steered an aggressive campaign for the AAP, holding several rallies and road shows in the last five months.

In Himachal Pradesh, it could be the Congress' turn to form the next government if one went by the state's 'riwaaj(tradition) and long history of voting out the incumbent government.

But with all but two exit polls predicting an edge for the ruling BJP it remains to be seen which way the voters have decided in the closely fought elections.

The hill state has not returned any incumbent government to power after 1985, a trend the ruling BJP, powered by Prime Minister Modi's personalised campaign, hopes to break.

The BJP slogan this time was "Raj nahin, riwaaj badlega", meaning the convention will change, not the government.

The BJP has bucked the anti-incumbency trend in the last Assembly polls in Uttar Pradesh, Goa, Assam, and Uttarakhand by repeating its state governments there, and is hoping to repeat its government in Himachal Pradesh, which is also the home state of Nadda. It is hoping for an encore on the back of its development agenda.

In the 2017 assembly elections in Himachal Pradesh with a house strength of 68, the BJP had won 44 seats and the Congress 21, with one seat going to the CPI-M, and two to independent candidates.

The Congress has been confident of its victory, saying the voters will decide on the fundamental issues of price rise, joblessness, the old pension scheme, and other challenges of life and livelihood the state residents have been facing.

With a muted campaign by the AAP and its former state in-charge Satyendar Jain lodged in Tihar jail, the Congress is upbeat that its vote share will only improve, while the BJP hopes to gain from a higher women vote percentage than men.

A higher women turnout has of late favoured the BJP, as seen in UP and Uttarakhand, with the party hoping that similar trends will hold in HP.

Both the BJP and Congress camps are learnt to have been in touch with independent candidates who might play a key role in the event of a close contest, predicted in several exit polls, with a slender edge to the BJP.

SC status can't...

discriminates against Scheduled Caste converts to religions other than Hinduism, Sikhism and Buddhism.

The matter came up for hearing on Wednesday before a bench headed by Justice S K Kaul.

The bench was informed by advocate Prashant Bhushan, appearing for petitioner NGO Centre for Public Interest Litigation and others, that the Centre has filed an affidavit saying it wants to appoint another commission to examine the issue.

The Centre recently appointed a commission headed by former Chief Justice of India (CJI) K G Balakrishnan to examine giving SC status to new people who claim to "historically" have belonged to the SCs but have converted to a religion other than those mentioned in the Presidential orders.

Bhushan told the bench, also comprising Justices A S Oka and Vikram Nath, the government has said the new commission will submit its report within two years.

"The first aspect which has to be dealt with is whether this court should stay its hands till report of the commission comes or whether it should proceed on the basis of the material on record," the bench said.

Solicitor General Tushar Metra, appearing for the Centre, said the government has indeed constituted a commission headed by the former CJI which will submit its report in two years.

The bench has posted the batch of pleas on the issue for hearing in January next year.

One of the pleas has sought reservation for converted Dalits on the same footing as is extended to the Scheduled Castes following Hinduism, Buddhism, and Sikhism.

In its reply filed in the apex court in October, the Centre had said the Constitution (Scheduled Caste) Order, 1950 "does not suffer from any unconstitutionality inasmuch as the exclusion of Christianity or Islam was due to the reason that the oppressive system of untouchability which leads to economic and social backwardness of some Hindu castes was not prevalent in Christian or Islamic society."

"There is no authentic data to suggest that the oppressive environment which existed in Hindu Society for hundreds of years qua Scheduled Castes also existed in Christian or Islamic society," it said.

It said the Constitution (Scheduled Caste) Order, 1950 was based on historical data which clearly established that no such backwardness or oppression was ever faced by the members of Christian or Islamic society.

"In fact, one of the reasons for which people from Scheduled Castes have been converting to religions like Islam or Christianity is that they can come out of the oppressive system of untouchability which is not prevalent at all in Christianity or Islam," the government said.

The reply said once they have come out and ameliorated their social status by converting themselves to Christianity or Islam, they cannot claim to be backward since backwardness based on untouchability is only prevalent in Hindu Society or its branches and not in any other religion.

"At the outset, it is submitted that the report of Justice Ranganath Misra Commission is flawed since the report bases its findings without any field studies. The findings of the Commission therefore cannot be corroborated by actual situation on the ground since no field study was done," it said.

"The Commission further has taken a myopic view of the social milieu in India and does not contemplate the impact of inclusions in the SC list on the present castes listed as Scheduled Castes. The findings of the said Commission have been therefore, not accepted by the government," it noted.

The reply said the Centre has examined the matter and noted that certain groups of persons who have historically suffered social inequality, discrimination and the consequent backwardness resulting therefrom, have been declared to be Scheduled Castes by Presidential Orders issued from time to time under Article 341 of the Constitution.

"It is noted that the said issue is a seminal and historically complex sociological and constitutional question, and a definite matter of public importance," the government said, adding, given its importance, sensitivity and potential impact, any change in definition in this regard should be on the basis of a detailed and definitive study and extensive consultation with all stakeholders".

The Centre said the limited question in this case would be whether Scheduled Caste converts to other religions suffer from the same degree of oppressiveness as suffered by Scheduled Castes practicing Hinduism, Sikhism and Buddhism.

"It is submitted that unless the oppressive severity of such backwardness is conclusively established by the petitioners, the present petition deserves to be dismissed," it said.

Police attaches property of man for providing logistic support to terrorists

SRINAGAR: Police attached property of a man falling within ambit of 'proceeds of terrorism' in Awantipora. As per details, on August 19-20, 2021, Police in Awantipora received information through reliable sources regarding presence of a group of terrorists in house of one Gh Ahmad Najar, son of Gh Mohd Najar, resident of Danak Mohala Khrew which are conspiring to carry out terror act in the area.

Accordingly, a joint cordon and search operation was launched along with Army (50RR) and CRPF (185 Bn), during which hiding terrorists fired indiscriminately on the operational party with the intent to kill the Police/Security forces. The fire was effectively retaliated leading to an encounter.

During the gun battle the terrorists by taking advantage of darkness managed to shift into the house of Ghulam Nabi Najar son of Gh Mohd Najar resident of Danak Mohalla Khrew, which is located adjacent to the initial target house. Subsequently the terrorists were zeroed down and again the fire fight erupted between the Police/SFs and hiding terrorists, which led successful elimination of 02 terrorists. From the site of encounter, 02 dead bodies of slain terrorists were recovered, who were later identified as Musaib Mushtaq Bhat son of Mushtaq Ahmad Bhat and Muzamil Ahmad Rather son of Nazir Ahmad Rather resident of Chakoora Pulwama.

Consequent upon this case FIR No. 57/2021 U/S 307-IPC 7/27 A. Act 16,18,20 & 38 UA(P) Act was registered in Police Station Khrew and investigation was taken up.

During the course of investigation, involvement of Nizam-ud-Din Najar son of Gh Ahmad Najar resident of Danik Mohalla Khrew (son of House owner) came to fore for providing of intentional harbouring and logistic support to the neutralized terrorists and was accordingly arrested in the instant case on 21/08/2021, for the commission of offences punishable under sections and 39 UA(P) Act which were invoked in the instant case.

Accordingly process u/s 25 UA(P) Act for attachment of the house used by the involved accused for intentional harbouring of accused was initiated and submitted to Worthy DGP J&K for accord of prior approval and was accorded by the competent authority.

In pursuance to the said order and the powers conferred upon investigating officer u/s 25 UA(P) Act of 1967 property (residential house belonging to Gh Ahmad Najar son of Gh Mohd Najar resident of Danak Mohala Khrew was attached.

The general public is once again requested to not harbour or provide shelter or extend logistics to terrorists/terror associates in their houses, failing which strict legal action will be taken against anyone doing so.

Two theft cases solved, 3 arrested, stolen items recovered

JAMMUU: Police on Wednesday solved to theft cases by arresting three accused persons and recovered stolen items from their possession.

As per the details, a complaint was lodged at Police Station Gandhi Nagar by one



person namely Vaneet Gupta, son of Vijay Gupta, resident of Gandhi Nagar Jammu stating that some unknown persons broke the wall of his mobile phone shop M/s Hotshopee, Gandhi Nagar Jammu and stole mobile phones, tablets and accessories.

In this regard FIR No. 275/2022 under section 457/380/IPC was registered and investigation was started. After this, a team of Police Station Gandhi Nagar under the supervision of SDPO South Sachit Sharma led by SHO Gandhinagar Inspr: Pankaj Sharma did strenuous efforts and with the help of CCTV footages of the area finally rounded up a suspect namely Bablu Mandal, son of Joginder Mandal, resident of Ekchhari Bhagalpur Bihar at present Preet Nagar Digiana Jammu. During sustained questioning, accused confessed his involvement in the above case and on his disclosure information was received regarding the stolen items and a dedicated team of this PS was deputed to Bhagalpur District of Bihar.

The said team raided at several locations there with the help of police of the local areas and recovered 18 mobile phones, and one tablet. The estimated cost of recovered stolen property is around Rs 3 lakh.

Meanwhile, a complaint was lodged at Police Station Miran Sahib by one person namely Tota Ram, son of Milkhi Ram, resident of Bena Garh Miran Sahib stating that theft occurred in his house and some gold and silver ornaments were stolen from the almira. In this regard, FIR No. 164/2022 under section 454/380 IPC registered. On this, a team of Police Station Miran Sahib under the supervision of SDPO RS Pura Surinder Singh led by SHO PS Miran Sahib Inspr: Zaheer Mushtaq did hectic efforts and with the help of CCTV footages of the area along with timely human intervention, finally rounded up two suspects from Taili Basti Bari Brahmna area. The suspects were later identified as Shiv Dayal alias Sunny, son of Rajinder Kumar, resident of Taili Basti and Ayub Ahmed, son of Shamadasen, resident of Taili Basti Samba. During sustained questioning accused confessed his involvement in the above case and on their disclosure stolen gold and silver ornaments i.e 2 gold Bangles; 1 gold ring; 2 silver payals; 1 gold Nath; 2 gold Kanta; 2 Gold Tika; 1 Gold Locket, 1 gold necklace and One gold coated chain, were recovered from them.

Moreover, one motorcycle (JK21H6151) was also recovered from the above mentioned accused. It is pertinent to mention that the accused namely Ayoub Ahmed is a habitual offender and had earlier also involved in numbers of theft cases.
