1. The Candidate must reach the Examination Centre at the time notified in the Admit Card.
2. No Candidate shall be permitted to enter the Examination Centre after the Gate Closing Time. (9:30 AM in case of First Shift and 02:00 PM in case of Second Shift).
3. No Candidate shall be permitted to leave the Examination Room/ Hall before the Completion of the Examination.
4. Upon completion of the examination, please wait for instructions from Invigilator and do not get up from your seat until advised. The Candidates will be permitted to move out, one at a time only.
5. All candidates are required to download the instructions and read them carefully, and strictly adhere to them.
6. The Admit Card consists of two Page 1 Contains the Candidate and Centre Details & Page 2 has "Important instructions for candidates". The Candidate has to download both pages/ THE PRINTED ADMIT CARD IN ORIGINAL SHALL BE BROUGHT ALONG TO THE EXAMINATION CENTRE AND KEPT AVAILABLE. THE SCANNED OR PHOTOCOPIES OF ADMIT CARDS SHALL NOT BE ACCEPTED/ ENTERTAINED.
