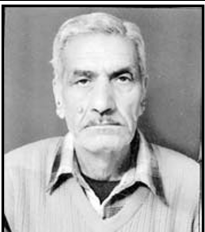

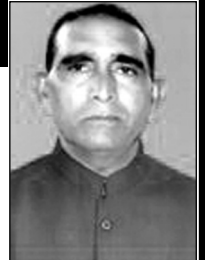

CRIME REPORT

Absconder arrested after 9 years

THANNAMANDI: Police on Thursday arrested an absconder who was evading his arrest since 2013. The accused was identified as Mohd Shrief, son of Abdul Majid, resident of Rajdihani, Thannamandi. He was an accused in FIR 218/2013 under sections 353/147/148/336/427/188 of RPC and 3 of PCA Act at Police Station Thannamandi and a general warrant of arrest under section 512 of CrPC was issued by JMIC Thannamandi. The absconder was apprehended by a team of Police led by Inspector Mohd Shoket Choudhary SHO Police Station Thannamandi under supervision of SDPO Thannamandi Dr Intiaz Ahmed. The accused was later produced before the court of law.

14 bovines rescued, vehicle seized

JAMMU: In a massive drive against bovine smuggling, Jammu Police has rescued 14 bovines during Naka checking at Bravo 3 Naka under jurisdiction of Police Station Bagh-e-Bahu. Police also seized a vehicle (JK03E/3951) which was on its way towards Srinagar. In this regard, FIR 118/22 under sections 188 of IPC 11 of PCA, 50/52/54/56 of transportation of animals of rules 1978 was registered at Police Station Bagh-e-Bahu. The overall recoveries were made by SHO Police Station Bagh-e-Bahu Inspr Sikander Singh under the supervision of SDPO East Syed Zaheer Abbas Jafari. Further investigation is going on.

6 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Police in which teams of Police Station Jhajjar Kotli, Police Posts Chatha, Greater Kailash, Sainik Colony and Chowki Choura acted stringently on specific inputs and raided at a location in their respective areas and seized 6 vehicles involved in illegal mining. The seized vehicles included a Tipper (JK14E-9455) seized by Jhajjar Kotli Police; a dumper (JK08K 9868) seized by Chatha Police; a dumper (JK 21H 5080) seized by Greater Kailash Police; a tractor without registration number seized by Sainik colony Police and two dumpers (JK11B-9352 and JK11E-8573) seized by Chowki Choura. The recoveries were made by SHO Jhajjar Kotli Inspr Samson Bhatti, Incharge Police Posts Chatha PSI Harjinder Paul Singh, Greater Kailash-PSI Harish Chander, Sainik Colony-PSI Bhawani Singh, Chowki Choura-PSI Pankaj Katoh in their respective jurisdiction.

Four drug-peddlers arrested; heroin, two sharp-edged weapons recovered

JAMMU: Continuing drive against drug trafficking and substance abuse, Jammu Police achieved success by arresting four drug-peddlers and recovered 5 gm heroin along with two sharp-edged weapons during Naka checking at Mehmoodpur, Bishmah.

As per details, a team of Police Station Bishnah constituted under the supervision of SDPO R S Pura Surinder Singh and led by SHO Bishmah Inspr Vikram Sharma rounded up four suspects identified as Sunil Sharma, son of Romesh Chander, resident of Bablian; Amajid Khan, son of Alam Din, resident of Sikanderpur; Sumit Verma, son of Rajesh Kumar, resident of Shergarh and Ismail Sandhu, son of Raj Kumar, resident of Dhinday Khurd. During search, 5 gm Heroin was recovered from them. FIR No. 211/2022 under sections 8/21/22 of NDPS Act read with 4/25 of Arms Act was registered at Police Station Bishnah and accused were arrested.

Rusted shell found in Mendhar

POONCH: Police on Thursday found an old rusted shell in Mendhar sector of Jammu division.

As per details, a rusted fired shell was found by children while playing near Gholad School. People later informed security forces about the shell, which might have fallen in this side of border during ceasefire violations.

Drug-peddler arrested, contraband recovered

BANDIPORA: Continuing its efforts to eradicate the menace of drugs from the society, police have arrested a drug peddler in Bandipora and recovered contraband substances recovered from his possession.

As per the details, acting on a specific information regarding movement of drug peddlers near Bagh Bandipora, a Police party led by SHO Police Station Bandipora under the supervision of DySP Hqrs Bandipora Shafat Mohammad intercepted two suspects. The duo on seeing Police party tried to escape but was chased by police party and nabbed an accused however the woman drug peddler managed to flee and left her bag on road. During search, 450 gm Charas powder was recovered from bag while 500 gm Charas powder along with cash amount of Rs 1400 was recovered from arrested accused, later identified as Mohd Shafi Sheikh, son of Mohd Shahbaz Sheikh, resident of Sheikh Mohalla, Bandipora. He was shifted to police station where he remained in custody. All efforts are on to nab escapes woman drug-peddler. FIR No.183/2022 under relevant sections of law was registered in Police Station Bandipora and further investigation started.

7 vehicles seized for illegal mining in Doda

DODA: Acting tough against Illegal mining in Sub-Division Thatthri, a joint team of local administration and Geology and Mining Department seized six vehicles involved in illegal mining.

The team comprising Tehsildar, Sahil Randhawa, District Mining Officer, Sunil Manhas and SHO Amrit Katoch seized vehicles during raids at different locations. The vehicles seized were booked under the Mining Act, sending clear message of strict action to perpetrators of illegal mining.
