The CJI said if the contention of the petitioners on the interpretation of Article 370 regarding the dissolution of the Constituent Assembly was accepted, then Article 370(3) would become redundant and would lose its temporary character.

Article 370(3) of the Constitution says notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify: Provided that the recommendation of the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a notification.

"It can be garnered from the historical context for the inclusion of Article 370 and the placement of Article 370 in Part XXI of the Constitution that it is a temporary provision," the apex court concluded

In his separate verdict, Justice Sanjay Kishan Kaul said the purpose of Article B70 was to slowly bring J&K on par with other states.

Justice Sanjiv Khanna, in his separate verdict, concurred with the CJI and Justice Kaul and gave his own reasons for the conclusion.

The petitions challenging the abrogation of the provisions of Article 370 and the validity of the Jammu and Kashmir Reorganisation Act, 2019 that divided the erstwhile state into the Union territories of Jammu and Kashmir and Ladakh were

Supreme Court's verdict has proved that the decision to abrogate Article 370 was completely constitutional.'

"It is once again the Jammu, Kashmir, and Ladakh that always belonged to our nation and will continue to be so," the minister said.

Shah said under the leadership of Prime Minister Modi, the NDA government is committed to establishing lasting peace in Jammu, Kashmir and Ladakh and the

all-around development of the region. "Whether it is boosting the local economy with new incentives, building state-ofthe-art educational infrastructure, or empowering the poor with welfare benefits, we

vill continue to exert all our might for the region," the home minister said. Reacting to the SC verdict, Defence Minister Rajnath Singh said, the court upheld Prime Minister Modi's decision to scrap Article 370 and 35A of the Constitution and

Union Information and Broadcasting Minister Anurag Thakur said the top court's verdict is yet another victory and a moment of celebration for all the "nationalist people" of the country who dreamt of "complete integration of Jammu and Kashmir with Bharat" and for which they fought political and legal battles, and even sacri-

The Modi government withdrew the special status of Jammu and Kashmir on August 5, 2019, to undo one of the many "historic blunders" committed by the Congress during the Nehruvian era, Thakur said on X.

Several BJP leaders also hailed the SC verdict as "historic", and said that with the scraping of the special status given to J&K, Prime Minister Modi has written a new chapter and given new strength to the unity and integrity of India.

In its reaction to the court order, the Congress demanded immediate restoration of statehood to Jammu and Kashmir and said assembly elections should be held there immediately to enable people to elect a government of their choice.

Congress leaders P Chidambaram and Abhishek Singhvi said the judgement of the Supreme Court in cases concerning the abrogation of Article 370 has decided many

The Judgement needs a careful study, Chidambaram said, noting "Prima facie we respectfully disagree with judgment on the manner in which Art 370 was abrogat-

He said the Congress has always demanded the restoration of full statehood of J&K and "we welcome the SC verdict in this regard".

"The verdict has sent a wave of despair among the people in J-K, and Ladakh. The verdict is very disturbing because....guaranteed by the Constitution," Tarigami said in a video statement.

Writing the judgment for himself and Justices B R Gavai and Surya Kant, Chief Justice of India (CJI) D Y Chandrachud said Article 370 was a temporary provision in the Constitution and the president had the power to revoke it.

Speaking in Rajya Sabha, he also hailed the Supreme Court's Monday verdict upholding the abrogation of Article 370 as historic and said there will now be only "one Constitution, one national flag and one prime minister".

He attacked the opposition saying it is unable to see the change on the ground in Jammu and Kashmir after the scrapping of Article 370 and said the entire country has understood that it was first Prime Minister Jawaharlal Nehru's mistake in han dling the Kashmir issue.

"I want to assure the people of the country, as Prime Minister Narendra Modi has promised from the ramparts of the Red Fort, that the youth of Kashmir will no longer carry guns or stones and will instead carry laptops

"The beginning of building a 'New Kashmir' has been made which will be free from terrorism. The foundation of a 'new and developed' Kashmir has been laid and when India becomes developed, Kashmir will stand equally among the other states, where tourists from across the world would come," he said in the Rajya Sabha.

"We are committed to providing justice to the people of Kashmir, its youth and chil dren. We are sensitive towards them and not towards terrorists," he also said while attacking the Congress.

In an apparent reference to the Nehru, Abdullah and Mufti families, Shah alleged that three families deprived the ST and poor people of Kashmir of their rights, as several laws were not implemented in Jammu and Kashmir earlier.

"They (Opposition) will not be able to see the change, there is a problem with their glasses. They are not ready to rectify their mistake.... But people do not care any more about them. The entire country has understood that it was Nehru's mistake,

He also attacked the Congress for being against the other backward classes, alleg ing that it was because of them that the OBCs did not get reservation under vari ous schemes in Jammu and Kashmir, which the new bills have now ensured.

He also alleged that the Congress has always been opposed to OBCs and their rights as they opposed the Mandal Commission too.

"The Congress party has always opposed the other backward classes and their rights," he said.

Shah also targeted the Congress and INDIA bloc over the huge recovery of cash during income tax raids on a company linked to a Congress MP from Jharkhand

Kashmir politicians allege house arrest, LG says claim baseless

The Jammu and Kashmir Police issued a cautiously worded statement, clarifying that no arrest orders had been issued in relation to the Supreme Court proceedings concerning Article 370, and that there were no restrictions on movement.

"The police have not

received any orders to effect any arrests, particularly those related to court proceedings on Article 370 by

the apex court," it said.

"There are no restrictions on movement. Examinations scheduled by different public bodies are proceeding as planned, businesses are open and transportation is operating," the statement said. Police emphasised that the normal life of the common people continued at its usual pace. "While the police remain vigilant against disruptive elements, they have no intention or instructions to curtail freedom of movement and activities," the Jammu and Kashmir Police asserted in the statement.

The police urged people to carry on with their daily lives and not be influenced or intimidated by social media posts contradicting this information.

JAMMU: Jammu and Kashmir BJP president Ravinder Raina on Monday hailed the Supreme Court's verdict upholding the abrogation of Article 370, saying "we honour and respect the judgement in letter and spir-
