**Swift Action by CISF personnel prevented suicide at Shadipur Metro Station**

NEW DELHI: Central Industrial Security Force (CISF) personnel on Tuesday saved the life of a young woman while she was attempting suicide by jumping off the elevated metro track at Delhi's Shadipur metro station.  
The video of the incident was posted on the official 'X' handle of the CISF.  
"Prompt response by CISF personnel saved the life of a lady pax who was trying to commit suicide by jumping off the elevated metro track @ Shadipur metro station," CISF said in a post on 'X'.  
"On December 11, 2023 at about 1725 hrs, the CISF personnel at Shadipur Metro Station successfully averted a potential tragedy involving a young female passenger," CISF official said.  
Official informed that a 20 years old lady passenger resident of Shadipur, New Delhi, arrived at platform no. 02 accompanied by her mother. Suddenly, the lady passenger ventured onto the metro track from plat-

form no. 02 and began walking towards Kirti Nagar metro station, official said.  
Responding swiftly to the urgency of the situation, the CISF Quick Reaction Team (QRT) and Bomb Detection Squad (BDS) personnel, along with a female personnel and the station controller, immediately rushed towards the passenger, official said adding that the passenger was perilously close to attempting suicide by jumping over the railings of the elevated metro track.  
CISF team managed to successfully apprehend her just as she was about to leap from the track towards the road.  
The coordinated efforts of the CISF personnel ensured the safety of the distressed passenger and brought her back to Shadipur Metro Station. Subsequently, the matter was informed to Delhi Metro Rail Police (DMRP) who arrived at the station and escorted her to the police station for further necessary action.


Rising Under 16 managed to score only 139 runs and lost the match by 30 runs. Mannohan Raina was awarded as the Man of the Match.
