## LLSI hails CJJ Dy Chandrachud for fairest judgment in a case of international importance

JAMMU: Live and Let Live Society of India (LLSI) in a meeting held under the Chairmanship of S. S Komal has hailed the Chief Justice of India, D Y Chandrachud for giving the fairest, unbiased and unquestionable judgment in response to 23 petitions from different individuals including politicians, against the abrogation of Art 370. The Constitution bench of five judges held a day-to-day hearing which commenced on 2nd August 2023 and continued for a month when he reserved the decision on September 5, 2023. After threadbare consideration of

the arguments put forth by the counsels of 23 petitioners, including those of the highest repute, besides the Solicitor General and team of counsels from Government side and thereupon the day to day findings, the judgment was pronounced on 11th December, 2023 by a bench comprised of 5 judges.

dom, dedication and hard work of CJJ Chandrachud, whose judgment has silenced the whole world over the case of international importance and brought smile on the faces of 140 crore people of the country.
