### **Charming Chinar-The** beauty of the Valley

hinar is virtually a person derivation meaning thereby 'chi' 'naar' haying affiliation to what is so called 'fire' or owing due to 'fiery colour of leaves when leaves fall in autumn and in their turning out as golden yellow manifesting flaming red 'leaves. Basically, this beautiful, giant and majestic tree is not only indigenious but exotic one. The mention of chinar as boin'is found in the folk lore of Kashmir.

The Chinar tree is the real beauty of the Kashmir vallev where many films have over the years bear affiliations to this majestic trees as for example the most prominent films like 'Azroo' and 'JabJab Phool Khiley have beenshot in and around Dal lake and the mostmagnificent 'Parks' and Gardens of Kahmir. The picturesqueand kaleidoscopic beauty of the Kashmir valley over the years have attracted and haunted the foreigners from China and western countries and they have described it as the 'Paradise on earth. The environment that surrounds the valley is unambiguously enchanting and enthralling more and more so due to these largely spreaded over 'Chinars' amongst other enchanting greenery of the flora and salubrious and lush green deodars, kails, oaks, spruce and fir with altitudinal variations apart from Pinus gerendana (chilgoza) which is richly found next to Paddar in Jammu region. But the majestic Chinar finds its rich and unique placement in Kashmir Valley. The 'Charchinari' admist 'Dal lake' can most conveniently be attributed as a 'heritage' of velvet Kashmir valley and the more you praise, the less it is and this valley is in no way less than Switzerland of Europe over the mother earth which having other enchanting and bewildering spots on the other parts of globe, yet the enchanting beauty of the velvet valley has got its own significance of rarety of beauty.

The magnificent and majestic 'Chinar' tree attains a gigantic height more than a 100 hundred feet with 40-50 feet girth and with a round spreading crown, leaves are mostly heart shaped 10 to 25 cms and 12 to 30 cms in length and breadth deeply cut in triangular toothed lobes which give an appealing grace from long distance and provide abundant shade to the tourists and visitors alike. The bark of the tree is with silvery flakes.

The tree is propagated less by seed sowing, but it is preferential if it is propagated through cutting which yield success-oriented results and as the locals go in far propagation through cuttings. At times, it is reported that there were as many as 70 garden in the velvet valley of paradise' which have now reduced to few and all those gardens were well flourished with majestic chinar with kaleidoscopic variety of flowers of multihued nature but ironically now only few survive in their resplendence. The attention of the Govt. is invited to bring it to the pristine grandeur and glory to ensure and further invigorate more and more influx of tourists, pilgrims and cine-stars. These will in unison boost tourism which is the dire demand of the day and we can yield hefty dividends apart from providing job to the local populace and improve their socio-economic

Shah Jahan amongst the mughals was over-enthusisuch he introduced the magnificent and majestic tree in the velvet valley of Kashmir in various parts and gardens extensively in Nishat Bagh, Shalimar, Harwan, Verinag, Hazrat Bal, Char Chinar, and on other prominent locations such as Tulmula, Avantipura, Mansabal Sopore, Bara-mula, Anantnag so on and so forth.

It is added over here that this majestic tree occupies its prominence in almost every corner of the beauteous valley of Kashmir also nomenclaturised as the "Paradise on earth". The majestic and magnificient treegains an attitudinal height upto 2600mtsbut however in the lower belts of altitudethis tree is cultivable and now in Jammuand its vicinity it is successfully flourishing to the exremes of Kud, Batote, Katra, Reasi so on and so forth. The wood is as good as anything likemanufacturing of plywood, apart from itsmultihued usages for the manufacture of furniture and its ilk. The tree as well find its usefulnesses in the firewood which mitigate problems of local populace of firewood in multitudinal ways. The timber is as well used for building construction and also used for the manufacture of furniture. It is, therefore, urged upon the Govt. to invigorate and boost 'chinar plantation extensively and intensively not confined to the Kashmir valley but elsewhere too where it is well suited to site so as to enhance the beauty of the state and haunt more and more tourists apart from improvising the environment of the State. In other words, this will yield and boost the socio-economic status of the local populace and help in mitigating the firewood, timber and other related problems of the locals.

Since the vale of Kashmir'falls under temperate zone soextensive efforts should be accelerated to enhance maximum plantation on the occasion of 'Arbor's' day as is beingdone in the sub-tropical region of Jammu on Vanamahotsava.Tree culture had been a ritual inour old scriptures if we unfold the pious pages of Vanupurana, Ramayana, Mahabbarta, these echoe that each part of the tree has most reverentially been prayed. # Validation of abrogation of Article 370 by Supreme Court -Sine-Qua-non for development of J&K

he Supreme Court has validated the decision of the centre government of L abrogating the useless, futile and discriminatory Article 370 which has placed the erstwhile state of Jammu and Kashmir at a distinctive pedestal and it harmed the national interest and also dealt a blow to the unitary spirit of the constitution. The supreme Court decision of December 11,2023 has ended all uncertainty and suspicion about the continuance or otherwise of the Article 370. .Modi dismantled the discriminatory as well as most controversial Article 370 of the constitution and now the supreme court has affixed its seal of approval on the centers decision of august 5,2019 and the top court said that the procedure adopted to scrap the Article 370 as well as its abrogation are lawful .legal and constitutional. .So all uncertainty and suspicion about the continuance of the Article 370 came to an end when the top court gave its historic judgment in favor of the centers decision of abrogation and thus the path has become clear for the investment and development of the economy which had come to standstill during the three decades of militancy but now the economy including tourist economy runs fast on the track of development. In effect it means that the separate constitution of Jammu and Kashmir stood abrogated and a single constitution now applies to all the Indian states including Jammu and Kashmir. ## Hibernation a winter sleep?

any a times we come across with animals that keep on **↓V** wandering around us throughout the year but hardly observe during winters. So where these animals hide during such dip temperature conditions? And why?

Well! Some few animals such as non-chordates (e.g. Insects, Molluscs etc.) are unable to maintain their body temperature as per environmental conditions while other like bear Hedgehogs, Ground squirrel etc.finding enough food in winter can be difficult, because their main source of food such as insects or green plants is in short supply. In

either of cases these animals solve this problem by hibernating.

Some of people have belief that these animals undergo winter sleep. Despite what they may have heard, species that hibernate don't "sleep" during the winter. Sleep is a gentle resting state where unconscious functions are still performed. While hibernation on other hand is an extended form of torpor, a state where metabolism is depressed to less than five percent of normal. So the fact is their most of the physiological functions are extremely slowed down or completely halted.

So what happens during hibernation? During hibernation the ani-

mal's body reduced metabolic activity and thereby temperature drops, and seemingly its heartbeat and its breathing slow down so that it does not use much energy. Some hibernators go into such a deep sleep that it is almost impossible to wake them, and they appear to be dead!Let's understand with example, when dwarf Lemurs hibernate, they reduce their heart rates from over 300 beats per minute to fewer than six. Instead of breathing about every second, they can go up to 10 minutes without taking a breath and their brain activity "becomes unde-

How the animals get energy dur-

Basically before undergoing hibernation these animals get ready for their winter sleep by eating extra which they then use as energy while sleeping. In animals there are two types of fat - regular white fat and brown fat. It is the brown fat that forms patches near the animal's brain, heart and lungs sends a quick burst of energy to warm these organs and perform basic metabolic functions and also help them when it is time to wake up. Do birds also hibernate? During

cold or wet weather, there is always dearth of insects so the parent

> However one bird is known to be a true hibernator i.e. North America's common poorwill that often hibernates among rocks during winters.It can slash its oxygen intake by 90 per cent, while its body temperature plummets to 5°C, barely registering signs of life.

Back in late 2022, few were surprised to learn that someone in Silicon Valley had finally managed to build a better chatbot. A chatbot that could actually raise the bar in terms of what consumers should expect? Many agreed that it was about time.

ChatGPT, it soon became clear, as hundreds of thousands of people gave the tool a try, was more than just the latest iteration of artificial intelligence (AI) -powered customer-assistance software. Many used the word "revolutionary" to describe what the system was capable of doing. Others said the technology seemed sentient like they were interacting with another human and not a machine.

And now, attention is turning to the technology's next phase: the one where businesses put it to work. Across industries and at companies of all types and sizes, there are

ChatGPT deployments in actions In nearly every case, business leaders acknowledge that it's still early days for ChatGPT. They're trailing the technology, "playing with the tool," getting a feel for what it can and cannot do. According to the Dell Technologies 2023 Innovation Index report, 59% of Indian businesses are currently investing or exploring the feasibility of investing in AI to advance inno-

## YOUR COLUMN **Suspension of** Kunwar Danish Ali

Kunwar Danish Ali has been suspended by the BSP for his anti-party activities. No one is expected to go against the policies and programmes of the parties. Any one going against the policies and programmes must invariably be subjected to disciplinary action. Accordingly, BSP suspended Danish Ali for accompanying other opposition parties while staging a walk-out in protest against expulsion of Mahua Moitra from Parliament House while all other members of the party were seated. Danish Ali's party loyalty is not above suspicion. His suspension neither conveys the message that BSP is in favour of Mahua Moitra's expulsion nor opposed to it. What has angered the party is his

reluctance to toe the party line. According to BSP General Secretary Chandra Misra, Danish Ali has allegedly ignored the warnings on multiple occasions. After changing his loyalty from JDS to BSP, he seems to be on his way to Congress party. Defectors do not have ideological interest. They have only their political and personal interest. There is no guarantee that Danish Ali would remain in Congress also unless he is "treated properly" in the party. Former Chief Minister Jagadish Shettar and former Deputy Chief Minister Lakshman Saudi defected from BJP to Congress in Karnataka. Now they have been cornered. They deserve it.

If Danish Ali crosses over to Congress, he is no more charismatic person than Jagadish Shettar and Lakshman Saudi to treat him more fairly than them. Undoubtedly, he will also get raw deal in Congress even if he wins the Lok Sabha election. If he loses, he will be ditched to such an extent that people forget that he was an MP earlier. Despite warnings if he continued to be indulging in anti-party activities, it means that he is not comfortable with BSP also. If he had quit BSP, he would have attracted the provisions of the Anti-defection law. Since he has no love lost with BSP, in order to avoid the provisions of the Anti-defection law, he has continued to cross the party line to prompt the party to ease him out. Indulging in anti-party activities by some Members of the Assembly or Lok Sabha is a clever ploy to hobnob with other political parties without endangering their membership. There is speculation that Danish Ali would contest the 2024 Lok Sabha election from the Congress ticket Defectors should be junked by the voters. BSP chief Mayawati has passed on the baton of leadership to her nephew Akash Anand. For quite sometime the party has been maintaining low profile. How far Mayawati's nephew keeps the party alive or can take forward the ideologies of the party remains to be seen. Danish Ali seems to be having last laugh for his suspension since BSP has been losing ground in its own birth place Uttar Pradesh.
