DUE TO POOR RESPONSE AND INADEQUATE APPLICATIONS RECEIVED FROM ELIGIBLE CANDIDATES, FRESH NOTICE INVITING APPLICATIONS FOR THE ENGAGEMENT AS FULL TIME DEPUTY LEGAL AID DEFENSE COUNSEL IN DISTRICT JAMMU AND GANDERBAL OF UT OF J&K UNDER J&K LEGAL SERVICES AUTHORITY IS ISSUED WITH MODIFIED QUALIFICATION CRITERIA.

The Legal Aid Defense Counsel System (LADCS) has been implemented in all the 20 districts of UT of J&K however in District Jammu and Ganderbal the post of Deputy Legal Aid Defense Counsels (LADCs) remained vacant either due to non-availability of suitable candidates or for want of candidates fulfilling the eligibility criteria. However, absence of Legal Aid Defence counsels in the LADCs office results in undue hardship to the people in need of legal assistance in Criminal matters

J&K Legal Services Authority after due consideration has modified the current eligibility criteria for the engagement as Deputy Legal Aid Defense Counsels in District Jammu and Ganderbal to encourage more lawyers to apply and actively participate in implementing LADCS Modified Scheme.

Accordingly, applications are invited from eligible lawyers of District Jammu and Ganderbal having at least seven years of practice in Criminal law at Sessions Court (The experience certificate to be issued by a District & Sessions Judge) for full time contractual engagement for the below mentioned posts shown below against their respective districts;
