SC to deliver verdict on Dec 11 on pleas challenging abrogation of Article 370

NEW DELHI: The Supreme Court is scheduled to pronounce its verdict on December 11 on a batch of petitions challenging the abrogation of Article 370 of the Constitution which bestowed special status on the erstwhile state of Jammu and

According to the cause list of December 11, Monday, uploaded on the apex court website, a five-judge constitution bench headed by Chief

Justice D Y Chandrachud would deliver the verdict.

The other members of the bench are Justices Sanjay Kishan Kaul, Sanjiv Khanna, B R Gavai and Surya Kant.

The apex court had on September 5 reserved its verdict in the matter after a marathon 16-day hearing.

During the course of the hearing, the top court had heard Attornev General R Venkataramani, Solicitor

General Tushar Mehta, senior advo-

cates Harish Salve, Rakesh Dwivedi, V Giri and others on behalf of the Centre and the intervenors defending the abrogation of Article 370.

Senior advocates including Kapil Sibal, Gopal Subramanium, Rajeev Dhavan, Zaffar Shah, Dushyant Dave and others had argued on behalf of the petitioners.

The lawyers had dwelt on various issues including the constitutional validity of the Centre's August 5, 2019 decision to abrogate the provision, the validity of Jammu and Kashmir Reorganisation Act, which split the erstwhile state into two Union Territories, challenges to imposition of Governor's rule in Jammu and Kashmir on June 20, 2018 and imposition of President's rule in the erstwhile state on December 19, 2018 and its extension on July 3, 2019.

Several petitions challenging the abrogation of Article 370 and the Jammuand Kashmir Reorganisation Act, 2019 that divided the erstwhile state into two union territories - Jammu and Kashmir. and Ladakh - were referred to a

SRINAGAR: A cab taking a group of persons from Srinagar to Kargil fell from a mountain highway in the Ganderbal district on Thursday, killing five persons, officials said.

The accident took place in the Sonamarg area where the passenger cab skidded off the mountainous Zojila Pass road on the Srinagar-Leh highway due to slippery road conditions caused by recent snowfall, the officials

They said five persons on board the vehicle died in the accident.

All the victims hailed from Kargil and were identified as Mohammad Hussain, Shabir Hussain, Mohammad Akbar, Mohammad Amin and Abdul Hadi, they added.

This is the second major accident along the Zojila Pass on the Srinagar-Leh highway in three days.



SRINAGAR: The National Investigation Agency on Thursday attached the properties of two key Lashkar-e-Taiba (LeT) operatives for their involvement in the 2015 terror attack on a BSF convoy in Udhampur district.

Two BSF personnel were killed and 13 others injured in the attack, which took place on August 5, 2015 on the Srinagar-Jammu national highway in Narsoo village of Udhampur district. One terrorist was killed and another, identified Naveed, was arrested in the retaliatory action by the security forces.

"The two accused whose properties have been attached today were also subsequently arrested and are currently undergoing trial in the NIA special court, Jammu," the anti-terror probe agency said.

As per the NIA investigations, the duo -- identified as



Fayaz Ahmed Itoo alias Fayaz Khar and Khursheed Ahmed Bhat alias Surya -are members of the banned Pakistan-backed organisation LeT, the agency

Inspector Masroor Ahmad Wani, who was critically injured when he was shot at by a Lashkar-e-Taiba terrorist while playing cricket in Srinagar in October, died at AIIMS here Thursday leaving behind his wife who is expecting her first child.

Officials said despite best efforts of the medical team, Wani succumbed to injuries this afternoon.

Son of a retired Police Sub-Inspector, 35-year-old Wani was playing cricket at the Eidgah ground when the lone terrorist fired three shots in


