### 3 narco-smugglers nabbed with 400 gm heroin

**STATE TIMES NEWS**  
**AKHNOOR:** Police on Friday nabbed three narco smuggler and recovered 400 grams of heroin from their possession.

As per details, a party of Police Station Akhnoor established a special Naka at Sohral road for checking of vehicles. During checking one Motorecycle bearing registration No. JK11G-7043 on which rider alongwith 02 pillion riders was coming from Akhnoor towards Sohral, when they saw Naka party, immediately diverted their direction and accelerated their bike, tried to escape but Police Party apprehended them on spot.

During questioning they disclosed their names as Vishal Gangyal, son of Rajiv Gangyal, resident of Makdi Nowshera District Rajouri; Jugal Kishore, son of Vipam Kumar, resident of Lam Ladoke Nowshera Rajouri and Gulshan Kumar, son of Tara Chand, resident of Matoo Tehsil Khour District Jammu. On their suspicious activities their personal search was conducted. During search 250 Grams of heroin like substance was recovered from Vishal Gangyal, 100 Grams from Jugal Kishore and 50 Grams from Gulshan Kumar. Trio was arrested and FIR No. 330/2023 under sections 8/21/22/29/60 NDPS Act was registered against them at Police Station Akhnoor.



### 4 overloaded passenger vehicles seized, drivers arrested

**RAMBAN:** Continuing drive against Motor Vehicle Act violations Traffic Police National Highway under the supervision of SSP NHW Rohit Baskotra registered 5 case FIR's for overloading and endangering human lives, 4 drivers arrested, 78 Vehicles Seized and 2032 vehicles challaned for different Motor Vehicles Act Violations.

As per details, 2023 Traffic Police team led by Inspector Novneet Verma DTI Ramban and DySP Traffic Ramban Ifkhar Ahmed intercepted one Bus (JK02AW 3015) on Ramban Gool Road. On checking vehicle found overloaded with 25 passengers in excess to its seating capacity. On this Vehicle Seized and case FIR no 342/2023 US 336 IPC 39/192 MV Act stands Registered at Police Station Ramban and driver of the vehicle namely Surjit Singh, son of Thakur Dass arrested in case FIR.

In another incident traffic Police Ramban while checking at Seri intercepted on Bus (JK02BB 2527) while on way from Banihal to Jammu and found bus overloaded with 18 passengers more than its seating capacity. On this case FIR 343/2023 US 336 IPC 39/192 MV Act stands registered at Police Station Ramban, and vehicle seized on the spot, whereas driver of the vehicle namely Tanveer Ahmed, son of Mohd Shafi, resident of Ramssoo arrested in case FIR.

Traffic Police team Udhampur led by DySP Traffic Arun Janwal seized one matador (JK14g 2947) from Dhar Road with 34 passengers more than its seating capacity. On this case FIR 625/2023 US 279/336 IPC stands registered at Police station Udhampur and driver of the vehicle arrested in case FIR.

Traffic Police team Udhampur led by SO Traffic Manwal ASI Tara Chand seized an overloaded (JK 14 7619) while on way from manwal to Udhampur. On this case FIR 622/2023 US 279/336 IPC stands registered at Police Post Round Domain.






