Chugh reiterated that it has now exposed clearly that the Congress has been following the agenda of foreign forces, including the Pakistan ISI, to create trouble in J&K.

The BJP, he said, would expose anti-national credentials of the Gandhi familv for the nation to understand the Congress agenda of subverting the mission Prime Minister Narendra Modi to make India a leading nation in

Rohingya settled in Jammu cannot be allowed to die of starvation, cold: Omar

JAMMU: Chief Minister Omar Abdullah on Monday said the Centre should decide the fate of the Rohingva population settled in Jammu, asserting that they could not be allowed to die of starvation or cold.

He also expressed concern over the "tense" relationship between Bangladesh and India. saving the foreign secretary was holding meetings with his counterparts in the neighbouring country and efforts were being made to improve the situ-

"It is a humanitarian issue. The central government should decide about them (Rohingya). If they are to be sent back, do that. If you can, send them back. If you cannot send them back, we cannot starve them to death. They cannot be allowed to die of cold," Abdullah told

"The government of India should tell us what we have to do with them. As long as they are here, we need to take care of them," the chief minister

Abdullah, the National Conference vice-president, also asserted that they did not bring the Rohingya to Jammu or set-

"They have been brought and settled here. If there is a change of policy at the Centre, take them back. As long as they are here, we cannot treat them like animals. They are



humans and they should be treated as such," he said. The BJP on Monday called

Hitting out at the National Conference government over granting water and power connections to the settlers, the BJP alleged it was being done to protect them as they belonged to a particular com-

Replying to a question about attacks on the minority Hindu community in Bangladesh. Abdullah said there was tension in the relationship between India and its neighbouring country.

"Now, the foreign secretary is holding meetings with them and efforts are being made to improve the situation. Atal Bihari Vajpayee sahib had said

that we could change a friend, not a neighbour. It is our compulsion to ensure good relations with our neighbours," he

Abdullah was also asked about West Bengal Chief Minister Mamata Banerjee expressing dissatisfaction with the functioning of the INDIA bloc, signalling her intent to take charge of the alliance.

"There has been no meeting of the INDIA bloc after the general elections. So where is the question of a change in leadership? Let the meeting take place. If Mamata Baneriee wants to take over the leadership, let her stake a claim in the meeting," the Jammu and Kashmir chief minister said.

In an interview with a Bengali news channel on December 7, Banerjee said, "I had formed the INDIA bloc, now it is up to those leading the front to manage it. If they can't run the show, what can I do? I would just say that everyone needs to be taken along.

JAMMU: The BJP Monday termed the settlement Rohingyas Bangladeshis in the Jammu city a major "political conspiracy" and demanded a CBI probe to identify those involved in facilitating it.

Hitting out at the National Conference (NC) government over remarks on granting water and power connections to them in Jammu, the BJP alleged it was done to protect them as they belong to a particular community

"The BJP will urge the lieutenant governor to initiate a CBI probe and lodge an FIR to comprehensively investigate this conspiracy. It must be determined who brought and settled the Rohingvas and Bangladeshis in Jammu, and stringent action, including prosecution and imprisonment, should be taken against them," Jammu and Kashmir BJP chief spokesperson advocate Sunil Sethi told reporters here.

Sethi claimed the settlement Rohingyas Bangladeshis in Jammu and Kashmir began around the same time militancy started in the region in the 1990s. "This is a major conspiracy that warrants a CBI probe. All forces behind this should be exposed and punished. The BJP condemns those who support these individuals on grounds," he said.

He said that NGOs played a significant role in resettling

Rohingyas and questioned the sources of funding for these organisations. "Was the funding sourced domestically or from abroad? The BJP believes the settlement of Rohingyas and Bangladeshis in Jammu, an area close to the international border, was done under a conspiracy," Sethi said.

He called for a detailed investigation to identify those who facilitated the settlement of these individuals on government lands, provided them with water and electricity connections, and helped them obtain Aadhaar cards. "These people have even cast votes in local elections. These facts have now come to light," he added.

Hitting out at political parties supporting them, Sethi said, "Ironically, these are the same individuals who opposed the abrogation of Article 370 and claimed that no Indian could settle in Jammu and Kashmir. Yet, they facilitated the settlement of Rohingyas and Bangladeshis in Jammu. Indians residing in other parts of India cannot settle in

Jammu and Kashmir, but these illegal immigrants were allowed to settle here based solely on religion.

Sethi alleged that these individuals pose a threat to national security as they have settled in areas close to the international border. "They were settled as part of a political conspiracy to create a vote bank," he claimed.

The BJP leader said the nation should know which forces are working against its interests and prioritising political gains over national welfare. "The BJP demands the eviction and deportation of Rohingyas residing in Jammu, who have formed large settlements in the city. Illegally settling on the land of Jammu and Kashmir is a crime," he added.

Sethi further said that evidence suggests Rohingyas and Bangladeshis are allegedly involved in local crimes, drug trafficking, and even cross-bor-

Replying to a question about NC minister Javaid Rana's

ply to Rohingya settlements, Sethi said. "I want to ask the NC government and its minister Javaid Rana whether they will follow the law or if the law does not matter to them. As per the rules in Jammu and Kashmir, obtaining water or electricity connections requires a domicile certificate and legal possession of land. Are they

Criticising Rana, Sethi said, "Under the UN charter, decisions are made about who qualifies as a legal immigrant, but these individuals are illegal. There is no justification for providing them with water and electricity. Removing them from Jammu is essential for national security and efficient governance.

unaware of this?'

Sethi said that Rana supports these individuals based on their religion. "If they belonged to another religion, would his stance remain the same? This protection based on religion is part of a political conspiracy," he said.

He reffered to Pakistani

Gorkhas, who were denied citizenship for 70 years by Kashmir-centric rulers.

The BJP leader said the Rohingyas should have been restricted to areas near the Assam or Myanmar borders. "What justification is there for them to travel thousands of kilometres to settle in Jammu and Kashmir? This appears to be a well-orchestrated conspiracy to settle them close to the international border in Jammu," he said, adding that this conspiracy must be exposed, and those involved punished.

According to government data, more than 13,700 foreigners, most of them Rohingyas (illegal immigrants Myanmar) fromBangladeshi nationals, are settled in Jammu and other districts of Jammu and Kashmir. Their population increased by over 6,000 between 2008 and

In March 2021, police found over 270 Rohingyas, including women and children, living illegally in the Jammu city during a verification drive and lodged them at a holding centre inside the Kathua sub-jail.

On November 25, SSP South Jammu Ajay Sharma said 18 FIRs were registered during a drive against landlords renting out properties to Rohingyas and other illegal immigrants without informing police as mandated by the district magistrate's orders

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court, comprising Justice Sanjeev Kumar and Justice Puneet Gupta, directed Union of India (UoI) to file an affidavit on behalf of the Ministry of Personnel, Public Grievances & Pensions to indicate as to how they have complied with the judgment of the Tribunal dated September 13, 2007, impugned in this petition and shall also explain as to how the Senior IAS Dheeraj Gupta, whose allocation to the J&K cadre stands struck down, is still continuing to serve in the Union Territory of J&K.

Affidavit shall also indicate as to whether respondent is allocated to AGMUT cadre. DB grants two weeks time to file affidavit.

This significant order has been passed in a petition filed by Union of India challenging the order dated September 13, 2007 passed by the Central Administrative Tribunal, Chandigarh Bench {'the Tribunal'} in O.A. No.116-JK of 2000 in case titled Dheeraj Gupta Vs. Union of India and Ors., whereby the Tribunal has struck down the allocation of the respondent to the J&K Cadre and directed the petitioners herein to allocate him to Haryana cadre. The direction was directed to be complied with by the Union of India within a period of three months. The impugned order of the tribunal is under challenge before this Court in the instant writ petition since the year 2011. We have gone through

the proceeding sheet and perused the orders passed in this petition from time to time.

After gone through the proceedings, DB does not find any order staying the impugned judgment of the Tribunal. Resultantly, it can be safely said that respondent does not belong to J&K cadre and therefore prima facie cannot hold any post borne on the J&K cadre/now AGMUT cadre unless he is allocated to such cadre During the proceedings it was told to Division Bench that respondent is still working in J&K despite his allocation to J&K having been struck down by the Tribunal. The respondent is also not coming forward to assist this court.

DB observed that before we proceed to decide this petition on merits, we would like to know the position with regard to the implementation of the judgment dated 13.09.2007 by the Union of India. DB directed Vishal Sharma, DSGI shall file an affidavit on behalf of the Ministry of Personnel, Public Grievances & Pensions to indicate as to how they have complied with the judgment of the Tribunal dated 13.09.2007, impugned in this petition and shall also explain as to how the petitioner, whose allocation to the J&K cadre stands struck down, is still continuing to serve in the Union Territory of J&K. Affidavit shall also indicate as to whether respondent is allocated to AGMUT cadre. He prays for and is granted two weeks time to do
