The appointment of the candidates shall remain provisional till such time the certificates are got verified by the concerned Principal(s) and are found to be in order. In case any certificate is found to be fake, inadequate or not consistent with the eligibility requirements, the appointment of the candidate(s) shall be deemed to have been cancelled ab-initio.
