- A student must pass both the tests i.e. Mental Aptitude Test (MAT) and Scholastic Aptitude Test (SAT) with at least.

- The duration of the Scholarship is four years and the student will have to score at least 55% marks in Class VIII, 60% marks in class X (relaxable by 5% for SC/ST candidates) and clear promotion in the first attempt from class IX to class X and class XI to class XII.
