Principal Secy reviews JPDCL functioning, asks for focus on reducing AT&C losses

JAMMU: Principal Secretary, Power Development Department (PDD), H. Rajesh Prasad, on Thursday reviewed the functioning of Jammu Power Distribution Corporation Limited (JPDCL), exhorting for maximising revenue and reducing Aggregate Technical and Commercial (AT&C) losses.

Present in the meeting were Managing Director JPDCL, Managing Director JKPTCL, Additional Secretaries, Chief Engineers, Chief Electrical Inspector and other JPDCL officers. The Principal Secretary reviewed the performance of JPDCL's all 1400 feeders and observed significant improvements in many areas with reduced losses. He instructed the MD to conduct case studies of the best-performing districts to replicate

successful practices in other areas. He also called for recognizing and rewarding high-performing officers while taking strict action against the under-performers. He also took stock of smart metering projects and appreciated notable progress in different districts of the UT. He expressed satisfaction with the outcomes, particularly in smart metered areas, where losses had decreased. He directed that 100 percent smart-metered areas should be ensured continuous power supply. The Principal Secretary reiterated Government's top priority of achieving 100 percent smart metering on all Feeders and Distribution Transformers (DTs). He called for effective implementation of smart Feeder & DT Metering projects. These initiatives will improve energy accounting and load management, he added.



He also inaugurated the stalls put up by Agriculture Department, Horticulture Department, ICDS, Social Welfare Department and those by BBIA Member Units including Sarveshwar Overseas Mills, Nav Bharat Flour Mill, VKC Nuts, Farm Fresh Milk. BBIA President Lalit

Mahajan welcomed the Commissioner Food and Drugs Administration J&K, Officials of Food Safety Department & BBIA Members in the Food Business Operator Meet. He drew the attention of the Commissioner towards the issues related to the Industrial Sector like Road Freight Subsidy to explore the Domestic as well as International Market of various Food & Pharma products being manufactured by Industrial Units of J&K.
