During search, 265 gms of heroine-like substance along with fire arm i.e one pistol and 02 live cartridges were recovered

In this regard a case FIR No 209/2024 under sections 8/21/22/29/60/NDPS Act, 3/25/A.Act has been registered at PS Bishnah and investigation set into motion.

It is pertinent to mention here that both the accused persons are habitual/hard-core criminals whose are involved in criminals activities in past also, while Jasvinder alias Jimmy has 6 FIRs registered against him, Jarnail has 2 FIRs registered against them in different Police Stations in Distt Jammu.

Police crackdown on illegal sale of high-dose medicines

POONCH: Acting on credible information regarding the illegal sale of high-dose medicines to youth without proper medical prescriptions, the Poonch Police has taken swift and deci-

During a series of coordinated raids conducted under the

supervision of DYSP HQ Poonch, several medical shops were found engaging in the unauthorized sale of such medicines. Police have seized a significant quantity of high-dose medicines from these establishments.

In this connection, the matter has been taken up with Drugs and Food Control Department, Poonch. The Assistant Controller Drugs, District Poonch has ordered for Suspension of operations of Sales of Licences of these three shops for one week viz Raman Medical Hall, Kamsar, Arsh Medical Hall Kamsar and Arvinder Medical Hall, Parade, Poonch. Any deviation in this regard shall follow penal action as per law

SSP Poonch assured that strict action will be taken against those found guilty, emphasizing the commitment of law enforcement to safeguard the health and well-being of the community, especially the youth. The SSP further urged the public to report any similar activities to the authorities to ensure such incidents are curbed effectively.

The police reiterate that the sale of medicines without a valid doctor's prescription is a serious offense under the law and can have severe consequences for public health.

Notorious fraudster arrested for duping innocent citizens in ATM fraud cases STATE TIMES NEWS

THANNAMANDI: A notorious fraudster was arrested by police who was duping innocent citizens by ATM fraud.

Police Station Thanamandi has arrested a notorious fraudster, Javed Iqbal Tass, son of Mohd Ashraf, a resident of Bhanghai, Tehsil Thanamandi, District Rajouri, for his involvement in multiple cases of ATM fraud. The accused has been cheating innocent people by swapping their ATM cards under the pretext of helping them withdraw money.

Javed Iqbal Tass recently duped Tahira Parveen W/o Mohd Alyas R/o Saaj Thanamandi of an amount of Rs. 17,000, leading to the registration of FIR No. 146/2024 U/s 303(2), 318(4) BNS at Police Station Thanamandi. In another case. he targeted Nazir Hussain S/o Wazir Hussain R/o Danna Husplote Thanamandi swapping his ATM card and withdrawing Rs. 16,400 of his hard-earned money, for which FIR No. 109/2024 U/s 420/34 IPC was also registered.

During interrogation, the accused confessed to his fraudulent activities and a total of 11 ATM cards belonging to various victims have been recovered from his possession, indicating the extent of his criminal acts, he investigation has also revealed that Javed Iqbal Tass has carried out similar fraudulent activities in other Districts, further highlighting his involvement in a broader pattern of deceit.

Most wanted hardcore criminal absconding in heinous cases arrested

SAMBA: In a major success against the Absconders/ Criminals, Samba Police apprehended a hardcore criminal absconding in two heinous criminal cases registered at Police Station Vijaypur and was also wanted/involved in multiple criminal cases registered at Police Station Samba, Police Station Vijaypur and Police Station Ramgarh.

A Police team headed by SHO PS Vijaypur under the supervision of SDPO Vijaypur and under the overall supervision of SSP Samba succeeded in apprehending an absconder namely Fareed Ali S/o LalHussain R/o RakhBarotian tehsil Vijaypur district Samba in case FIR No. 111/2018 U/S 307/452/323/147 RPC and FIR No. 08/2021 U/S 376-

D/323/366/504 IPC registered at PS Vijaypur. The said absconder was one of the main accused in sensational gang rape case of PS Vijaypur and was also involved in attacks on the police party at RakhBarotian Vijaypur. After hectic efforts, Police arrested the absconder who was evading his arrest after the commission of the crime.

The said accused is a hardcore criminal against whom multiple criminal cases have been registered at different Police Stations of district Samba which includes FIR No. 111/2018 U/S 307/452/323/147 RPC of PS Vijaypyur; FIR No. 08/2021 U/S 376-D/323/366/504 IPC of PS Vijaypyur; FIR No. 106/2021 U/S 353/332/336/147/506 IPC of PS Vijaypyur; FIR No. 99/2021 U/S 307/452/323/436/506 IPC of PS Vijaypyur; FIR No. 90/2016 U/S 341/323/382/506 RPC of PS Samba; FIR No. 78/2021 U/S 188 IPC 11 PCA Act of PS Samba; FIR No. 262/2024 U/S 109/132/121(1)/125/324(4)/191(3) BNS 4/25 Arms Act 3/4 PDPP Act of PS Samba and FIR No. 69/2018 U/S $341/323/34\ \mathrm{RPC}$ of PS Ramgarh.

Accordingly, the said absconder will be produced in the court of law and the arrest warrants u/s 512 CrPC issued against him will be executed.

Forest wood recovered; truck seized, smuggler nabbed

KATHUA: J&K Police Kathua recovered/seized one Load Carrier vehicle(Truck) laden with "Forest Wood" in the jurisdictional area of PS Basohli at Behani - Mahanpur area which were allegedly being smuggled from Behani Mahanpur area and 01 person was arrested alongwith the said vehicle which was seized in this connection.

An information was received at PCP Mahanpur through reliable sources that one vehicle is indulged in the Smuggling/Theft of Banned Wood of Forest Produce, and doing the illegal "Trade of Smuggling" of Wood without any valid document and permission which is loaded in a vehicle (Truck) bearing Reg. No. HP38D-0226 and proceeding from Behani chowk towards the Mahanpur side.

Following a tip off about the smuggling of forest wood, the police team led by IC PCP Mahanpur under the guidance of SDPO Basohli and SHO P/S Basohli laid a naka and intercepted the said Truck bearing Reg. No. HP38D-0226 which was driven by a person namely Bunty Kumar, son of Balwant Singh, resident of Dunera Tehsil & District Pathankot who was indulged in smuggling of different types of Forest Wood. During checking it was found that the said vehicle was laden with forest Wood logs, when asked for any valid permission the accused person could not produce any document related to the sale and purchase of the forest wood and therefore, the recovered Forest wood logs alongwith said vehicle was seized and 01 person was arrested and later on handed over to Forest Check Post Mahanpur for further legal proceedings.

4 drug peddlers arrested; contraband/ psychotropic substances recovered

SRINAGAR: Police in Srinagar have arrested two drug peddlers in separate incidents and recovered contraband/psychotropic substances from their possession.

During search, substantial quan tity of contraband substances have been recovered from his

Police in Pulwama have arrested two drug peddlers and recovered psychotropic substances during their possession.

During the course of investigation of case FIR No 246/2024 U/S 8/22 NDPS Act of PS Pulwama, further leads were developed, which led to the arrest of two more drug peddlers identified as Sajad Ahmed Sheikh resident o Nambla Uri and Mudasir Ahmed Thoker son of Gh Hassar Thoker resident of Sonasamil. 264.5 grams of heroin was recovered from the possession of one of the accused Mudasin Ahmad. Pertinently, a drug peddler namely Shabir Ahmed Chowdary son of Mir Ali Chowdary resident of Sidhra Jammu has already been arrested along with his vehicle JK02DB-4579 in the instant case besides, 305 grams of Heroin was recovered from his possession.

Police destroys narcotic drugs & psychotropic substances worth over 1 cr

During incineration, 123.728 Kgs of Poppy (Straw/Powder), 2811 Bottles of Codeine Phosphate & 28,316 Capsules of SpasmoProxyvon have been destroyed after following all legal requirements as envisaged under Rules, 2022 & was done strictly in compliance to directions issued by the Special Court (NDPS) Baramulla.
