JAMMU: Deputy Commissioner Sachin Kumar Vaishya convened a meeting on Friday to assess the progress of pending land acquisition, de-acquisition and requisition cases concerning the Army.

During the meeting, the DC emphasised the necessity for DEOs and SDMs to expedite the resolution of all outstanding cases within set timelines. He directed the officers to ensure that pending rent assessments are completed without delay, enabling prompt disbursement of rental payments to rightful landowners. Pursuant to Notification No. 191-BOPEE of 2024 dated 16.12.2024, the Board has conducted special stray round of Physical counselling for filling up of seats of BAMS/BUMS/BHMS/BPT Courses-2024 in various Government/Private Colleges of UT of J&K on 19-12-2024. The list of candidates provisionally allotted seats in Government/Private Colleges/Institutions of UT of J&K, is hereby notified as per Annexure-A to this Notification, which shall be available on the official website of the Board viz. The provisionally selected candidates shall report to the colleges allotted to them upto **20.12.2024 till 3:30 p.m.** along with the following documents in original: -

- i. Domicile Certificate.
- ii. 12<sup>th</sup> Class Marks Card.
- iii. D.O.B. Certificate/10th Class Marks Card issued by the Board.
- iv. Category Certificate, wherever applicable.
- v. NEET 2024 score card.
- vi. Any other document may be required by the College Authorities.

The provisionally selected candidates shall have to mandatorily report for admission to the allotted Colleges / Institutions by or before **20.12.2024 upto 3:30 p.m.** along with their relevant certificates/documents in original, failing which they shall not be eligible for further counselling, if any, conducted by the Board.

**Note:**

1. The admission of candidates shall be purely provisional and liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated and action as warranted under law shall be initiated against them.
2. If any candidate(s) is found to have concealed any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him/her as may be deemed proper by the Board in accordance with the laid down rules.
3. All the provisionally selected candidates are advised to visit their respective allotted Colleges/Institutions for fee and other relevant documents required by the respective Colleges/Institutions.
4. It is the sole responsibility of the concerned Colleges/Institutions to check and verify the documents and eligibility of the provisionally selected candidates before allowing them to join in their respective Colleges/Institutions.

In case, if any, candidate from the provisionally selected list fails to join up to the prescribed cut-off date fixed by the Board i.e. **20-12-2024 upto 3:30 p.m.**, the waiting list shall be operated by the college on the same date i.e. **20-12-2024 from 3:31 p.m. to 6:00 p.m.** considering the last date of admission fixed by the Ministry of Ayush so that no seat shall remained unfilled.
