Deepak elected unopposed as President of TFWHNM Jammu

JAMMU: Deepak Gupta has been elected unopposed as the President of the Traders Federation Warehouse Nehru Market (TFWHNM) Jammu.

Saturday marked the last day for filing nominations, and no other candidate came forward for the post of President. As a result, Chief Election Officer Rajesh Bhagotra, along with his team members Atul Khanna, Krishna P Gupta, Sudesh Gupta, and Sunil Kumar Gupta, declared Deepak Gupta as the unopposed President. This marks a historic moment as it is the first time in the 60-year history of the Federation that a candidate has been elected unopposed to the President's post.

Deepak Gupta first contested the election for the position of General Secretary in 2015, winning by a significant margin. He was re-elected unopposed as General Secretary in 2018.



In 2021, he contested for the President's post and triumphed with a margin of over 300 votes, becoming the youngest-ever President of the Federation. Upon his unopposed election, Deepak Gupta expressed his gratitude to the members for their trust and said that their decision has increased his responsibility. He pledged to live up to their expectations and work towards the Federation's growth and success.
