

DB quashes Govt order appointment of respondent as SI

Directs respondent shall be deemed to have been appointed as Inspector in Excise Deptt

JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court comprising Justice Sanjeev Kumar and Justice Puneet Gupta, while disposing the petition filed by GAD against the judgment of CAT, with the observations that Government Order No.1133-GAD of 2017 dated September 7, 2017, whereby the case of the Rajan Vikrant for his appointment as Inspector in the Excise Department was rejected is quashed.

DB further observed that the government Order No.127-GAD of 2008 dated August 31, 2008 to the extent it refers to the appointment of the Rajan Vikrant as Sub Inspector is also quashed and ordered that the Rajan Vikrant shall be deemed to have been appointed as Inspector

in the Excise Department in relaxation of Rules with effect from January 31, 2008 and the appointment of the respondent w.e.f. January 31, 2008 till he was appointed as Inspector in the Excise Department on promotion shall be purely on notional basis, though his seniority in the cadre of Inspectors shall be reckoned w.e.f. January 31, 2008. DB further directed that the petitioners shall pass appropriate orders to give effect to his judgment within a period of three months.

This judgment has been passed in a petition challenging the order and judgment dated March 22, 2024 passed by the Central Administrative Tribunal, Jammu Bench, Jammu ["the Tribunal"] in TA No.61/978/2020 titled Rajan Vikrant v. State of

J&K and others is subject matter of challenge in this petition filed by the Union Territory of Jammu and Kashmir and two others invoking extraordinary writ jurisdiction of this Court under Article 226 of the Constitution of India.

The case is that the father of the respondent, namely Late Davinder Kumar Sharma was serving as DySP in Jammu & Kashmir Police and attained martyrdom on October 27, 2001 in an IED blast while he was posted as SDPO, Basohli. He left behind his wife, daughter and a son i.e. respondent herein.

The respondent applied for compassionate appointment in the J&K Police as Inspector under SRO 43 of 1994. Initially, the respondent was considered for appointment as Inspector

in the J&K Police by the then Director General of Police. The matter was taken up with the Financial Commissioner, Home Department, J&K Govt. and thereafter with the General Administration Department. It seems that the General Administration Department did not agree with the proposal of the Director General of Police for appointment of the respondent as Inspector in the pay scale of Rs.4000-6000 in the Excise Department in Jammu Division in relaxation of proviso to Sub Rule (1) of Rule (3) of SRO 43 of 1994.

FIR (Supra) came to be registered against the petitioner herein and his parents for commission of offences under Sections 304-B/498-A/109 IPC. Justice Javed Iqbal Wani after hearing both the sides observed that Having regard to the gravity of the accusations levelled against the petitioner, inasmuch as the position of the petitioner being an army personnel/officer where there is every likelihood that the petitioner would intimidate the witnesses acquainted with the case directly or indirectly so as to dissuade them from disclosing facts to the trial court or may tamper with the prosecution evidence, it is deemed appropriate and desirable to decline the concession of bail to the petitioner.

HC denies bail to Army Major in dowry death case

JAMMU: Justice Javed Iqbal Wani of Jammu & Kashmir and Ladakh High Court rejected the bail application of one Army Major who was booked by the Rajouri police in dowry death case.

The facts emanating from the record would reveal that the petitioner herein is holding the post of Major in the Indian Army and came to be married to one Dr. Kavita (hereinafter referred as 'the Deceased') on April 22, 2023 under Hindu rites and customs, who died an un-natural death on October 1, 2023, which information came to be received by the Police Station, Rajouri on phone from one 150 GH Rajouri Army Hospital through

Messenger Call vide No. 9805220002, whereupon the receipt of the said information, the same came to be entered into the daily diary under No. 19 dated 01.10.2023 and proceedings under Section 174 Cr. P. C. came to be commenced by the Police Agency and in the process, site plan came to be prepared and the custody of the dead body of the deceased taken over and post mortem conducted and thereafter the wearing apparels of the deceased as well came to be seized and after completing all necessary requisite formalities the dead body later was handed over to the Army Authorities under proper receipt. Besides, during the course of proceedings under Section 174 Cr.P.C.,

laptop and mobile of the deceased were also seized and it also got revealed that the deceased had died in her residential quarter, whereafter statement of mother of the deceased was also recorded besides other persons acquainted with the facts of the case and that during the course of post mortem Virsa of the deceased was obtained, which was submitted to FSL for its opinion and that the personal tab of the deceased was also seized, which contained a written suicide note of the deceased, which revealed that the death of the deceased was a case of dowry death and after taking cognizance of the aforesaid facts, as also the suicide note contained in the tablet of the deceased, the
