He emphasized the need for a robust mechanism to minimize public inconvenience during severe weather conditions

The Chief Minister also engaged with Deputy Commissioners to assess district-level preparedness and urged them to prioritize timely and effective responses to weather-related challenges

The Chief Minister stressed the importance of keeping men and machinery in a state of readiness to ensure the routine functioning of essential installations.

He directed departments to prioritize uninterrupted trade, transport, and essential supblies while addressing disruptions caused by snow, waterlogging, or power outages

On snow clearance, he was briefed that a sufficient number of hi-tech snow clearance nachines have been deployed by the R&B Department, SMC, MED, BRO, and NHAI, with additional machines on standby to handle heavy snowfall.

The Chief Minister instructed the concerned authorities to focus on clearing key routes, ncluding inter-district highways and roads leading to hospitals, power grids, water supply systems, and fire and emergency services.

The meeting was informed that adequate stocks of ration, petrol, diesel, and LPG are available to meet the needs of residents for several months. Additional provisions have been nade to ensure timely distribution across districts.

The Chief Minister directed for establishment of joint control rooms in all districts to handle winter-related complaints promptly.

He stressed the importance of a swift response system to minimize public inconvenience and ensure seamless delivery of essential services. Reviewing the health sector's readiness, the Chief Minister directed the Health Department to ensure adequate stocks of medicines, oxygen cylinders, and emergency supplies across all hospitals.

He also emphasized maintaining functional central heating systems in healthcare facilities and ensuring the deployment of medical personnel in snowbound areas.

Instructions were given for providing transport service to expecting mothers in remote and far-flung areas.

Highlighting the criticality of uninterrupted power supply during winter, the Chief Minister instructed KPDCL engineers to prioritize the restoration of electricity, particularly for essential installations.

He called for timely replacement of damaged transformers and urged for protection of field staff with proper safety gear to prevent accidents during repair work.

The Chief Minister underscored the importance of maintaining road connectivity and effieient traffic management.

He directed agencies to deploy sufficient manpower and equipment for snow clearance on national highways, main roads, and internal routes, ensuring minimal disruption to public movement.

Omar Abdullah concluded the meeting by urging all departments to work in coordination and take proactive measures to mitigate the impact of harsh winter conditions. He reiterated his commitment to minimizing public inconvenience and ensuring the effective delivery of essential services throughout the region.

Registrar General to review the Bar Council rules regarding the dress code for female

Upon review, the Registrar General submitted a report on December 5, confirming that the rules under Section 49(1)(gg) of Chapter IV (Part VI) of the BCI Rules do not allow for a lawyer to appear in court with her face covered.

The rules specify that the prescribed attire includes a black full-sleeve jacket or blouse with a white collar and bands, with specific options for sarees, skirts, or traditional dresses, but there is no provision for covering the face.

On December 13, the judge, after considering the Registrar General's report, reiterated that there is no provision in the rules permitting women lawyers to appear with their faces covered. The female lawyer did not appear on this date, and the case was argued by a male

Senior Advocate Sajjad Mir added that the court did not issue any further opinion on the matter, as the Bar Council's dress code was already clear. The judge emphasized that a woman lawyer must be identifiable to the court, meaning she cannot argue a case while wear ing a veil or Hijab that covers her face.

The accused are charged with conspiring to lisrupt communal harmony by intentionally disposing of dead cows and calves in Majority dominated areas, a deliberate act aimed at outraging religious sentiments. # Fake court order case solved: Advocate arrested as main kingpin

JAMMU: In a significant breakthrough, the Jammu Police have solved a fake court order case, arresting an advocate identified as the main kingpin behind the forgery. The case (FIR No. 142/2024) was registered under sections 318(4)/338/336(3)/340(2) of the BNS at Police Station Janipur, Jammu, following a complaint received on 19-12 2024 from the 3rd Additional Munsiff, JMIC Jammu through the Chief Judicial Magistrate, Jammu. The com plainant also requested the constitution of a Special Investigation Team (SIT) to expedite the investigation.

The complaint alleged that a fake court releasing order, cre ated using forged stamps and the Judge's signatures, along with a fraudulent G.R. receipt for Rs. 50,000/-, was used to illegally release a seized vehicle (Tipper bearing registration number JK02CT-6827) involved in a mining case. Acting on the request, the Senior Superintendent of Police, Jammu promptly constituted an SIT to investigate the matter. The eam meticulously collected critical evidence, including the forged releasing order and the fake G.R. receipt. After a detailed probe, the SIT identified and arrested the accused, Advocate Basharat Ahmed Khan, son of Mohd Bashir, resi dent of Asrarabad Sidhra, Jammu, who was revealed as the main conspirator in the case. The accused is currently in custody at Police Station Nagrota. A search of the advocate's res dence, conducted in the presence of an Executive Magistrate ed to the recovery of the mobile phone used to prepare the fake documents. Additional electronic devices, including a computer and printer, were also seized, along with the fraudulent G.R. receipt used in the transaction. The Jammu Police are continuing their investigation, with further recoveries and arrests expected in the coming days. The arrest of the kingpin reflects the police's unwavering commitment to combating fraudulent activities and ensuring accountability.

They sought more time to discuss the issue with higher authorities. Therefore, we have decided to proceed with the strike," he said.
