UDHAMPUR: The body of a Village Defence Guard (VDG) with a bullet wound was found in Udhampur district a day after he went missing, police said on


His rifle was recovered from the spot, they said.

"The body of a VDG member, Ashok Kumar, with a bullet injury was found in the upper reaches of Chapper. However, it remains unclear whether he shot himself or was shot by someone else," a senior police officer told PTI.

After receiving information about the body, a police team was rushed to the spot. The body was shifted to a hospital for post-mortem. Kumar's rifle was found at the spot, the officer said.

The post-mortem report revealed that he was shot in the abdomen and the bullet was fired from his rifle, the officer added.

infiltration of terrorists into the country. The parliamentary panel is headed by senior Congress lawmaker Shashi Tharoor.

"The committee also desire that the government should make regular assessment on whether the situation is conducive for resumption of high-level interaction with the Pakistan government and take steps accordingly," the report said.

It said the problem of terrorism in India is largely sponsored from across the border.

"Terrorist outfits are provided safe havens, material support, finance and other logistics by Pakistan's ISI (Inter-Services Intelligence) to carry out terrorist activities in India," the report

"The committee are of the firm view that terrorist attacks in the country can only be curbed by dismantling all terrorist networks and safe havens and recommend that an action plan/mechanism may be worked out at the earliest for effective sharing of resources, capacity enhancement and pooling of available experts of the central agencies," it said.

The committee also noted the challenges being faced by India in dealing with radicalism and recommended that the government should remain proactive and maintain close coordination with multilateral and regional bodies to combat the challenge.

UK Parliament raises concerns over attacks on Hindus in Bangladesh

LONDON: The British government continues to monitor the situation in Bangladesh Parliament raised concerns over recent attacks on the minority Hindu community there and arrest of religious leaders, a senior minister said here. During an urgent question tabled in the House of Commons by Labour MP Barry Gardiner on Monday, the Foreign Office Minister in charge of the Indo-Pacific, Catherine West said that she had been given assurances by the interim government in Bangladesh that support was available for minority communities during her visit to Bangladesh last month.

She stressed that the UK was one of the first countries with ministerial support to arrive in Dhaka to speak with Chief Adviser Professor Yunus and be "vocal" in support of minori-

No lawyer to represent Hindu monk in court

DHAKA: A Bangladesh court on Tuesday deferred to next month a hearing on the bail petition of Hindu monk Chinmoy Krishna Das, arrested on a sedition charge, as no lawyer appeared on his behalf.

Swatantra Gauranga Das, an associate of the monk at his Sammilita Sanatani Jagaran Jote, claimed that no lawyer represented the Hindu leader due to threats from a "politically motivated lawyers' group".

The bail hearing at the Chattogram court has now been postponed to Das' arrest on November 25 had triggered demonstrations by supporters of the monk, who was previously with the International Society for Krishna

ter Sheikh Hasina fled to India. The situation aggravated further with Das' arrest last week. The Hindu community in Bangladesh has regularly faced attacks on its members and places of worship during the widespread protests against Hasina's Awami League-led government over a controversial job quota system.

The attacks have continued even after Muhammad Yunus, a Nobel laureate, took over as the Chief Adviser of the interim government on August 8. Gardiner, MP for Brent West in London with a large British Hindu population, described the situation as being "clearly on a knife edge" and ■ CONTD ON PAGE 9 raised concerns on behalf of the "large diaspora populations in the UK and large Hindu communities with strong links to the community in Bangladesh".

The shadow foreign secretary, Conservative MP Priti Patel, noted that the degree of escalation in the violence is "deeply, deeply concerning".

60 lakh new job cards issued under MGNREGS every year, Govt tells LS

MGNREGS workers have been deleted in the last four

new job cards are issued under the MGNREGS on average every year and the government has no role in the deletion of the job cards which is done based on various parameters, the Centre said on Tuesday.

Minister of State for Rural Sekhar Pemmasani told the Lok Sabha that 57 per cent of the rural development budget is allocated for the Mahatma Gandhi National Employment Guarantee Scheme (MGN-REGS) and asserted that Aadhaar-seeding of the cards enhances transparency.

Venugopal also wanted to know whether the deletions were linked to the Aadhaarseeding requirement.

"Ninety-nine per cent of all job card holders have Aadhaar seeding. Aadhaar seeding is nothing but to increase transparency. It is not an obstacle," the minister said during the Question

According to Pemmasani, the deletion of job cards is based on five factors, including fake or duplicate cards and a person moving from one panchayat to another.
