attack. Security forces have launched a search operation to trace the terrorists, the officials said.

Terrorists lobbed two grenades at an Army post behind an Army camp in the Surankote area. While one of them exploded, the other did not and was subsequently defused by experts during the search operation, they said.

The safety pin of the exploded grenade was found near the perimeter wall of the Army camp, they added.

A massive search operation has been launched by the Army and police in the area to track down the terrorists, who fled after the attack, the officials said.

Meanwhile, security forces continued their search for terrorsts in the Dachigam forest in Srinagar outskirts, a day after a Lashkar-e-Taiba ultra was killed in an encounter in the area officials said. According to officials, the security forces halted their search on Tuesday night but maintained a tight cordon n the area. The search for militants in the vast mountainous and forest area of Dachigam resumed in the morning, they

"The search operation in the upper reaches of Dachigam continued on Wednesday and the security forces are conducting extensive searches in the area," an official said.

LeT terrorist Junaid Ahmed Bhat was killed in the encounter with security forces on Tuesday. The category "A" terrorist was involved in the October 20 attack near a tunnel construction site in the Gagangir area of Ganderbal in which a local doctor and six non-local labourers were killed.

Dachigam, a national park located in the Zabarwan range of the Himalayas, reaches the districts of Pulwama and Ganderbal on either side and covers an area of about 141 square kilometres.

In a related development, a hardcore Over-Ground Worker (OWG) of a terror group was detained under the stringent Public Safety Act in Doda district, police said.

The PSA is an administrative law that allows detention vithout charge or trial for up to two years in some cases.

"In order to fight against anti-national elements and to curb terror-related activities in Doda, police have detained hardcore OGW Mohd Irfan of Kanhal Bajarni Tehsil Bhagwah under the PSA and lodged him in jail following a detention order issued by the district magistrate, Doda," police said in a statement. It said the accused was involved in unlawful activities and was trying to spread the terror network to revive militancy in the district at the behest of his handlers operating from across the border. "The accused was operating in a very dubious manner and his activities were a constant threat to the society at large and were prejudicial to the peace, tranquillity and security of the region. "The subject was warned a number of times and bound down to desist himself from antinational activities but he did not change his behaviour and was deemed a grave potential to assist militants in their nefarious designs to revive militancy in the district," police said.

He has been lodged at Kot Bhalwal Jail in Jammu after obtaining a detention order from the district magistrate, Doda, it said. "The step is taken to maintain the safety and security of the region and is a loud warning to all the antinational elements to either mend their ways or the law of the land will firmly be applied against them," the statement said.

liking of the Islamists, who don't want other religions to occupy even an inch of space. That is typical of all the Islamist nations. Bangladesh is copying Pakistan in persecution of the minorities where Hindus and Christians have been subjected to murders, rapes and conversions. The people in Bangladesh particularly its rulers of the time, have forgotten the atrocities that Pakistani army had committed on them, their women folk, intellectuals and all the sane elements in 1971 before India liberated them by sacrificing its own soldiers for their cause. Mehbooba is in a survival mode. It is the tragedy of her brand of politics that she had to preside over the worst-ever electoral defeat of her party in 2024 Assembly elections where her tally was down to dismal three seats as against 28 in 2014, 21 in 2008 and 16 in 2002. There was a gradual progression since 2002 polls before the whole thing reversed in 2024. It happens in politics. The electoral map doesn't always remain the same. But Mehbooba Mufti brought unto herself and the party that she has been leading for over two decades.

She was responsible and credited for getting Chief Minister's chair for her father Mufti Mohammad Sayeed in the aftermath of 2002 polls when the party could win only 16 seats, much short of the required majority of 44. She was able to persuade Congress, which was having 21 seats and others including Panthers Party, that a Kashmiri should head the government. The same very Mehbooba Mufti undid prospects of her father becoming Chief Minister in 2008 despite the party having scored five more seats than 2002 polls. She is looking at something more this time to expand her party's base by challenging the Indian nationalism.

"Facilitators/collaborators in this act will also become the subject of investigation," they added.

The officials said the operation is aimed at uncovering crucial evidence, curb illicit activities, prevent the misuse of communication devices, such as mobile phones, within the security zones, including the jails and dismantling the terror ecosystem in the Union Territory.

A further drop in temperatures is expected in the coming days, owing to the forecast of dry weather, they added.

Barring Kokernag, all other weather stations across the valley recorded sub-zero night temperatures, the officials said. Srinagar recorded a low of minus 2 degrees Celsius, down from the previous night's minus 1.8 degrees Celsius, they noted. Qazigund, the gateway town to the valley in South Kashmir, recorded a low of minus 2.2 degrees Celsius

The minimum temperature in Pahalgam, a popular tourist resort and one of the base camps for the annual Amarnath Yatra, settled at minus 4.8 degrees Celsius, three degrees lower than the previous night. The famous ski resort of Gulmarg registered a low of minus 3.5 degrees Celsius, while Kupwara recorded minus 1.2 degrees Celsius and Kokernag, at 0.4 degrees Celsius, was the only station to stay above freezing

### Police attaches properties of 2 drug peddlers worth over Rs 3 Cr in Srinagar

SRINAGAR: Jammu and Kashmir Police on Wednesday attached properties worth more than Rs 3 crore belonging to wo alleged drug peddlers in Srinagar, officials said.

"Reinforcing the ongoing efforts against drug eddlers/smugglers, police in Srinagar has attached properties worth more than Rs 3 crore belonging to two drug peddlers under Section 68 of the Narcotic Drugs and Psychotropic Substances (NDPS) Act," a police spokesman

Giving details, he said the police attached a three-storey resdential building belonging to Abdul Ahad Bhat at Banpora Batamaloo worth Rs 65 lakh.

Bhat is accused of selling drugs to the youth of the region or which a case under the NDPS Act was registered against him at the Shaheed Gunj police station.

In another case, police attached a three-storey residential building belonging to Manzoor Ahmad Bhat, father of Jan Manzoor Bhat from Natipora, at Umer Lane Azad Basti valed at Rs 2.5 crore, the spokesman said.

Jan Manzoor Bhat is also a drug peddler involved in selling narcotics to the youth of the area, and a case stands registered gainst him at the Chanapora police station.

Both the properties were acquired using proceeds of illegal arcotics trade, the spokesman added.

In compliance with Section 68 of the NDPS Act, the immovable properties shall not be transferred/sold/purchased or othrwise dealt with without the prior permission of the compeent authority, the spokesman said.

The action underscores the commitment of J-K Police in eradicating the drug menace and dismantling the infrastructure supporting narcotics trafficking in the region, he added.

The accused identified as Rakib Ahmad Dar son of Abdul Salam Dar resident of Rajouri Kadal Srinagar has been arrested on the spot.

# Sukhbir Badal escapes attempt on life at Golden Temple; former Khalistani terrorist arrested

AMRITSAR: Shiromani Akali Dal leader Sukhbir Singh Badal escaped a bid on his life on Wednesday when a former Khalistani terrorist fired from a close range at Punjab's ex deputy chief minister at the Golden Temple's entrance here but missed as plainclothes policemen overpowered him.

The audacious attack, which occurred at around 9:30 am, was captured on cameras by mediapersons who had gathered to cover the second day of Badal performing the duty of 'sewadar' at the main gate of the Sikh shrine as religious penance for "mistakes" committed by the SAD government in Punjab from 2007 to 2017.

As other devotees were entering, the shooter, identified as former terrorist Narain Singh Chaura, slowly walked towards Badal (62), a Z+ protectee who was sitting in a wheelchair due to a fractured leg, and pulled out a gun from his pocket.

Chaura, 68, was seen at the shrine on Tuesday as well.

Assistant Sub-Inspector (ASI) Jasbir Singh, who was standing close to Badal in plainclothes, sensed the threat to the senior Akali leader and pounced on the shooter, grabbed his hands and pushed them upwards after which the attacker

was overpowered with the help of other security personnel and Shiromani Gurdwara Parbandhak Committee (SGPC) task force members.

In the melee, the gun fired and the bullet hit the entrance wall of the shrine behind Sukhbir Badal, who escaped

Additional Deputy Commissioner Harpal Singh said the police had been keeping an eve on Chaura, who was at the Golden Temple on Tuesday as well.

Special Director General of Police Arpit Shukla told PTI that more than 20 cases including under the Unlawful Activities (Prevention) Act are registered against Chaura.

He was involved in the 2004 Burail jailbreak case where he allegedly helped terrorists Jagtar Singh Hawara, Paramjit Singh Bheora and two others escape from prison. A native of Chora Bajwa village Dera Baba Nanak in Gurdaspur district, he has been out on

Chaura had remained in jail in Gurdaspur, Amritsar, Ludhiana and Chandigarh, his wife Jasmeet Kaur told reporters at his native place. To a question, she said he had told her that he was going to Golden Temple. She said whatever he did was wrong.

Amritsar Police Commissioner Gurpreet Singh Bhullar said the attack on Badal was foiled because of the alertness of police and the motive behind it will be ascertained after Chaura's ques-

The shooter came alone to the Golden Temple, he said, adding that the case will be investigated from all angles.

Sukhbir Singh Badal is the son of five time former chief minister of Punjab Parkash Singh Badal and had recently announced his decision to step down as SAD president. He was the deputy chief minister of Punjab from August 2009 to

March 2017. Responding to a question, Bhullar said the security deployment at the shrine was sufficient. Police cannot carry out frisking because religious sentiments

are involved, he said. "Around 175 police personnel led by an assistant inspector general have been deployed at the complex," he said.

Devotees are not frisked at the entrance of the Golden Temple, one of the most revered Sikh shrines. It has four entry points. No metal detector has been installed at any entrance. However, the Shiromani Gurdwara Parbandhak Committee deploys its task force members who keep an eye on suspicious persons. If they find anyone suspicious,

they can check the person.
