Subject: Compliance with Hon'ble Supreme Court's Order dated 07th November, 2025 in *Suo Moto Writ Petition (Civil) No. 5 of 2025 - Regarding Stray Dog Management in Institutional Areas.*

Circular No. 10-JK (HUD) of 2025
Dated: 08-12-2025

In continuation of this Department's Circular No. 07-JK (HUD) of 2025 dated 05-09-2025, and in pursuance of the directions contained in the Order dated 07.11.2025 passed by the Hon'ble Supreme Court of India in *Suo Moto Writ Petition (Civil) No. 5 of 2025* titled "*In Re: City Hounded by Strays, Kids Pay Prices The State Of Andhra Pradesh*", all Urban Local Bodies (ULBs) of the Union Territory of Jammu & Kashmir are hereby directed to ensure immediate, time-bound, and strict compliance of the following comprehensive directions:

A. Identification of Institutional Areas
All Urban Local Bodies, in coordination with the concerned District Magistrates, shall, within a period of two weeks from the issuance of this circular, complete the identification of all Government and private institutions falling within their territorial limits. This survey must be meticulous and shall specifically include:

- Educational Institutions:** All pre-primary schools, primary and secondary schools, higher secondary schools, colleges, universities, technical institutes, coaching centers, and tutorial institutions, irrespective of whether they operate hostels or not.
- Healthcare Facilities:** All medical colleges and associated hospitals, district hospitals, sub-district hospitals, primary health centres.
- Sports and Recreation Infrastructure:** All public sports complexes, stadiums.
- Transportation Hubs:** All bus stands, bus depots, Inter-State Bus Terminals (ISBTs), railway stations.
- Other Sensitive Areas:** The ULBs may, at its discretion, include any other public institution frequented by large numbers of people, particularly children, where the presence of stray dogs is deemed a significant risk.

B. Securing Institutional Premises to Prevent Ingres
The local ULBs shall assist in all possible way the administrative heads of all institutions identified under Direction (A) to immediately undertake and complete all necessary structural and administrative measures to secure their premises. These measures must include, but are not limited to:

- Erection and repair of boundary walls and perimeter fencing.
- Installation and proper management of gates.
- Any other necessary structural interventions to physically prevent the ingress of stray dogs.

Suitable budget provisions shall be made in the upcoming budget both under UT Capex and CSS schemes if any. Duty compiled budgetary estimates shall be submitted by 15th December to this office by all concerned agencies/Departments. Nodal officer, I&UDD shall ensure duly compiled budgetary estimates for onwards submission to UT Committee. This critical exercise of securing the premises must be completed as soon as possible. District Magistrates shall monitor the progress bi-weekly.

C. Regular Inspections by ULBs
The local Municipal Authorities are directed to institute a regime of mandatory regular inspections of all institutional premises identified under Direction (A). These inspections must be conducted at least once every three (03) months. The inspection team shall verify that no stray dog habitats exist within or in the immediate vicinity of these institutions.

A standardized inspection proforma shall be used for all inspections, which shall record findings, observations, and recommendations.

D. Removal of Stray Dogs from Institutional Premises
The process of removal must be conducted with utmost humanity and in strict conformity with the provisions of the Animal Birth Control (ABC) Rules, 2023, and all other applicable animal welfare laws. The use of cruel methods, indiscriminate poisoning, or any form of inhumane treatment is strictly prohibited and will attract severe disciplinary action. The dogs so picked up shall be transported safely to a designated ABC center or animal shelter for mandatory sterilization/vaccination and subsequent care.

The ULBs must maintain this data in the mobile application already developed, for such removals, documenting for each animal: the date of pickup, precise location (with geo-coordinates if possible), description of the animal, details of the ABC center where it was shifted, date of release, and the location of release. This data uploaded on mobile application shall be subject to review.

E. Management of Transport Hubs
Urban Local Bodies having jurisdiction over bus stands/depots, ISBTs, and railway stations, shall accord top priority to these high-footfall areas. They shall ensure that such public-transport premises are effectively secured and are maintained to prevent the habitation, feeding, or movement of stray dogs. A robust, foolproof waste-management system shall be implemented and strictly enforced at all these locations to eliminate open food waste, discarded food packets, and other organic waste that attract animals. This includes:

- Provision of an adequate number of covered, animal-proof bins at strategic points.
- Enforcement of a schedule for frequent garbage collection, ensuring that waste does not accumulate for more than a few hours.
- Strict enforcement of regulations against littering and open disposal of food waste by vendors and commuters.
- Signage and public awareness campaigns at these hubs to educate the public on responsible waste disposal.

The Commissioner, Municipal Corporation, Jammu/Srinagar and the Director, Urban Local Bodies, Kashmir/Jammu shall be responsible for the strict adherence to these directions across all ULBs. Director, Urban Local Bodies, Kashmir/Jammu shall also issue necessary instructions to all Chief Executive Officers/Executive Officers for immediate compliance.

A comprehensive compliance report, specifically and point-by-point indicating the actions taken and progress achieved on each of the above directives, shall be furnished to this Department within thirty (30) days, by Commissioner, Municipal Corporation, Jammu/Srinagar and Director, Urban Local Bodies, Kashmir/Jammu. Any reported non-compliance or lethargy in implementation shall be viewed very seriously and may invite strict disciplinary action, including the initiation of proceedings for dereliction of duty, against the erring officials.
