unprecedented attacks from ten heavily-armed Pakistan-trained terrorists. Defending himself over the criticism, he had said people should criticise policy, not clothes. The sheer scale of the Mumbai attacks weighed heavily on Patil's political career and made his position in the Union Cabinet virtually untenable, leading to his resignation on November 30, 2008.

Condolences poured in from across party lines, reflecting the wide respect the Congress politician commanded.

President Droupadi Murmu, Prime Minister Narendra Modi, Chief Minister Devendra Fadnavis, NCP (SP) chief Sharad Pawar, Congress president Mallikarjun Kharge, Lok Sabha Leader of Opposition Rahul Gandhi and many others offered condolences and paid tributes to Patil.

Born on October 12, 1935, Patil began his political journey as the president of Latur municipality between 1966 and 1970 and was subsequently elected as an MLA for two terms. He held key posts in the Maharashtra assembly, including Deputy Speaker and Speaker, between 1977 and 1979.

He then went on to win the Latur Lok Sabha seat seven times and was the 10th Speaker of the Lok Sabha from 1991 to 1996. He lost to BJP's Rupatai Patil Nilangekar in the 2004 Lok Sabha elections. He was also a Rajya Sabha member.

The Congress leader held several key portfolios in the Union Cabinet, including Home, Defence, Commerce, and Science and Technology. Patil was the Governor of Punjab and also served as Administrator of the Union Territory of Chandigarh from 2010 to 2015.

In 2022, speaking at a book launch, he courted controversy for claiming that the concept of "jihad" was present not just in Islam but also in the Bhagavad Gita and

In March 2025, he had met Prime Minister Narendra Modi in Delhi with his fam-

Calling Patil a distinguished parliamentarian and statesman, Fadnavis said his demise was deeply saddening.

Patil served in several key roles, leaving an indelible mark through his exemplary public service, said Fadnavis. As Speaker of the Lok Sabha, he initiated and supported several innovative parliamentary practices, earning respect across the politi-

"Renowned for his integrity, deep knowledge and firm leadership, Patil commanded a place of esteem in Indian politics. His death has created a void in the country's political and social leadership," he added.

Sharad Pawar said Patil played a significant role in the politics of both Maharashtra and the nation, harmoniously blending the Congress ideology with his unwavering commitment to resolving people's issues. "In every position he held, his work consistently reflected justice for the common man," said the NCP (SP) chief.

Former CM Ashok Chavan, who hails from neighbouring Nanded, described Patil as a "guiding figure, like a father".

"For me, the death of Shivraj Patil Chakurkar is a great personal loss. He shared a brotherly bond with (my father) Dr Shankarrao Chavan, and for many years, our families have shared a deep relationship," said the BJP Rajya Sabha member.

In Patil's death, the country has lost a cultured and scholarly personality, Deputy Chief Minister Ajit Pawar said, calling the Congress leader a "symbol of simplicity and ethical conduct"

Highlighting Patil's initiatives during his stint as the Lok Sabha Speaker, Pawar said he pushed for modernisation and computerisation of the House. "The Outstanding Parliamentarian Award was also started during his tenure," said

Deputy Chief Minister Eknath Shinde said Patil served in different constitutional posts, from his home state Maharashtra to the Centre, during his decades-long

In his demise, the country has lost an experienced, cultured leader who skilfully blended politics and social work, noted Shinde.

NCP (SP) MP Supriya Sule mourned Patil's death, saying his passing marks the loss of a leader with vast parliamentary experience. Latur MLA Amit Deshmukh also offered his tributes to Patil.

Known for his dignified conduct, he never indulged in personal attacks, neither in

public speeches nor in private conversations, said a Congress leader. Patil was also known for his vast reading, meticulous study, and articulate presentation. His command over Marathi, English, and Hindi, along with his exceptional grasp of constitutional matters, made him a much-respected parliamentarian of his time, added the party leader.

at the initial stage may not be determinative. However, the claimants must establish the specific identity of the vehicle/driver, with the caveat that the connection of the accident with the said vehicle must be established through cogent and reliable evidence," the bench said.

Referring to a report of the motor vehicle inspector, the bench said it revealed no damage whatsoever to the alleged offending vehicle.

"We find no perversity in the appreciation of evidence, nor exceptional circumstances warranting interference with these concurrent findings," the bench said, while dismissing the appeals.

Teacher Education (NCTE). "The bill to set up Viksit Bharat Shiksha Adhikshan has been approved by the

Cabinet," an official said. While the UGC oversees non-technical higher education, the AICTE oversees technical education and the NCTE is the regulatory body for teachers' education.

The Commission is proposed to be set up as a single higher education regulator, but medical and law colleges will not be brought under its ambit. It is proposed to have three major roles -- regulation, accreditation and setting professional standards. Funding, which is seen as the fourth vertical, is not proposed to be under the regulator so far. The autonomy for funding is proposed to be with the administrative ministry.

The concept of HECI has been discussed before in the form of a draft bill. A draft Higher Education Commission of India (Repeal of University Grants Commission Act) Bill, 2018, which sought to repeal the UGC Act and provided for the setting up of the Higher Education Commission of India, was put in the public domain in 2018 for feedback and consultation with stakeholders.

It adds that the new system should ensure the distinct functions of regulation, accreditation, funding and academic standard setting are performed by distinct, independent and empowered bodies.

Red Fort blast: Delhi court sends 3 doctors, preacher to 12 days jail

NEW DELHI: A Delhi court on Friday remanded three doctors and a preacher who were arrested in connection with the November 10 Red Fort blast case to 12 days of

Another accused Dr Bilal Naseer Malla was also produced before Principal and Sessions Judge Anju Bajaj Chandna to authenticate his voice sample.

The four accused -- Dr Muzammil Ganai, Dr Adeel Rather, Dr Shaheena Saeed and Maulvi Irfan Ahmed Wagay -- were produced before the expiry of their four-day NIA custody granted on December 8.

Mediapersons were barred from covering the court proceedings, which were held under tight security in and around the Patiala House district court premises. Till now, the National Investigation Agency (NIA) has made eight arrests in the

case, which is linked to a 'white collar' terror module busted by the Jammu and Kashmir Police. Dr Bilal Naseer Malla, a resident of Baramulla district in Jammu and Kashmir

is the eighth accused arrested so far. The NIA team arrested the doctor from Delhi on December 9, calling him a key accused in the conspiracy. "As per NIA investigations, Bilal had knowingly harboured the dead accused

Umar Un Nabi by providing him logistical support. He is also accused of destruction of evidence related to the terrorist attack," the agency stated earlier on December 9. "The agency continues to pursue various leads in connection with the suicide

bombing, and has been conducting searches across states in coordination with the

respective police forces to identify and track the others involved in the gruesome attack," the agency said in a statement earlier. Dr Umar Un Nabi was driving the explosive-laden i20 car that detonated outside

the Red Fort on November 10, killing 15 people and injuring several others. PTI had earlier reported that the sophisticated terror module spearheaded by a group of doctors had been actively scouting for a suicide bomber since last year, with Umar being the alleged key planner.

NEW DELHI: The Union cabinet on Friday approved a Bill to rename the Mahatma Gandhi National Rural Employment Guarantee Act and increase the number of work days, sources said.

According to the sources, the scheme will now be renamed as 'Poojya Bapu Grameen Rozgar Yojna', and the number of workdays under it would be increased from 100 days at present to 125 days.

The Mahatma Gandhi National Rural Employment Guarantee Scheme, better known as MGNREGA or NREGA, is a flagship scheme of the government aimed at enhancing livelihood security of households in the rural areas by providing at least 100 days of guaranteed wage employment in a financial year to every household whose adult members volunteer to do unskilled manual work.
