

Reiterating the provisions of the Food Safety and Standards Act, 2006, and guidelines issued by FSSAI, the advisory directs all Designated Officers, Food Safety Officers, and enforcement teams to strictly adhere to approved disposal procedures to prevent envi-

Govt designates Tribal Affairs Department as Nodal Agency for FRA implementation

JAMMU: Tribal Affairs Minister, Javed Ahmed Rana, on Friday hailed the government's decision to designate the Tribal Affairs Department as the Nodal Department for implementation of the Forest Rights Act (FRA), 2006 across Jammu & Kashmir.

Describing the move as a historic and corrective intervention, the Minister emphasized that this is a landmark step, reflecting the long-standing aspirations of tribal communities. This will ensure a more community-centric, accessible and responsive institutional mechanism for implementation of FRA, he added.

Rana highlighted that transferring FRA responsibilities from the Forest Department to the Tribal Affairs Department will usher in fair, transparent and time-bound recognition of individual and community forest rights. He added that this decision marks a significant milestone achieved under the visionary leadership of Chief Minister, Omar Abdullah.

Reaffirming the government's commitment towards advancing tribal welfare, the Minister assured that every necessarv step will be taken to ensure the benefits of FRA reach every eligible tribal family across Jammu & Kashmir.

ronmental harm, health risks, and misuse of unsafe food items.

The Department has emphasized that disposal of any seized, rejected, or expired food items including their packaging, into rivers, lakes, natural water bodies, or open land is strictly prohibited.

The advisory directs enforcement teams to adopt the approved disposal methods such as, authorized incinerators compliant with Central Pollution Control Board (CPCB) Disposal in designated sani-

tary landfills with leachate control, composting or anaerobic digestion biodegradable waste through certified units, in coordination with local municipal bodies, panchavats, or other statutory authorities.

All disposal activities must be video recorded in the presence of two independent witnesses. After completion, the supervising FSO must submit a certificate of disposal to the Designated Officer, with copiesto the Commissioner of Food Safety and the concerned norms, Food Business Operator

(FBO). Designated Officers have been instructed to identify suitable incineration, composting, or alternative disposal facilities and share list with Commissioner of Food Safety. For high-volume disposals, coordination with the State Pollution Control Board has been advised.

Additionally, Designated Officers must submit monthly disposal compliance reports to the Commissioner of Food Safety by the 3rd of following month, highlighting any deviations from the prescribed guidelines.

Talwara migrants appeal for attention, basic facilities

STATE TIMES NEWS

SUNDERBANI: Migrant families of Talwara today staged a protest under the banner of the Migrant Action Committee (MAC) Talwara, led by its president Jagdev Singh, urging the government to address their long-pending demands and provide basic living facilities. The protesters expressed deep anguish over the fact that, despite being displaced by terrorism decades ago, many families continue to live in deteriorated quarters without adequate support. Jagdev Singh recalled that during the peak of terrorism in



Hindu residents lost their lives in brutal attacks across Prankote, Kotchadwal, Panglar, and Bamblia villages. Following these incidents, more than 1,000 families were forced to flee their homes and migrate nearly 90 kilometers to Talwara in Reasi district. He shared

families currently residing in Talwara, only 642 are officially registered and receive ration and limited government assistance. The remaining 352 families, however, remain unregistered and are deprived of any welfare benefits. The protestors said the tin-sheet quarters they

live in have become unsafe. leaking, and structurally weak, demanding immediate repair reconstruction.Jagdev Singh appealed to Lieutenant Governor Manoj Sinha and Prime Minister Narendra Modi to intervene compassionately and sanction funds for repairing and building proper housing for migrant families. He also urged the inclusion of all unregistered families in official records. MAC leaders Chamail Singh, Chung Lal, Kartar Singh, Hukam Chand, Dhani Ram, Dharam Singh, and Shatter Singh also participated in the protest.
