T01 to Hasyote, Package No. JK12-391, Phase XII, Stage-II, District Rajouri (Length 7.00 Kms) Whereas, the above-mentioned road was allotted to you vide NTP No. 3-11 dated 01-04-2021 and the work was

2022, has developed major structural failures, pavement distress, and recurring damages within the 4th Year Defect Liability Period (DLP). Whereas, as per contract agreement the contractor is bound to maintain the road till defect liability period (DLP) of five Years. But you have not done the routine maintenance of the road, as a result, the condition of

the road is getting worse day by day. Due to non-maintenance of the road, the public of the area are put to great inconvenience and face lot of problems while travelling on the said road. Whereas, sufficient time was given to you by issuing notices to quickly

the routine maintenance of the road, but all in vain.

Whereas, the Hon'ble MLA Thanamandi Sh. Muzaffar Iqbal Khan has also given instructions to maintain the said road as there is tremendous stress and public pressure for making the road traffic worthy.

Whereas, during the site visit of the undersigned on 09-12-2025, it has been witnessed that you have not maintained the road properly as per SBD Clause 32.4, despite several instructions issued to you by the PIU Budhal from time to time.Clause 32.4 reads as: The routine maintenance standards shall meet the following minimum requirements:-(i) Potholes on the road surface to be repaired soon after these appear or

brought to his notice either during the Contractor's monthly inspection or by the Engineer.

(ii) Road shoulders to be maintained in proper condition to make them free from excessive edge drop offs, roughness, scouring or potholes.

(iii) Cleaning of surface drains including reshaping to maintain free flow of

(iv) Cleaning of culverts and pits for free flow of water. (v) Maintenance of road signs, pavement markings and other traffic control

(vi) Any other maintenance operation required to keep the road traffic worthy at all times during the maintenance period. (vii) Maintenance of Cross Drainage Works

(viii) The maintenance activity includes clearing of tree branches to keep the sight distance visible all the time.

Keeping in view of the above, you are hereby finally directed to mobilize men and machinery immediately and maintain the road without any further delay, otherwise as per clause 33.1, 52.1 and 52.2(c) of SBD, your contract shall be terminated as your conduct causes a fundamental breach 33.1 If the Contractor has not corrected a Defect pertaining to the Defects

33.1 If the Contractor has not corrected a Defect pertaining to the Defects Liability Periodunder clause 32.1 and clause 32.2 of these Conditions of Contract, to the satisfaction of the Engineer, within the time specified in the Engineer's notice, the Engineer will assess the cost of having the Defect corrected, and the Contractor will pay this amount, on correction of the Defect. 52.1 The Employer may terminate the Contract if the Contractor causes a fundamental breach of the Contract.
52.2 (c) the Engineer gives Notice that failure to correct a particular Defect whether particular to construction work or participing to defect liability period is

whether pertaining to construction work or pertaining to defects liability period is a fundamental breach of the Contract and the Contractor fails to correct it within a reasonable period of time determined by the Enaineer

Treat this as final notice, no further correspondence shall be done from this office, if the work shall not commence within next three days, by or before 17th December, your contract shall be terminated as perclause 33.1, 52.1 and 52.2(c)of the SBD".

For non-compliance of the requirements of clause 32 of SBD regarding defects liability period and routine maintenance of roads for five years, on your part, the Executive Engineer PMGSY Division Budhal should be directed, as per clause 53.2(II) to assess the cost of having the defect corrected. If the total amount due to the Employer exceeds any payment due to the Contractor, the difference shall be recovered from the Security Deposit and Performance Security. If any amount is still left un-recovered, it will be recovered from any dues payable to the Contractor from State PMGSY works, any other State Government works including State Public Sector works executed by the Contractor.

The matter should be treated as MOST URGENT.
