shall form an appendix or the concluding segment of the judgment and shall be prepared in a clear, structured and easily-comprehensible format.

"We are of the considered view that a more structured and uniform practice must be adopted to enhance the legibility of criminal judgments. Accordingly, to ensure a systematic presentation of evidence that enables efficient appreciation of the record, we issue the following directions to all trial courts across the country.

"These directions aim to institutionalise a standardised format for cataloguing witnesses, documentary evidence and material objects. This will serve to facilitate better comprenension and immediate reference for all stakeholders, including the appellate courts," the bench said.

The apex court said each criminal judgment shall contain a witness chart with serial numbers, names of the witnesses, a brief description of the informant, eyewitnesses, the doctor

"The description should be succinct but sufficient to indicate the evidentiary character of the witness. This structured presentation will allow quick reference to the nature of testimony, assist in locating the witness in the record and minimise ambiguity," the court said.

It added that a separate chart shall be prepared for all documents exhibited during the trial and it shall include the exhibit numbers, a description of the documents and the witnesses who proved or attested the documents.

"In complex cases, such as conspiracies, economic offences or trials involving voluminous oral or documentary evidence, the list of witnesses and exhibits may be substantially long.

"Where the number of witnesses or documents is unusually large, the trial court may prepare charts only for the material, relevant and relied-upon witnesses and documents, clearly indicating that the chart is confined to such items. This

ensures that the charts remain functional reference tools rather than unwieldy compilations," the bench said.

The directions came while setting aside the conviction of a man for sexually assaulting a four-year-old girl.

The complainant stated that the accused, Ashu Choudhary und Karan Kumar alias Anil Kumar alias Nandi-armed w sharp-edged weapons (tokas), intercepted and launched murderous attack on her brother with clear intent to kill, indicating a pre-planned criminal conspiracy.

Taking serious cognisance of the matter, Police Station R.S. Pura promptly registered a case and constituted special teams under the supervision of the SHO. Using a combination of technical surveillance and ground intelligence, police launched a manhunt for the accused.

Govt to bring G RAM G Bill to replace MGNREGA

NEW DELHI: The Viksit Bharat Guarantee for Rozgar Ajeevika Mission (Gramin) (VB-G RAM G) Bill, 2025 that seeks to replace the existing rural employment law MGNREGA is set to be introduced in the Lok Sabha during the ongoing Winter session of Parliament.

According to a copy of the Bill, it will provide a statutory guarantee of 125 days of wage employment in every financial year to every rural household whose adult mem-

unskilled manual work.

Within six months from the date of commencement of the VB-G RAM G Act, states will have to make a scheme consistent with the provisions of the new law. Under this centrally sponsored scheme, the financial liability would be shared between the Centre and the state governments. It would be 90:10 for the Northeastern states and Himalayan states and 60:40 for all other states and Union territories with legislature. For the UTs without legislature, the whole cost would be borne by the Centre. The MGNREGS was a 100

Sports Minister assures fair probe into team selection for Santosh Trophy

JAMMU: Sports Minister Satish Sharma on Monday assured a time-bound and impartial inquiry into Santosh Trophy team selection, a day after the BJP alleged discrimination with the Jammu region and demanded his resignation. "Taking Cognizance of the media reports regarding issues in selection of team for football championship for Santosh Trophy, a detailed impartial enquiry shall be held in a timebound manner: "I assure all that violation of the meritbased selection policy by anyone will result in severe consequences and appropriate punitive measures," the minister said in a social media post.

Responding the same day, a sports council official said, "The players for the Santosh Trophy were selected in a process lasting more than one-and-a-half months. In the absence of the J&K football Association due to non-conduct of elections, the sports council has been raising the teams in coordination with All India Football Federation for the past two vears and has ensured meritbased and transparent selection." The official further said that after the trials, out of 51 players, 32, including eight from the Jammu region, were shortlisted for the residential

coaching camp in Jammu from November 21. The camp continued till December 12, and the selection committee finally selected 23 players, including four from Jammu, for the team to represent J&K in the Santosh Trophy, the official said and added that one of the Jammu boys could not join due to some examination, while another is joining the team in the coming days.

Unemployment allowance would be paid if an applicant is not provided work within 15 days, which will have to be paid by the state government, according to the Bill. The amount should not be less than one-fourth of the notified wage rate for the first 30 days during the financial year and not less than half of the wage rate for the remaining period of the financial year.

The plea claims that the detention is illegal and an arbitrary exercise violating his fundamental On November 24, the top

Security Act (NSA) on September 26, two days after violent protests demanding statehood and Sixth Schedule status for Ladakh left four people dead and 90 injured in the Union territory. The government had accused him of the violence. According to the amended plea, the detention order is founded upon "stale FIRs. vague imputations, and speculative assertions, lacks any live or proximate connection to the purported grounds of detention and is thus devoid of any legal or factual justification". "Such arbitrary exercise of preventive powers amounts to a gross abuse of authority, striking at the core of constitutional liberties and due process, rendering the detention order liable to be vitiated by this court," it alleged. The plea said it is wholly preposterous that after more than three decades of being recognised at the state, national, and international levels for his contributions to grassroots education, innovation, and environmental conservation in Ladakh and across India, Wangchuk would sud-
