Highlighting people's trust in the armed forces, especially the air-defence capability, Singh said, "Usually, when the enemy attacks, people hide. But when the Pakistani forces tried to target Indian installations, the people of India remained calm and continued with their daily routines. This is a proof of the trust of every Indian in our operational preparedness.'

The conclave was attended by Chief of Defence Staff General Anil Chauhan, IAF chief Air Chief Marshal A P Singh and other senior IAF commanders.

Reflecting on the changing nature of warfare, Singh said the Russia-Ukraine conflict, the Israel-Hamas war, the Balakot air strikes and Operation Sindoor have proved that air power has emerged as a decisive force in today's times.

Air power is not just a tactical asset, but a strategic instrument, and speed, surorise and the shock effect are its inherent characteristics, he asserted.

"Air power gives any leadership the capability to deliver a clear strategic message to the adversary that every step will be taken to uphold national interests. Through speed, reach and precision, air power has become an effective tool for aligning the nation's objectives with military means," Singh said.

Commending the performance of India's air-defence system and other equipment, effectively used during Operation Sindoor, the senior Bharatiya Janata Party (BJP) eader reiterated the commitment of the government, led by Prime Minister Narendra Modi, to further strengthening India's security apparatus.

Describing the operation as a shining example of tri-service synergy, Singh underined the importance of jointness in today's rapidly-changing times.

"Jointness among the three services is crucial as it would further strengthen our security system and enable us to deal with our adversaries even more effectively," he

Singh also lauded the IAF for its humanitarian assistance and disaster-relief efforts, both domestically and internationally.

"Whether at home or abroad, the IAF has consistently provided critical support during natural calamities. Many of the missions were executed in extremely challenging situations which has increased the trust of the people in our air warriors, he said. After his arrival at the conclave, Singh was briefed on the IAF's operational preparedness. The conclave provides a strategic platform for the IAF leadership to deliberate on operational priorities, address emerging challenges and advance 'Aatmanirbharta" (self-reliance) in defence capabilities, steering the force towards excellence, the defence ministry said.

Dr. Paul also stressed the need for a flexible and collaborative framework, enabling nstitutions to seek support from one another and adopt best practices nationally. He urged the Department to go beyond the Terms of Reference of the high-level committee constituted by the UT and explore the establishment of advanced faciliies such as Eye Banks, strengthening Forensic Medicine, and upgrading Emergency and Trauma Care services across healthcare institutions.

Calling for a pragmatic yet ambitious approach, Dr. Paul assured that NITI Aayog would facilitate linkages with premier national institutions and provide expert guidance to help J&K achieve its healthcare objectives.

On the occasion, Chief Secretary Atal Dulloo sought NITI Aayog's guidance on strategies to retain senior faculty in medical colleges, attract talent from outside the UT, and extend specialized healthcare services to far-flung, mountainous, and bor-

He also acknowledged NITI Aayog's crucial role in guiding the UT's health sector reforms, particularly over the past few months, which resulted in the addition of zens of postoraduate seats and hundreds of MBBS seats across medical collect n J&K.

The Secretary, Health & Medical Education Department, Dr Syed Abid Rashid Shah presented a comprehensive overview of the initiatives undertaken following sustained consultations with Dr. Paul over the past several months.

He outlined progress in expanding tertiary healthcare services to district hospitals, augmentation of UG, PG, and DNB seats, and development of a robust governance framework. He also detailed the proposed roles, responsibilities, accountabilty mechanisms, monitoring and evaluation systems, and implementation timelines.

The Executive Director, SMVDIME, Dr. Yashpal Sharma, made a detailed presentation on the proposed healthcare interventions envisaged with active support from NITI Aayog.

Key interventions deliberated during the meeting included the strengthening of critical care services through Tele-ICU rollout in government hospitals under a huband-spoke model. It was revealed during this meeting that the Tele-ICU tender, vetted by Team NITI Aayog, has already been floated. To address diagnostic gaps, particularly in peripheral and underserved areas, the UT also plans to implement Tele-Radiology services, for which the tender is in the final stages

The Health Department is also exploring the establishment of a Dentistry Department, while the creation of Oral & Maxillofacial Surgery and Pedodontics departments in newly established GMCs is under active consideration, the meeting was informed.

Dr. Paul was further apprised about the constitution of a high-level committee tasked with devising collaborative models among AHMS Jammu, SKIMS Soura, GMC Jammu, GMC Srinagar, and the newly established GMCs. The committee was tasked to focus on cardiology, cancer care, mental health, telemedicine, tele-radiology, and academic integration, including enhancement of UG, PG, and DNB train-

The Department also sought NITI Aayog's assistance in taking up the matter with the National Medical Commission (NMC) for designating District Hospitals as Associated Hospitals of Government Medical Colleges, a move aimed at improving clinical exposure and decentralizing healthcare delivery.

Detailed deliberations were also held on strengthening Drug De-addiction, Mental Health, and Social Health priorities, with a draft action plan titled "Circle of Care", prepared by Dr. Arshad Hussain, Professor of Psychiatry, GMC Srinagar, submitted to NITI Aavog for its consideration.

In another major development, facilitated by NITI Aayog, it was learnt that the Institute of Liver and Biliary Sciences (ILBS) has agreed to provide training to transplant teams along with continued technical support and mentoring. In this regard, a formal request has been submitted by the Health & Medical Education Department seeking support for establishing Liver Transplant facilities in the UT.

The meeting concluded with a reaffirmation of NITI Aayog's continued guidance and support in transforming Jammu & Kashmir's healthcare landscape through technology-driven solutions, academic collaboration, and systemic capacity building, ensuring accessible, affordable, and quality healthcare for its citizens across the length and breadth of the UT.

Parliament passes Nuclear...

State, Department of Atomic Energy, Jitendra Singh, said it aims at making India self-reliant in nuclear energy and reducing dependence on other sources of

He asserted that nuclear energy is a reliable 24x7 power supply source, which is not so in the case of other renewable energy options.

Stating that the country has already reached 8.9 GW of nuclear energy in 2025, Singh said by 2047, "if we are able to follow the roadmap we have envisaged, we will be 100 GW, and we would be contributing nearly 10 per cent of the energy requirement..."

He also noted that India's energy requirement will be highly dependent on nuclear sources, with AI coming in a big way.

"This (nuclear energy) will be the most reliable, steady 24x7 source of energy, unlike some other renewable sources," he pointed out.

Defending the opening up of the tightly-controlled civil nuclear sector for private participation, Singh said the "fruits and the outcomes" of opening various sectors to private players have been very rewarding.

He said that when the government opened up the space sector, its economy was dismal, but today it is USD 8 billion.

"And, the pace is so fast that in the next eight to ten years, we hope to go five times to USD 45 billion. The concept of space startups was unheard of. Today, we have over 300 space startups. In the space sector, some of them have turned multi-millionaires. And some of them have global potential. This was possible because private sector participation was allowed. The FDI was allowed," Singh said.

He also asserted that the safety provisions in the nuclear bill have not been compromised in any way.

The safety provisions and their standard operating procedures (SOPs) are the same as in the Atomic Energy Act of 1962, which was enacted when Pandit Jawaharlal Nehru was the Prime Minister, Singh noted.

"The SOP in place clearly mentions 'safety first, second production'," he added.

They said that 114 system-generated alerts were verified on the ground, leading to confirmation of 14 cases of illegal mining and imposition of penalties amounting to Rs 90 lakh.

conviction in a terror-related case, after the accused confessed his involvement befor the court through video conferencing," the spokesperson said. He said the case was registered on December 1, 2020 under Sections 16, 18, 19

and 20 of the ULA(P) Act, Section 307 of IPC and Sections 7/27 of Arms Act. The convict has been identified as Zamir Sadiq Lone, who was arrested in

November 2021. The case also involved three other accused terrorists, who were eliminated in earli

er security operations, the spokesman said. "Upon conclusion of the trial, the court sentenced the convicted accused to four years and four months of imprisonment, along with a fine of 10,000," he added.

Night temperatures rise above freezing point in Kashmir ■ STATE TIMES NEWS

SRINAGAR: Kashmir is experiencing a huge relief from intense cold as night tem peratures rose and settled above the freezing point, with rain and snow expected to coincide with the oncoming "Chillai-Kalan", the 40-day harshest winter period, offi cials said on Thursday.

The mercury in most places in the valley settled above the freezing point, with Srinagar recording a low of 0.2 degrees Celsius on Wednesday night, an improve ment from the previous night's minus 1.6 degrees Celsius, they said. Night temperatures were 2.2 notches above normal for this time of the season. The

minimum temperature across the valley hovered between 1.7 to 6.6 degrees Celsius

A thick layer of fog engulfed Srinagar and most other parts of the valley, especially near water bodies, during the early hours.

Qazigund in south Kashmir recorded a low of 0.8 degrees Celsius -- up by over aree decrees, while the temperature in Kupwara in north Kashmir settled at 1 degrees Celsius. Kokernag in south Kashmir registered a low of 1.8 degree

In Gulmarg, the minimum temperature settled above the freezing point at 1.6 degrees Celsius, the same as the previous night, the weather officials said. Pahalgam, one of the base camps for the Amarnath Yatra in south Kashmir

recorded a low of 0.4 degrees Celsius. Pulwama town was the coldest spot with a minimum of minus 3.2 degrees Celsius, they said. The Kashmir Vallev is bracing for the onset of Chillai-Kalan on December 21 Chances of snowfall is highest in this period, with temperatures dropping sharply

across the valley. Chillai-Kalan ends on January 30. So far this winter, the valley has not witnessed any major wet spell, officials said. Jammu and Kashmir Chief Minister Omar Abdullah expressed optimism, saying

the dry spell would end soon. "Alhamdulillah, this prolonged dry spell in J-K that has persisted since early las month looks like it will finally end this weekend," Abdullah wrote on X

The dry weather so far has led to an increase in ailments like cough and the com mon cold, but the meteorological department (MeT) has forecast a spell of we weather on December 20-21, coinciding with the onset of 'Chillai-Kalan'.

Moderate to heavy snowfall is expected in the higher reaches of Kashmir, while light to moderate precipitation may affect the plains, ending the dry spell, officials said.

J&K Govt constitutes committees for strict implementation of Indian Aircraft Rules near Airports

JAMMU: The Government of Jammu & Kashmir on Thursday constituted committees for strict implementation of Rule 91 of the Indian Aircraft Rules, 1937, aimed at ensuring aviation safety and compliance around airports in the Union Territory. The order was issued by M. Raju, Commissioner/Secretary, General Administration Department.

The Jammu Division Committee will be chaired by the Divisional Commissioner Jammu, and include as members the Administrative Secretary, Civil Aviation Department; Deputy Commissioner, Jammu; Commissioner, Jammu Municipal Corporation; Senior Superintendent of Police, Jammu; Director, Urban Local Bodies, Jammu; and J&K Pollution Control Board. The Director Airport, Jammu will serve as Member Secretary.

Similarly, the Kashmir Division Committee will be headed by the Divisional Commissioner, Kashmir, with members comprising the Administrative Secretary Civil Aviation Department; Deputy Commissioners of Srinagar, Budgam, and Pulwama; Commissioner, Srinagar Municipal Corporation; Senior Superintendents of Police of Srinagar, Budgam, and Pulwama; Director, Urban Local Bodies Srinagar; and J&K Pollution Control Board. The Director Airport, Srinagar will act as Member Secretary. Both committees are tasked with the immediate identification and mapping of unauthorized slaughterhouses, meat shops, dairies, piggeries garbage dumps, and other prohibited facilities within a 10 km radius of the interna tional airports in Srinagar and Jammu. Strict enforcement measures, including clo sure or relocation of non-compliant units, will be carried out in coordination with

municipal authorities, pollution control boards, and law enforcement agencies. Additionally, the committees are required to institutionalize compliance monitoring mechanisms and submit quarterly reports to the Director General of Civil Aviation, Government of India, ensuring sustained adherence to aviation safety norms in the region.
