**ORDER**

Exercising powers under Municipal Act 2000, the Municipal Committee finds it necessary to curb the growing dog breeding units coming up in the city. It has been observed that there has been a sharp rise in the number of dog breeding units in the Municipal Committee Bari Brahmana. The discarded/unsold animals are often left out on the roads.

As per the Animal Birth Control Rules 2001 framed under the Prevention of Cruelty to Animals Act 1960, there is a requirement for all dog breeders to be registered with the Animal Welfare Board of India, Ministry of Environment and Forests. However, none of the Dog breeders in Bari Brahmana are complying by any standards laid down for such registration. The pups are generally mutilated, diseased and are not kept under veterinary care. Under Section 3 of the Jammu and Kashmir Prevention of Cruelty to Animals Act, sale of such animals is prohibited.

In the interest of reducing the dog population on the streets, adoption of Indian dogs shall be promoted by the Municipal Committee Bari Brahmana through registered NGOs. Henceforth, all dog breeding units are disallowed within Committee limits.

Any report of dog breeding shall be acted upon as a public nuisance and the animals Involved in the trade shall be confiscated and neutered. No advertisements for sale of pups from any breeding unit shall be allowed.

The Committee shall initiate a drive to close down all non complying dog breeding shops from 21.12.2025.

**ORDER**

It has been observed that hygiene norms and practices are not being observed at meat shops and slaughterhouses. Also, refused meat parts are dumped in public drains and alongside streets which have given rise to rodents and scavenging animals.

In Accordance with the Municipal Act 2000 and Food Safety and Standards Act 2006 and Licensing and Registration of Food Businesses Regulations 2011:

- Municipal Committee Bari Brahmana shall only provide an NOC for a meat shop or a slaughterhouse but the license for the same must be obtained from the Food Safety Officer. The penalty for selling meat or slaughtering animals without license is upto Rs.5.00 lakh a day.
- No Meat shop is allowed to slaughter animals. However, slaughtering of any animal can only be done in a licensed slaughterhouse.
- No animal other than sheep, goat, poultry, fish are allowed to be slaughtered for food.
- Roadside slaughter units where live birds and goats are kept and slaughtered do not have the requisite infrastructure for stunning and handling not are other statutory conditions for ante and post mortem carried out. This is detrimental to the health of consumers and grossly against the law.

The Committee shall initiate a drive to close down all non complying meat shops 21-12-2025.

The offenders will be charged under the Food Safety and Standards Act 2006 and Municipal Act 2000.
