GeM Scam continues unabated: RTI reveals massive irregularities in JKSPDCL Balvinder singh urges CM to hand over inquiry to CBI

JAMMU: Renowned RTI activist and social activist Balvinder Singh, while addressing a press conference today, stated that the Government e-Marketplace (GeM) scam continues unabated despite repeated exposures and official alerts. He recalled that on 31 April 2022, he had exposed a GeM scam exceeding ?500 crore involving the Directorate of Health Jammu and the Rural Development Department, following which the J&K Anti-Corruption Bureau (ACB) issued an alert note to all government departments.

However, Singh said that the latest revelations obtained through RTI have brought to light shocking irregularities in the Jammu & Kashmir State Development Corporation Limited (JKSPD-CL). According to the information received, large-scale financial irregularities were committed in purchases made through GeM, indicating an open loot of the public exchequer by officers entrusted with procurement responsibilities.

Singh alleged that purchases

were executed under the active involvement of the Buyer, Deputy General Manager JKSPDCL Jammu, the then Chief Accounts Officer, and other senior officers, under whose watch the scam was allowed to flourish-something that would not have been possible without the patronage of higher authorities. Explaining the modus operandi, Singh said the department cleverly manipulated the GeM process to procure items from preferred vendors at rates of their own choosing. RTI replies revealed that several items were purchased at prices 200% to 300% higher than prevailing market rates.

Citing specific examples, Singh produced invoices before the media. He stated that two Bridgestone tubeless tyres (205/65/R15) were purchased by the Deputy General Manager, JKSPDCL, vide GeM Invoice No. GEM- $56817735 \, dated \, 20.03.2025 \, at$?18,000 per tyre, whereas the market price was approximately ?6,950, reflecting a markup

Similarly, four Apollo tubeless tyres (145/80/R12) were purchased vide Invoice No. GEM-57136127 dated 22.03.2025 at ?12,375 per tyre, while the prevailing market price was around Rs 2,800, amounting to more than 340% overpricing. Singh further stated that four

questioned how the Chief Accounts Officer cleared and released payments without verifying market rates, proving that despite the ACB alert issued on 19.09.2022, nothing has changed on the ground.

He urged the Chief Minister of J&K to hand over the matter to the CBI for an in-depth investigation into the buverseller nexus. He also demanded that the ACB register FIRs against all officials involved in earlier and current GeM scams. including those in the Directorate of Health and RDD. team, successfully performed a rare implantation of a leadless pacemaker (AVEIR) on a 29-year-old patient at KD Hospital, Marble Market, Jammu. The advanced procedure has given a new lease of life to the young patient, who was earlier battling severe complications following a conventional pacemaker implantation.

The patient was admitted with a serious infection on both sides of the chest after undergoing a traditional pacemaker procedure at another medical centre. Due to the severity of the infection



and related complications. the patient had lost hope of recovery. However, following the successful implantation of the AVEIR leadless pacemaker at KD Hospital, the patient made a full recovery and is now in stable condition. Explaining the procedure, Dr. Nikhil Mahajan said that AVEIR is the world's smallest pacemaker and represents a significant advancement in cardiac pacing technology. "Unlike conventional pacemakers, which are implanted in the chest with lead wires running to the heart, AVEIR is implanted directly into the heart through a vein in the leg. The procedure does not require any chest incision, leaves no visible scar or bump, and significantly reduces the risk of infection," he said.

Dr. Mahajan further added that AVEIR eliminates complications associated with lead wires and chest incisions. "It is 93 percent smaller than traditional pacemakers, roughly the size of a large vitamin capsule, and offers an impressive battery life of up to 18 years. This makes it especially suitable for younger patients who require long-term pacing support," he explained. With the growing number of patients requiring pacemakers, advancements in cardiac technology have become crucial. For most patients, the AVEIR design results in fewer medical complications, including reduced risk of infection, bleeding and lead failure, along with shorter hospital stays and minimal post-procedure restrictions.

Highlighting the hospital's capabilities, KD Hospital CEO Dr. Sumit Sharma said that the procedure is among the rarest and most advanced in cardiac care. He added that with world-class infrastructure and highly qualified medical staff, KD Hospital is now equipped to provide advanced cardiac treatments, eliminating the need for patients from Jammu to travel to metro cities for specialised care.
