Subject: Un-authorized absence from Government duty – regarding.

Whereas, as per available office records, you proceeded on Earned Leave w.e.f. 03.10.2024 to 02.11.2024 and further 03.11.2024 to 03.12.2024, but thereafter failed to resume Government duties w.e.f. 04.12.2024 till date, thereby remaining absent without authorization; and

Whereas, Notice-I was issued to you vide this office letter No. KFD/Estt./2025-26/2682-84 dated 08.11.2025, directing you to report for duty within seven (07) days of the issuance of the said notice; and

Whereas, you have submitted an explanation along with a medical report and Form-I for the period 04.12.2024 to 07.01.2025, claiming that you met with an accident; and

Whereas, upon verification of the submitted medical documents from the Chief Medical Officer, Kathua vide his letter No. CMOK/8332 dated: 08.11.2025, it has been reported that the said medical certificates were issued by Dr. Nipun Sharma (GMC Kathua) during private practice, and the authenticity/validity of such certificates for Government leave purposes is not established; and

Whereas, the Range Officer, Kathua Range vide his letter no. RFO/K/2025-26/871 dated: 28.11.2025 has also reported that despite the lapse of 21 days since issuance of Notice-I, you did not report back for duty.

Whereas, Notice-II vide this Office Letter No. KFD/Estt./2025-26/3001-03 dated: 01.12.2025 was also served upon you by giving 07 more days & directed you to report to the office of the undersigned & advised to explain, in writing, the reasons for your prolonged unauthorized absence but you again failed to respond to the notice & still not joined the duty after lapse of 18 days.

Now, therefore, through this Final Notice by granting Last & Final opportunity, you are hereby once again directed to report to the office of the undersigned within seven (07) days from the date of issuance of this notice and advised to explain, in writing, the reasons for your prolonged unauthorized absence, failing which it shall be presumed that you are wilfully absent from Government duty. Appropriate disciplinary action under the relevant provisions of J&K CSR/Leave Rules/Conduct Rules shall be initiated against you, which may include treating the period of absence as 'Dies-Non', and/or recommendation for termination of services, without any further notice.

2. **Cost of Tender Document:** Bids must be accompanied by a Treasury Challan (dated between the bid start date and the Bid Submission End date) deposited in M.H. 0059 (Revenue) mentioning the name of work/e-NIT No. pledged to Executive Engineer PW(R&B) Division Chatroo (Tender Inviting Authority) as the cost of the tender document. Any deviation in the specified amount, the bid shall be rejected outrightly. The cost of Tender Document is non-refundable.

3. **Earnest Money Deposit/ Bid Security:** At the time of tendering, all bidders must upload Earnest Money/Bid Security equal to 2% of the Advertised Cost (Requisite amount not above or below, strictly as tabulated above against work) in the shape of CDR/FDR (dated between bid submission start date and bid submission end date) pledged to the tender receiving authority, i.e., Executive Engineer PW(R&B) Division Chatroo. Any deviation in the specified amount, The bid shall be rejected outrightly.

3.1. 3. Bidders must quote for all the particulars of the item in the Technical Bid and in the price schedule/BOQ of financial bid. The bids of Bidders who will not quote for all the particulars for any item in technical and financial bids shall be liable to be rejected at the discretion of the Employer keeping in view the interest of the JPDC.

4. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee only from any Nationalized/Scheduled bank only pledged to Executive Engineer, JPDC, ED-I, Parade Jammu. No Interest shall be payable on Earnest Money deposited with the Department.
