ORDER

Whereas, the Senior Superintendent of Police, Rajouri has brought to the notice of undersigned that there is an imminent need to conduct verification of tenants and Hotel Guest.

And Whereas, it is necessary that measures be taken to make the landlords/property owners/business owners/ commercial establishment (S) accountable before renting out/hiring workers/making available their premises to tenants/domestic helpers/workers; and

And Whereas, I consider the threat posed by any adverse elements as imminent danger to public safety and security that warrants immediate preventive measures under section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023;

Now, therefore, for the reasons aforesaid, and by virtue of powers vested in me under section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023, I **Abhishek Sharma, IAS, District Magistrate, Rajouri** do hereby order and require all landlord (s), owner (s) of properties, attorney holder (s), persons (s) in charge of properties, contractors, business owner (s), commercial establishment (s)/shop owner (s) in capacity (hereafter called as owners) located in entire jurisdiction of the District to comply strictly with the following directions:-

- (a) All owners shall after the issuance of this order within three 03 days submit without fail, the detailed particulars of the tenants as per the Declaration Form (annexed herewith), to be signed by both the owner and the tenants, either in person or by registered post addressed to the concerned Station House Officer (SHO).
- (b) The owners who have already let/sub-let/rented out their properties or thereof to any tenants on any date prior to the issuance of this order, shall submit the detailed particulars of the tenants as per the declaration form to the concerned Police Station within two days.
- (c) It is clarified that all arrangements of letting or sub-letting the property like Paying Guest, tenants etc., shall be covered by this order.
- (d) Owners who have allowed jhuggies in their lands shall also be required to disclose the details as per the declaration form.
- (e) Every SHO in District Rajouri, shall maintain a separate register for such purpose.

Any person contravening this order shall be punishable under section 223 of Bharatiya Nyaya Sanhita (BNS) 2023.

As the notice cannot be served individually to all concerned, this order is therefore passed ex-parte. It is being promulgated for the information of public at large and shall be published on district website, leading newspapers and by affixing copies on the Notice Boards of the offices of SSP Rajouri, all Additional Deputy Commissioners, SDM, all Tehsildars, all SDPOs, and all SHOs of Rajouri District.

It is hereby informed for the information of the general public, shopkeepers, vendors and institutions that as per Government orders and directions of the Pollution Control Committee, the use, sale, storage, distribution and manufacture of Single-Use Plastic (SUP) items such as plastic carry bags, plates, cups, straws, cutlery, polythene sheets, etc. is strictly prohibited within the limits of Municipal Committee Thathri.

As per the latest Plastic Waste Management Rules, plastic carry bags below 120 microns thickness are strictly banned. All citizens are requested to avoid the use of single-use plastics and instead adopt eco-friendly alternatives like cloth bags, jute bags, paper cups, and biodegradable materials.

Defaulters found violating the norms shall be liable to penalty and legal action as per rules.
